Walk It! Bike It! Public Program January 7th

The first Walk It Bike It public program for the year will focus on the recently adopted Middle Susquehanna Bicycle and Pedestrian Plan on January 7th, 7pm at the Public Library for Union County. The program will review the primary report and discuss the many supplemental documents available. The plan is the result of an 18-month process including a study committee, official interaction, and public outreach. It has been adopted by the SEDA-COG MPO (regional transportation oversight authority) and the Susquehanna Greenway Partnership. This event is part of a series of programs developed in response to public input suggesting Walk It Bike It appeal more to general public interest as opposed to inviting the public to attend the committee's business meetings. Supreme Court Affirms Rape Conviction Against Craig Poust

District Attorney Mike Piecuch (pronounced "Pea-YET-Sue") announced that the state Supreme Court has affirmed Craig L. Poust's rape conviction.

In January 2018, Poust was convicted by a Snyder County jury for the substance-facilitated sexual assault of a 16 year old girl at his Port Trevorton residence in 2012. For that crime, he was subsequently sentenced to 10-15 years in state prison. This sentence is being served consecutively to the sentence of 8 to 18 years he received for his October 2016 conviction on weapons and drug charges.

Poust appealed the convictions in both cases, and in both cases the Superior Court rejected his appeals. The Pennsylvania Supreme Court has now also denied Poust's appeal of his rape conviction.

DA Piecuch said, "I am gratified that the Supreme Court has affirmed the jury's guilty verdict. This validates the courage of all the women who spoke up about Craig Poust's crimes."

Craig Poust is still facing additional charges, along with Chanel H. Kantz, for allegedly committing two substance-facilitated sexual assaults in 2014.

Bucknell Professor's Research Team Awarded \$1.2 Million NSF Grant



Bucknell University mechanical engineering professor Craig Beal is part of a research team awarded a \$1.2 million National Science Foundation (NSF) grant to study the collection and use of data generated by connected users that could lead to safer and more ubiquitous self-driving vehicle technology.

Beal, Penn State University mechanical engineering professor Sean Brennan; and University of Massachusetts Lowell computer science professor Cindy Chen and mechanical engineering professor Kshitij Jerath were awarded the grant. They will collect data from connected intelligent vehicles to determine how it might best be used to navigate hazardous road conditions, such as icy patches.
 "This work can save lives and suffering by improving safety-critical decision-making used by connected and autonomous vehicles driving under hazardous operational situations," Beal said. "This research is timely and impactful due to the recent and rapid deployment of vehicles with enhanced sensing and connectivity."
 "This grant is really intended to investigate how data points are related to each other and when data are no longer useful and actually lead to worse computer decision-making," he continued. "It has broader applications beyond vehicles, such as in predicting yields of crops in fields planted at specific times within a region, or determining for how long Yelp user reviews of a restaurant provide useful information."
Building Upon Previous Research
 Beal previously received a 2017 NSF grant to measure steering torque — the effort required to hold the front wheels at a given angle as a vehicle travels around a turn — through sensors mounted within the wheels of an autonomous vehicle. The new grant builds upon that work to study how data collected through steering sensors in a fleet of connected and autonomous vehicles can be shared in a timely fashion to improve driving safety under hazardous road conditions. For example, when several connected vehicles hit a slick patch on an icy roadway, they could alert other connected vehicles in the area to take corrective action.

Even when considering only inclement weather accidents, the researchers point out that roughly 4,200 people die in the United States each year with 20 times that number injured or disabled, and 40 times both amounts when considering worldwide accidents.
 Beal hopes that the methods and algorithms developed in this work can guide the deployment of all database systems where trust in data quality and timeliness are competing factors.
 "This enables a wide range of information sharing," he said. "The crux of what we're trying to study is how you can use data to make the best decision. In a vehicle application, that includes where are you going, how fast should you go and what the conditions ahead are like. We're using the vehicle as an important and socially acceptable example, but there are a lot of examples that are becoming data-connected systems."
Outreach to Women in Engineering and Computing Fields
 The grant also includes funding for outreach activities to provide young women with increased knowledge and role models, with the aim of increasing their participation in study of the engineering and computing fields. It will also support the development of graduate and undergraduate researchers at Bucknell, Penn State and UMass Lowell.
 Bucknell undergraduate students will participate in the project.

Question: Alice, what is the part B deductible? I just got a bill from one of my providers. I am confused because my Medicare Statement says I have satisfied the deductible for 2019.

Answer: The part B deductible in 2019 is \$185. You must pay all Medicare approved costs until you meet the yearly Part B deductible. After your deductible is met, Medicare pays 80% for Part B services. Most people that keep Medicare as their primary, also pair a Medicare Supplement with it. Those quarterly statements that mention your deductible amount can be very misleading. When your statement says you have met the deductible, I tell people that is only in theory. You must actually pay the bills that get mailed to you from those providers. Medicare doesn't know if you have paid your provider.

I teach our clients an exact method for keeping deductible records concise and organized. Buy a cheap folder. Inside on the flap write down the dates of service and the amounts you pay for each provider. Don't worry, you only need to document your first \$185 of provider service bills. When a random bill comes into your house, what do you do? You go to your folder, and see if your documented total that you have paid has reached \$185. If you have paid that out already my advice is to just wait that bill out. It was probably sent out before payment was received. If you still have some deductible left to meet, then you probably need to pay that provider.

I hope this clears up the mystery of the Medicare notices and the deductible. One last peculiar occurrence is that occasionally a provider never bills or missed billing for a service while in that deductible phase. I believe that rare occurrence will be happening less and less.
