

Over \$100,000 Given At Sun Tech's Student Recognition Program



On Thursday, May 23, SUN Area Technical Institute held the Student Recognition Program for the 2012-2013 class. It was estimated that \$108,650 was awarded in the form of scholarships, checks, saving bonds and tools/equipment.

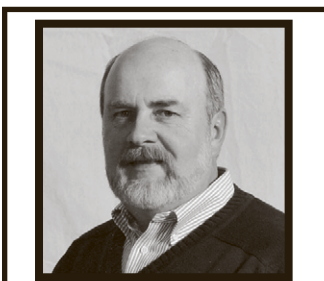

Bake Ovens/Bock Dag (Baking Day) of Years Gone by (Continued)

It required a fine art to time each part of the baking operation so that pies, cakes and especially the raised bread, were in exactly the right condition for baking just when the oven was ready to receive them.
 At the season of year when fruit was dried, it was after the baking was finished that the fruit was put into the oven for drying.
 For the firing of the oven, fire wood in 6-foot lengths from the family wood pile was cut in half and placed against the outside of the oven, ready for use. After the baking was finished and the oven was still hot, wood and shavings were placed in the oven for the next week's baking. This meant that the wood would be thoroughly dry for burning when it was needed. Each part of the baking operation had its exact time and place in the plan of farm life.
 On Bock Dag usually no less than 40 pies, tarts and cakes were baked. And of course, many loaves of bread, some white, some half-rye, some half-wheat, 16 inches in diameter, 4 1/2 inches in height were baked also.
 Every piece was baked in the old-fashioned, outdoor oven and even the children had to help with the work and the preparation for the day.

Bread Baking
 The first leavened bread is alleged to have been baked by the Egyptians. It is also speculated that leaven was discovered by accident when fermentation inadvertently developed in a batch of dough. Many years later in colonial America and up until 1868, when commercial yeast first became available, home bakers had to make yeast and keep it going from baking to baking. Even after this date, many homemakers continued to make their own yeast, as trips to the store were infrequent. Quite naturally, numerous ways of keeping yeast were developed. Each batch of yeast possessed varying degrees of strength and the quality of each baking day's yield was subject to many factors.
 Bread-baking began with "sots" (a yeast starter). It was often made of grated raw potatoes and the juice of hops, some of which was held over as a starter from week to week. This was then mixed with potatoes, boiled with their jackets on, skinned and mashed, and became the leaven, so long ago spoken of in the Holy Writ. Often very small potatoes were used as a matter of economy. (To be continued next week.)

I need a tutor!

I salute Representative Fred Keller for obtaining a 45 day extension and asking for another 45 day extension. I salute Commissioner John Showers for having placed in the Union County Library several binders of materials related to the En-Tire Logistics' request to burn tires to produce electricity.
 In the materials at the county library, on ALL 4 letterhead, "Re: ...Inhalation Risk Assessment and Air Quality Modeling Report Addendum," dated November 16, 2012, to a Harrisburg DEP official, states, "...Carcinogens - Aggregate inhalation risk from all substances is not more than 1 in 10,000,000," and (thus) "...it is understood that a multi-pathway exposure assessment for the WDE facility is not required." I thus must ask, what toxic chemicals and fine particles (particulates) will not be identified as a "multi-pathway exposure assessment... is not required?" I did not see in the information at the library a letter to DEP dated December 4, 2012, from Dr. Sherri Mason of SUNY, an atmospheric chemist, that states, "...the emission factors in the Plan Approval Application are not scientifically valid." Also, the transcript of testimony, almost all of which was critical, from the May 2 DEP public hearing was not included. Full disclosure is needed.

There are so many new concepts, words, and acronyms to understand in order to make an informed decision. TDF, HAPs, VOC, AERMOD, UTM, and to quote again from the ALL 4 letter, "For Hg, cancer risks are not evaluated, but the chronic Hazard Quotient (HQ) is, 1,1E-04 and the acute HQs are 2.2E-03..."
 Representative Keller's and Commissioner Showers' leadership is again needed.
 We need a twelve to fifteen month delay and the materials, all the materials, need to be placed in area county libraries, university libraries, and high school libraries. This will provide all downward citizens and students an opportunity to study, learn, and make an informed decision. For our youth, this represents an extremely practical learning, leadership, and community service opportunity. We are obligated to allow everyone, but especially our youth, time. Something this important and complex should not be rushed.

Dig Into a Cause with the Union County Library System: Bookmarks & Backpacks program launched for tornado victims

Monday, May 20 is a day many people will never forget as the entire nation watched as an EF5 tornado terrorized the town of Moore, Oklahoma, leaving in its wake lives lost, homes destroyed and schools desolated.

In the days that followed, many other towns were affected by tornados, leaving one disaster after another. So many people were now faced with rebuilding their lives from scratch.

After seeing the devastation in Moore, the Union County Library System (UCLS) is 'digging into a cause' with a project called Bookmarks & Backpacks: Libraries for 'Moore' Hope.

Throughout June and July, each library in the system—Herr Memorial Library, Mifflinburg; The Public Library for Union County, Lewisburg; and West End Library, Laurelton—is collecting school supplies for students and teachers, as well as supplies for infants and toddlers.

"Our goal is to fill a tractor trailer," said Kelly Walter, director of the Herr Memorial Library, where the idea for the project originated. "We'd like to collect backpacks, tote bags, and diaper bags and enough materials to fill each of them."

For school-age children, the UCLS is collecting the following items: backpacks for boys and girls, pens, pencils, markers, crayons, highlighters, pencil cases, notebooks, notepads, binders, bookmarks, books, stickers, glue, glue sticks, erasers, blunt scissors, tissues, hand sanitizer, and lunch boxes/bags for boys and girls.

For teachers, the library system is collecting: tote bags, pens, pencils, markers, dry-erase markers, highlighters, planning calendar 2013/2014, notebooks, binders, bookmarks, construction paper, reference/educational books, reward stickers, paper clips, stapler, tape, scissors, tissues, hand sanitizer, water bottles and lunch bags.

Items being collected for infant and toddlers include: diaper bags, diapers, wipes, ointments, hand sanitizer, baby blankets, bibs, stuffed toys, teething toys, baby bottles, baby cereal, and prepackaged toddler/infant snacks.

Gift cards to Walmart, Target and Staples are also being collected. These will either be used to purchase supplies to fill the bags or sent along as part of the donation. Local businesses are also encouraged to donate recyclable shopping bags (non-plastic).

Items may be dropped off at any of the three UCLS locations through July 24. The goal is have these items to Oklahoma at the beginning of August before the school year begins.

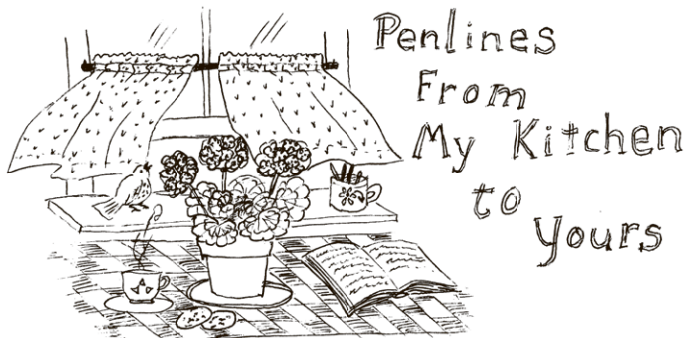

BROOKLYN, Mich.—Greg Biffle took the lead near the end of Sunday's 200-lap Sprint Cup race, then coasted to victory after his pursuer, Jimmie Johnson slapped the outside wall on lap 197. "I was really worried about him (Johnson)," said Biffle. "I knew that he had been gaining on me and that it would be close. But I felt like we had the advantage of the cleaner air by being out front. But if he had been able to keep coming, I don't know."

Biffle had a good car throughout the race, but not a dominant one until the last pit stop on lap 167. After his crew made adjustments, he went to the front, and was never challenged. "We had a great race car," said Johnson, who finished 28th. "And we had great strategy throughout the race. The little problem I had there at the end cost us a great day."

Kevin Harvick finished second, but was never a threat to the winner. "I think everyone on the team did a great job and are satisfied with today," said Harvick. "We made adjustments on our first pit stop and the car just kept getting better and better. We just couldn't get it to the front in time."

Martin Truex ran a good race and came home third. "The car ran funny all day," said Truex. "Our old tires were as good as the new ones. We tried a lot of different things, but whatever changes we made, the car stayed the same."

Kyle Busch, Tony Stewart, Matt Kenseth, Clint Bowyer, Carl Edwards, Joey Logano, and Jeff Burton were the remaining top-10.

Biffle's teammate and polesitter Carl Edwards saw his chances for a win slip away after his team called for a green flag pit stop during lap 162. A caution came out as soon as he returned to the track, which meant he had to go to the rear of the field when green flag racing resumed. The engine in Dale Earnhardt Jr.'s car went sour, and he wound up with a DNF, finishing 37th.

Kurt Busch was one of the early leaders, but brushed the wall during lap 29, and finished 39th. Earnhardt's teammate Jeff Gordon was involved in an early wreck, and was out after only 52 laps.

BIG MONEY TALKS IN NASCAR

For those race fans who believe money is not the major factor in NASCAR racing, they need to rethink their beliefs. A glaring example of this came last week, while Brad Keselowski was visiting Ford Motor Company's headquarters in Dearborn, Michigan.

In a USA Today article, Keselowski accused Hendrick Motorsports and Joe Gibbs Racing of luring some of their employees away with big money contracts.

"Hendrick and Gibbs have this nasty little habit of going to other teams and outbidding other people and taking those employees and stealing our information, and, when that happens, that puts walls up between the camps because you are giving up more than one piece of information," said Keselowski. "You are giving up two companies' information and trying to protect yourself

against that, it forces you to put up walls. It doesn't necessarily lend itself to working together."

Keselowski cited two incidents where he claimed Hendrick and Gibbs lured away Ford team employees with big offers.

"Gibbs stole the Roush aero director and took all the information," continued Keselowski. "And Hendricks took three employees from our Chase-winning team last year."

Rick Hendrick didn't agree, and issued a different version of Keselowski's story.

"The comments Brad reportedly made were misinformed. The truth is that we hired one tire changer, who was a backup for Penske and whose contract was up. We also brought over one mechanic from their Nationwide program and, when the Penske engine shop was closing, added a few of those people.

"What Brad left out was that his organization also hired one of our tire changers. All of this was above board and is part of doing business in a competitive environment. I take no issue with any of it, and I expect Roger [Penske] would say the same. Brad misrepresents the facts and spends a lot of time making insinuations and accusations about other teams when he should be focused on his own program and competing at a high level. I hope he figures that out and begins representing himself and the sport with more class."

It appears Keselowski may have stuck his foot in his mouth, but speed does cost money. Having the best workers guarantees better performance on the race track, which translates into more wins.

FORMER NASCAR DRIVER LEFFLER KILLED

NASCAR driver Jason Leffler died after an accident June 12, in a 410 Sprint Car race, at Bridgeport Speedway in Swedesboro, N.J.

Leffler, who was from Long Beach, California, made 423 starts in NASCAR's three national series

The 37-year-old Leffler, a two-time winner in the NASCAR Nationwide Series came onto the racing scene after winning three consecutive USAC racing championships from 1997-1999.

He went into NASCAR with Chip Ganassi, after finishing 17th in the 2000 Indianapolis 500. But it was a short stay. Leffler failed to qualify five times in the 36 Cup races for Ganassi, and was released. Although he did return to the Cup level, he only had 11 starts over the last four years.

His last NASCAR race was June 9, at Pocono.

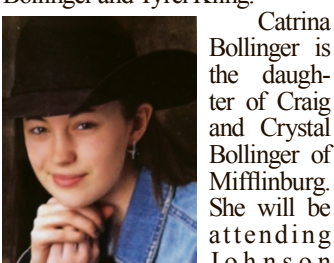
