Keller's Auto Body

Keller's Auto Body Towing and Recovery Incorporated is celebrating their 60th Anniversary. Three generations have worked in the family business. Matt Keller is the current owner of the business started by his father Andrew. Matt's son Cody is learning the business and will take over ownership sometime in the future.

For Cody Keller being a part of the family business is all he has ever wanted to do. "It's just because I grew up here and was here every day. It is a natural thing." Cody is a tow truck driver/operator. He also works in the office. He attended Penn College for Business. Cody also races the Keller's Sprint car at Selinsgrove Speedway.

He explains the success of Keller's Auto Body, "We have been here so long. We treat our customers with the best service. We have been here since 1953." He adds, "We have a loyal customer base and you see a trend as generations of customers return."

Although Andrew Keller turned the business over to his son years ago, he still is invested in all aspects of the operation. "Grandpa comes over every day, walks around and checks everything out." Cody Keller continued, "He looks at wrecked vehicles, observes what is going on, and gives his 2 cents worth."

Andrew Keller didn't start with a dream of owning an Auto Body shop. He worked in his father's business-Keller's Ice and Beer. "The trucks needed to be painted. So I painted them. Everyone in town liked the paint job I did on the trucks." He painted each of the three trucks a different color. One was cream, another green and the other was painted red. That job sparked an interest in painting and body work. "The trucks had some dents and started hammering on fenders to straighten them out."

While in high school Andrew was drafted into the Army. After the war Andrew went to Williamsport Tech under the GI bill. His family wanted him to further his education. "School was so many hours a day. In the meantime I had gotten married. So I worked the night shift at Benner Motors

(Selinsgrove Ford) and for Red Fisher."

Then he had an opportunity to rent a garage on Spruce Street in 1953. Andrew had one full time body man when he opened his garage. He operated out of the Spruce Street location for five years.

Andrew Keller began his towing business there with one wrecker. "When I got my first wrecker on Spruce Street, it was white. Then I painted it green but the dark colors didn't show up in the bad weather. Yellow worked better or visibility for oncoming traffic." Keller painted his truck Corvette Yellow. Soon all his vehicles were painted his trademark yellow color. Later when it was time to repaint the building, it went from white to yellow to match the trucks.

The police needed someone to come out right away when there was a wreck. So Keller's Auto Body Towing and Recovery became one of the first Quick Responders in the area. Then he purchased land at the present location of Keller Auto Body. "The old building served a purpose but the new one held more vehicles." The new location later allowed for greater expansion as larger trucks were added to the fleet.

Many people attended the Grand Opening of Keller Auto Body. "Lots of people in town came to see the new building and have me check out their cars."

The eldest Keller was an innovator and had a vision of where he wanted his business to head. When the building was under construction, Andrew Keller had them install a paint booth, fans, lights and filters. He purchased a frame and alignment machine. "At that time, for a small town and rural area we were pretty well-equipped." He continued, "I was the first one in the area with a 10 ton hydraulic wrecker that extended and turned."

Matt Keller is the current owner of the shop. Matt grew up in the shop. He did body work, painted cars, pushed a broom and helped out however he could. He worked full time in the family business after graduating from high school in 1981. He also furthered his education by attending Paint

Refinishing School and Frame and Unibody School. Matt took over the business when Andrew retired to take care of his wife who was stricken with cancer. In 1987 the business became incorporated.

Andrew Keller added onto the garage as the business grew. His son Matt added another section to the garage as the business continued to grow. In 1999 Keller's Auto Body expanded to include the Liverpool location. In 2002 Keller's expanded into the Milton/New Columbia area to provide heavy duty towing and recovery on the interstate. Keller's Auto Body does light, medium, and heavy towing, body work, paint, frame work and general repairs...just about everything.

Matt Keller commented on the changes in the business. "Collision repair has really changed over the years. Nowadays, vehicles are built to keep people safe but are not cost-effective to repair." Keller's Auto Body provides a variety of services. "We have state-of-the-art equipment for medium and heavy duty towing and recovery." This service is available at all three locations.

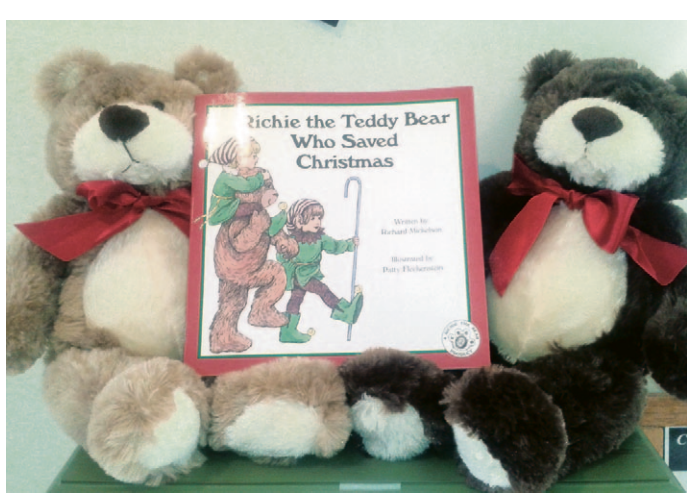
Keller's Auto Body excels in

the refinishing of vehicles in the collision repair industry. The Towing and Recovery side of the business is available 24 hours, seven days a week and employs certified employees to handle any recovery situation.

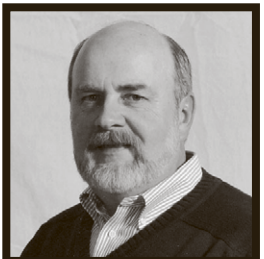

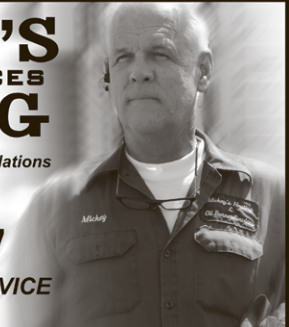

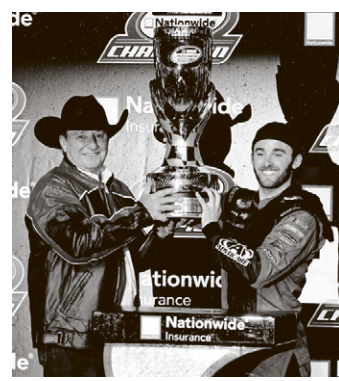

Johnson Cruises To Sixth Championship



The fireworks have ended. The lights are out, and the final checkered flag has been given in the 2013 NASCAR Sprint Cup season.

Denny Hamlin won the Ford 400 Cup race, but it was Jimmie Johnson, who took home the big chrome-plated championship trophy, the sixth of his career.

Hamlin took the race lead from Dale Earnhardt Jr. on lap 243 of the race's last restart, and led the remaining 24 laps of the 267-lap race, for his first win of the season.

"This one's for all my friends that stuck with me," said Hamlin. "What a way to end the season."

Hamlin's teammate, Matt Kenseth led the most laps (144) and finished second.

Kenseth went into the Homestead race 23 points behind Johnson in the Championship Chase. His runner-up finish, coupled with Johnson's ninth place finish, means Kenseth finished second, 19 points behind the champion.

"We gave it our best shot," said Kenseth. "What an unbelievable year for us. We needed a couple better finishes, but overall, it's been a great one."

Johnson, who started seventh seemed to have it on cruise control for most of the race. Since he only needed to finish 23rd or better, it didn't appear he raced as hard as he normally would.

"Thank you. Thank you," said Johnson. "This has been a spectacular year. Racing is about people, and we've had some of the best people in the business help us win this one."

Dale Earnhardt Jr. finished third, followed by Martin Truex, Clint Bowyer, Brad Keselowski, Kyle Busch, Joey Logano, Jimmie Johnson, and Kevin Harvick.

Keselowski came from midway of the pack on a late restart and passed the leader, Kyle Busch, with two laps remaining in the 200-lap race to take over the top spot.

"That late-race restart was key," Keselowski said. "It was a heck of a finish for us. I didn't think we were going to have a shot at it."

"But we got the right restart and made our way through. I'm going to have to watch the in-car camera, because that was one hell of a ride. Be glad there wasn't a passenger with me, because they would have been screaming the whole way. I know I was."

Sam Hornish, who finished eighth, lost the title by three points.

Dillon did not have the best car for most of the night, and finished 12th.

"I was just glad to see Hornish's back bumper after the final restart," Dillon said. "I knew if I could see him and know where he was that I wasn't going to give up till the end. I had a great start and tried to get the jump on him. It worked out."

Mark Martin said Sunday's Sprint Cup race at Homestead was his last.

"It is hard to believe that I've lived this dream," said Martin. "I'm so fortunate. I got two chances at it. I got a chance at it and had success and failed, and had to go and start my career all over again and spend several years getting back up on my feet and getting a second opportunity in NASCAR."

"I am still - deep down inside, I'm still the kid from Arkansas that got the huge thrill the first time I went to Daytona as a spectator to watch the Daytona 500. I wasn't even a teenager yet. I never dreamed I would be able to do the things that I've done and to have the success that I've had. It's been a dream. Living a dream."

In 31 years of competing at NASCAR's highest level, Martin has earned 40 wins, 56 poles, 271 top-fives, 453 top-10s and led a total of 12,879 laps in 881 career Sprint Cup starts.

Although Martin never won a Sprint Cup title, he certainly put forth his share of championship-worthy seasons. Seventeen times he finished among the top-10 in points, and in five of those seasons, Martin was runner-up to the champion, finishing second in 1990, 1994, 1998, 2002 and 2009.

Martin will not leave racing completely. He will be testing for Tony Stewart's team in 2014. And if Stewart's broken leg hasn't healed in time for the Daytona 500, you might see him in that race.

Thanks for the memories.
This marks the end of NASCAR racing for 2013, but there will still be lot of racing news leading up to the 2014 Daytona 500. This year's Sprint Cup Awards will take place Dec. 6, in Las Vegas.

In my last article I had a mistake in my broccoli cheese casserole recipe. Instead of using one pound of butter it is suppose to say use one stick of butter.

November is here and that means Thanksgiving is just around the corner! It's the time of the year when most people feel like we gained 20 pounds just from eating a Thanksgiving meal or least that's how I feel because I like to eat.

So my youth group leader went and talked to this little girl and the little girl says this is the first time I have eaten in four days. I never realized until my youth group leader said that in church how much those community meals mean to people. I am not a crying person but when she said that in church it brought sadness to my heart to know that I have plenty of food to eat and that the little girl had nothing. Be thankful for what you have. Here are some recipes:

Onion Soup with Aged Cheddar and Swiss cheese:

- 2 tablespoons butter
- 8 cups red onions, thinly sliced
- 1 cup sweet potato, grated
- 1 cup red wine
- 4 cups low-sodium beef broth
- 1-2 teaspoons fresh rosemary, chopped
- 4 1/2 ounces aged cheddar cheese, grated
- 4 1/2 ounces Swiss cheese, grated

Preparation:
In a large sauce pan over medium heat, melt butter and cook onions 10 minutes, stirring frequently. Add sweet potato and cook for 3-4 minutes. De glaze with red wine and reduce by half. Add broth and rosemary bring to a boil and let simmer 15 minutes. Preheat oven to 450 Fahrenheit. Divide soup among oven safe bowls with a slice of toasted bread and a handful of both cheeses. Place bowls on a baking sheet and cook in oven until cheese is browned. Serve immediately. This is for 6 to 8 servings.
