## Convenience Store Thieves Apprehended

On Monday, January 30, 2012, police apprehended two suspects that robbed The Forest Hills Store, on Buffalo Road, West Buffalo Township, in Union County on January 28, 2012. The robbery occurred at approximately 7:15 p.m. as two store employees, Nichole Ann Mullany, 31, of Lewisburg and Courtney Marie Shirk, 21, of Mifflinburg, stepped out the side door for their break. They were forced back into the store by Michael Anthony Gulli, who was holding them at gun point and his accomplice, Jeffrey Stahl, 31, of Mifflinburg, who stayed outside. Gulli demanded they open the register and hand

over the money. Mullany was unable to open the register but grabbed a bank bag with \$400 in it and handed it to him. Gulli then fled the store.

On February 1, 2012, Stahl and Gulli were arraigned on charges of robbery, criminal conspiracy to commit robbery, theft and simple assault. They were committed to Union County Prison in lieu of \$100,000 bail. A preliminary hearing for Stahl was held on February 7, at 2:30 p.m. before District Judge Jeffrey Mensch, in Mifflinburg. A preliminary hearing for Gulli was held on February 9, at 9 a.m. before District Judge Jeffrey Mensch, in Mifflinburg.

The annual event features chili chefs vying for awards and an auction of over 100 items including a turkey hunt, paintings from local artists, gift certificates, sports memorabilia, clothing items, and a wide variety of wine and beer mirrors, signs, and glassware.

"We're glad the Scarlet D stepped up to keep this community event going," Betty Hollenbach, PACFI president, said. "And Budweiser continues to be our major sponsor." The event was always held at Mike & Dot's II until the popular bar and restaurant closed last year.

The state-wide event sponsored by the Pennsylvania Farm Bureau will benefit all five Ronald McDonald Houses in the Commonwealth. Food check-out Day started in 1998 and to date has raised more than \$700,000 for Ronald McDonald Houses in Pennsylvania.

## New Regional Police Force Formed

On Monday, February 6, 2012, the Buffalo Valley Regional Police Department (BVRPD) officially opened its doors at 8:30 a.m. with an oath of office ceremony presented by President Judge of Union and Snyder County Michael H. Sholley. The newly formed force is a combination of the Lewisburg Borough Police Department and the East Buffalo Township Police Department. The merger has kept all 15 members of both forces employed plus five part-time officers. The structure of the

newly formed force is a chief, lieutenant, an administrative sergeant, two corporals and the patrol division. The merger of the two department will prevent double investigations of cases since one officer is assigned to a case. This will ultimately save move and time. The phone numbers remain the same and they are still dispatched through the Union County 911 Center. There will still be patrol cars assigned to designated zones and rover cars.

## Libraries offer Tax Forms

Free federal and state tax forms are now available through the Public Library for Union County, Lewisburg; Herr Memorial Library, Mifflinburg; and West End Library Laurelton. Tax returns must be mailed by midnight on Tuesday, April 17, 2012.

Federal forms that are not available at the libraries may be obtained through the IRS website at www.irs.gov and may be printed at the libraries. State forms that are not available may also be printed. The Public Library for Union County also has a notebook of reproducible federal forms at the circulation desk. Each library may charge a small fee for printing or copying services.

Copies of local tax forms are also available at the circulation

desk at the Public Library for Union County. These include Lewisburg, Mifflinburg, Milton and Warrior Run school districts.

Along with offering tax forms, information on filing tax returns, local IRS contact information and local tax information are available on the libraries' websites under the "Find an Answer" page on the left side-bar. You can also find this information through the Union County Library System website at www.unioncountylibrarysystem.com.

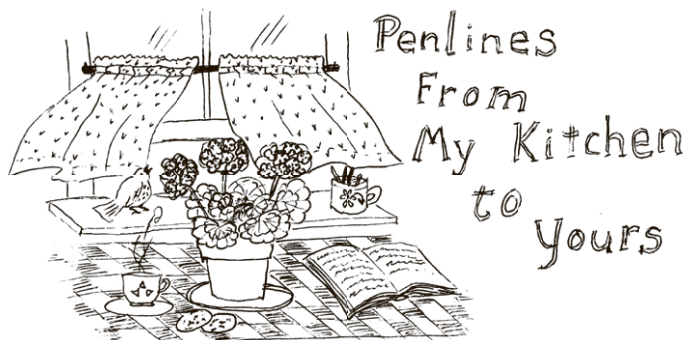

- 5 large eggs
- Salt and pepper to taste

Cover the bottom of an 8x8 dish with shredded potatoes. Spray potatoes lightly with cooking spray. Bake at 400°F for about 10 minutes or until browned. Mix all other ingredients well in a bowl and pour over the slightly cooked hash brown crust. Bake at 400°F for 25 minutes until well set and not overly browned.

## It's Time To Put Up Or Shut Up

With the season's first race, the Daytona 500, fast approaching, it's time for some teams and drivers to either "put up or shut up."

When a team falls to the bottom of the points standings, who should be faulted; the organization itself, or the driver?

In the case of Dale Earnhardt Jr., his team, Hendrick Motorsports is considered number one in NASCAR, but Earnhardt has yet to win a race with them. He said the first thing a team does when they start losing is blame the driver.

"A driver can only do so much," he said. "If he doesn't have a car capable of winning a race, he's not going to have a good day. If a driver has a poor handling car, he's going to be stuck back in the middle with all the other guys that are having bad days."

But Earnhardt is not alone. There are several Cup drivers that have what are considered great teams, but either no wins or a subpar performance.

Joey Logano came to the Cup scene with great expectations, but after several years with Joe Gibbs Racing, he has only one win, thanks to a rainout. The other two JGR teams driven by Denny Hamlin and Kyle Busch have several wins.

So the argument might be that Logano just doesn't have the potential to be a great driver.

Let's look at the Earnhardt Ganassi team, which fields cars for Juan Montoya and Jamie McMurray. This outfit has adequate funding and good equipment. They announced last week that their 2012 sponsorship quota had been reached.

With enough money it would seem any team could "buy" themselves out of a hole, by having the latest equipment and racing know-how.

But this hasn't been true for Ganassi's two teams.

A year after combining to win four Sprint Cup races, including the sport's two biggest events, Montoya and McMurray both went winless last year and finished 21st and 27th, respectively, in points. Both drivers had just two top-five finishes all season and were no threat to make the Chase.

How could an organization that won the Daytona 500, the Brickyard 400 and two other Cup races in 2010 fall so far in 2011?

While that still seems somewhat of a mystery to the drivers and crew chiefs, Ganassi has a good idea, and is very specific in summing that up as well.

"It's obviously looking at the wrong things and being led astray," he said. "We live in the information age and I don't want to be in the information age, I want to be in the correct information age. I don't need bad information, I need correct information."

"And that's obviously what happens with these teams. They get the wrong information and they are focused on the wrong things. That's how you think they are going to be good and they end up being bad. They were good for reasons that they don't even know why."

The information highway in NASCAR runs so fast that what is new today may be outdated tomorrow. Rick Hendrick told a group of reporters last week during the Charlotte Media Tour, "If you plan on using last year's technology and information, you might as well close up shop."

Ganassi cleaned house during the off season. Gone are competition director Steve Hmiel and team manager Tony Glover, two long-time veterans of the sport. Glover had been with the organization since co-owner Felix Sabates sold the majority of the team to Ganassi and Hmiel came over when the team merged with Dale Earnhardt Inc. in 2009.

Crew chief Brian Pattie also is gone, along with several other crewmen and engineers.

Former Roush Fenway Racing manager Max Jones has taken over as team manager while former Red Bull Racing technical director John Probst is the new technical director at Earnhardt Ganassi.

The first order of business is trying to figure out where the team got off track.

McMurray says simply, "I don't know." Asked what changed from 2010 to 2011, he says, "Nothing."

"That's what makes it so frustrating for us. We ended 2010 so good and we went into last year and didn't really change anything and struggled," he said. "... It wasn't like we went back and tried to recreate the wheel and make things better; we didn't change anything. We just didn't have the success that we had and the cars just weren't as fast."

"It seemed like we took just a short break (after 2010) and we went back to the track and no one knew our name, we didn't know our name. We didn't know where we were headed for some strange reason. The difficult part is putting our finger on what happened."

Felix Sabates said that the team's cars simply were not being built correctly.

"We went to (one race) and both cars wrecked within half a lap of each other. The frame came apart in both cars," he said.

"We thought we had something great, and it might have been great for IndyCar, and that's where we had some of the engineering people we had [come] from. That doesn't work. You've got to have a guy from (NASCAR) to make the cars go."

Sabates said another sure sign that the problem was the cars was Montoya's performance at Infineon Raceway, where he finished 22nd. Montoya has two Cup wins - both on road courses, including a 2007 victory at Infineon.

"When you go to a road course and Montoya is not one of the prominent drivers, that tells you something is wrong," Sabates said. "That might have been the eye-opener for Chip, when he saw Montoya in the back of the pack at Sonoma."

Sabates said it was difficult to pinpoint the source of the problems, thus the wholesale changes.

"It's time for us to put up or shut up. This has got to be the year when we shine and show people that we are here again."

The 54th annual Daytona 500 on Sunday, Feb. 26 will carry a record purse of more than \$19 million as well as a new contingency award that will payout \$200,000 to the driver leading at the completion of Lap 100. The posted awards for "The Great American Race" are \$19,142,601 with the winner collecting a minimum of \$1,431,325. The second, third, fourth and fifth-place finishers in the Daytona 500 will receive a minimum of \$1,050,075, \$759,600, \$609,900 and \$486,550. The Daytona 500 Mid-Race Leader Award will reward the driver leading the mid-way point of the historic 200-lap, 500-mile race with a \$200,000 bonus. If the race is under caution at Lap 100, the leader of the race at the completion of the fifth consecutive green flag lap following the caution will receive the award.

# Commissioners Adopt 2012 Budget

The Union County Board of Commissioners today adopted the 2012 General Operating Budget for Union County. The final budget version approved calls for a total county spending plan of \$19,983,628 and no tax increase (Union County's fourth consecutive year without a tax increase). With current year obligations paid, the \$289,117 difference between planned spending and projected 2012 revenues of \$19,694,511 will be covered by the county's fund balance. Commissioners cut \$1,007,925 from the tentative 2012 budget document placed on the table for review on December 6, 2011.

"The big news of this budget," declared Commissioner Chair Preston Boop "Is that Union County manages to buck the local government trend of paying for declining state and federal revenues with an increase on county property taxes." Commissioner John Mathias added, "The cooperation of Union County elected officials, department heads, and dedicated employees together with the financial stewardship of the County Administrator/Chief Clerk Dianna Robinson are key to the county's ability to provide one more time increased value for the same tax dollar investment." Commissioner John Showers noted, "The Commissioners timely refinancing of the Great Stream Commons bond issue in late 2010 has enabled the county taxpayers to again elude one more year of making bond payments with county tax dollars."

## 2012 Union County General Fund Budget highlights include:

A. \$325,000 is budgeted for merit/step and other salary scale adjustments in 2012 for Union County employees. Union County employees have not received merit or step increases for two years as an effort at county cost containment during the downturn of the economy. The Commissioners and County Treasurer will shortly begin review of the recommendations of a new merit/step plan as proposed by a recently completed consultant's study of the county employee compensation structure. These increases will be retroactive to January 1, 2012 when placed in operation early in the year.

B. An expanded investment and effort is offered with alternatives to county prison incarceration; turning lives around, restoring families, reducing the costs of inmate housing, reducing financial and time management impacts on the courts, and saving valuable county and state tax dollars in the administration of the county's Office of Children & Youth Services. Expanded efforts in 2012 include a solid commitment of the Board of Commissioners to continue the court's DUI and Drug Courts, continuation of the Union County Community Service Coordinator (began in August 2011) to place court offenders in valuable community service positions, and opening a day reporting center offering the court one more alternative to costly jail housing. This day reporting center opening later in 2012 will result in two additional county employees being hired; a program coordinator and an administrative assistant at the center. Union County has been promised a \$128,000 grant from the Pennsylvania Commission on Crime and Delinquency to assist in the opening and initial operation of the center.

C. The expected 2012 gift of the Federal Reserve Center in Kelly Township to Union County will also allow for storage of equipment, supplies, and vehicles used by the county's Emergency Services department. This budget reflects those operations.

D. The 2012 budget cuts no county employees and adds a second county IT employee to deal with the growing county investment in computers and technology.

E. The budget calls for the expenditure of \$75,128 for efforts to expand digital technology and services in the Union County Office of Prothonotary and Clerk of Courts, and the Office of Register and Recorder.

F. The new budget picks up for the first time increased bond payments (\$329,655) for the financing of a new emergency radio system for Union County and upper Northumberland County. Union County Commissioners are working to seek a greater financial contribution for emergency 9-1-1 services provided to upper Northumberland County.

G. For the most part, annual contributions to cooperating and outside county agencies remain the same. We are pleased to include a \$15,000 grant to the Mediation Center this year.

H. In keeping with the Commissioners' commitments made in "Cultivating Community: A Plan for Union County's Future" (Union County's Comprehensive Plan), Union County's annual appropriation for Agriculture Land Preservation continues at the same investment of \$125,000. Investment in Union County's farmland preservation began in 1990 and has continued annually since.

I. An additional \$1500 was included to prepare for the Union County's 2013 Bicentennial Celebration.

J. The 2012 county budget also includes growing payments for county employee health care insurance (\$1,145,000) and for the county retirement system (\$725,000).

K. Capital projects are financed by the county's Capital Reserve Fund which is used to finance the county's long-term facilities renewal and replacement plan. The county's annual contributions to the reserve have averaged approximately \$275,000 in recent years. These projects for 2012, include among other minor projects, the replacement of the roof membrane system at the County Government Center at Mifflinburg and upgrades and replacements in the courthouse HVAC system to improve air quality in the 1855 courthouse and addition.

L. The county's policy is to maintain operating fund balances in the neighborhood of \$2 million to fund cash flow needs and other contingencies. For 2012, our anticipated fund balance allows us to comfortably finance the projected budget shortfall and maintain our reserve policy.

The Union County Commissioners stated in a 2012 budget directive to county elected officials and department heads on September 15, 2011, "As we stated in our memo last year, our over-riding goal is a government that is effective, efficient and economical. It is imperative that our budget reflect that goal, while not increasing if at all possible the millage rate on real estate taxes." Commissioners Boop, Showers, and Mathias concluded, "To that end, our work has been accomplished. Happy New Year!"

## Letters Written During WW1 From Jay A. Rigel to Family and Friends

### THOUSANDS SOON TO QUIT OHIO CAMP

Article from the Cleveland Plain Dealer - April 29, 1918 (Continued from last week)

"With the arrival of the last of the first increment of the second draft by the middle of this week, the cantonment will be taxed to its present capacity. Officers have pointed out that there are several alternatives when new selectives are sent here for training. Either some of the troops who have been here longest can be moved or the camp can be enlarged. It was stated today that no authority had been received to construct additional barracks.

"Two thousand, one hundred and forty-seven new selectives arrived here today and were assigned to the first, third, fourth, sixth, eighth and ninth training battalion. Cleveland and Columbus men formed the greater part of today's quota. The newcomers were issued as follows: First battalion - Franklin county, 712; Columbus board No. 1, 103; No. 2, 108; No. 4, 110; Pickaway county, 33. Third battalion - Cleveland No. 1, 97; No. 8,98; No. 10,88; No. 11, 01; No 13, 101. Fourth battalion - Toledo, No. 1, 128; No. 5, 96; Wyandot county, 26; Marion, 69; Delaware, 39. Sixth battalion - Akron, No. 1, 3; No. 2, 5; No. 3, 7; Holmes county, 23; Perry County, 48. Eighth battalion - Cleveland, No. 2, 64; No.3, 90; No. 4, 59; No. 4, 142; No.6, 180. Ninth battalion - Lawrence county, 53; Scioto county, 99; Pike county, 19.

"Brig. Gen. Willard Holbrook, commanding the 165th infantry brigade here, is slated for a post at another cantonment, according to information received here today. Gen. Holbrook, who was recently nominated by President Wilson to be major general, is to return from Washington tomorrow morning, where he has been in conference with war department officials since last week.

"A telegram was received here today instructing that his property and personal effects be packed up at once. Reports had it he is to command the troops on the Mexican border. With his departure Camp Sherman will be without a brigadier. It should have at least four, according to military schedule.

"Options were being closed today on additional land adjoining the camp totaling 300 acres. Huge sheds and warehouses are to be constructed on the property, while additional trackage will be laid from the Baltimore & Ohio railroad, which bounds the land on the west. The sheds and warehouses will cost about \$150,000, it was stated today."

Letter to: Mr. Norman Rigel  
Date: May 16, 1918  
Location: Camp Sherman

Dear Parents and Bro,

This is Thursday evening so will write a few lines. I sure hope you are home by this time (Father).

Well, I had to go for a hike on Monday noon and got back yesterday about 4 o'clock. I had to haul some of the boys bedding, also officers bedding. We were not very far from camp.

I have not heard very much about us leaving since you left. We are getting new rifles. The ones we have are not fit for overseas service. I saw John Herbst today. We got the rifles from the warehouse he works in. The man we met at the depot is the father to the (Elliot) in my company. It must be one of the boys in Headquarters Co.

I sent two of my pictures home. I don't want them here if we leave soon. I gave one to each of the boys and left one with Chas for myself. We had rain all Sunday night. How many chicks have you now, Mother?

Well, news is scarce and Father could tell you about the camp. Suppose you are finished planting the corn, Norman.

I got a letter from Wm yesterday. He thought maybe I left camp. I had not written for two weeks.

I will close for this time. I am well as this leaves here and trust it will find you the same.

My love to all, Jay
