## PA Property Tax/Rent Rebate Appointments

The Union-Snyder Agency on Aging is sponsoring appointments to assist individuals with completing the Property Tax/Rent Rebate Form PA-1000. This program began in 1971 and is funded by the Pennsylvania lottery. The Rebate program benefits eligible Pennsylvanians age 65 and older; widows and widowers over age 50 and older; and people with disabilities age 18 and older. The income limit is \$35,000 for homeowners and \$15,000 annually for renters with half of the Social Security income excluded.

The minimum rebate is \$250 and the maximum standard rebate is \$650. Property owners will need paid property tax receipts for 2011 and renters will need their landlord to complete the Rent Certificate. Available dates include March 21st at the Penns Creek Adult Resource Center and April 18 at the Lewisburg Senior Center. Additional locations for rebate appointments include Senior Centers in Selinsgrove, Beaver Springs and the West End. Please call 524-2100 or 374-5558 for your no cost appointment.

## Fire Destroys Home, Pet Perishes



Charles Hulsizer, 62 and his companion Linda Enlehart, both of Colonel John Kelly Drive, Buffalo Township, Union County, returned home on Thursday, February 23, 2012, at approximately 4:31 p.m. from a trip to the pharmacy, in Mifflinburg, to find their home up in flames.

Firefighters from Mifflinburg were called to the scene to extinguish the fire. Their cat perished in the fire due to the fact that firefighters were unable to save it or much of their belongings; however, firefighters were able to save Hulsizer's gun collection that was kept in an upstairs room that remained untouched by the fire. They were not home when the fire began and all the

doors and windows of the residence were locked.

State Police Fire Marshall Norm Fedder reported that the fire began in the area of a ceiling light in the kitchen of the residence. The light and the electrical wires leading to the light were the only potential ignition sources in the area. Hulsizer had recently renovated the 100 year old home where he has lived for the last 30 years. The fire was ruled accidental.

Hulsizer was insured for the home and its contents. The estimated value of the home was \$150,000 in damage. He is currently living with family until he decides what he will do next.

systems, electronic health records, medical orders and other sources of information, and assist the critical care staff at Evangelical Community Hospital when a patient is trending toward a serious health event.

"The new eICU program will offer advanced care for our most critically ill patients," said Doyle Ashburn, D.O., medical director of critical care, Evangelical Community Hospital. "By using this new technology many patients who may have previously required transfers to tertiary hospitals, can continue to receive their care at Evangelical."

The program will complement care delivered by critical care physicians at the bedside, according to John McIlwaine, D.O., director of the eICU at Geisinger Health System. Real-time voice and video communications, as well as data, will be utilized to ensure continuous remote monitoring of intensive care patients at Evangelical Community Hospital.

"Patients in the intensive care unit are at the highest risk because of their illness' complexity. The vision of this program is to enhance patient safety, and the efficiency of care that is delivered," said Dr. McIlwaine. "We are extremely pleased in our partnership with Evangelical Community Hospital in offering this advanced technology to those in the region who need these very critical services."

Data suggests hospitals with eICU programs realize reduced mortality rates and patient lengths of stay.

# Kenseth Wins Marathon Daytona500

Matt Kenseth won the Daytona 500 ahead of Dale Earnhardt Jr., in a race that started Monday night at 7 pm and ended Tuesday after 1 am. "I didn't really think I could win," said Kenseth. "The engine was spewing water early in the race and I thought we would cook it. I've got to thank Greg Biffle, my teammate for sticking with me. This was a team win."

Kenseth was the leader when green flag racing resumed on lap 165 after a caution. His Roush Fenway Racing teammate, Greg Biffle was lined up on the outside, and the pair were able to get hooked up and pull away from the rest of the field.

Kenseth was still leading when the final caution out on lap 193, after a six-car pileup involving David Gilliland, Ryan Newman, David Reutimann, Ricky Stenhouse, Dave Blaney, and Tony Stewart.

This set up a green-white-checked finish with Kenseth on the inside and Biffle on his outside. Denny Hamlin and Earnhardt were lined up behind them.

Biffle was again able to get behind Kenseth and push him. Dale Jr. got around Hamlin and was on Biffle's rear bumper for most of the final lap. As the leaders exited turn-4, Earnhardt pulled out. He barely got by Biffle, but was unable to catch Kenseth before the race ended.

"I could have won it, but Biffle wouldn't pull out," said Earnhardt. "I pushed and I pushed him (Biffle), but nothing was happening, so I pulled out. I got him, but no way was I going to get Matt."

For Biffle, who finished third, it was a team victory. "I don't know what happened," said Biffle. "The 17 (Kenseth) had lots more motor than I did. I wasn't able to get a run on him."

Denny Hamlin, Jeff Burton, Paul Menard, Kevin Harvick, Carl Edwards, Joey Logano, and Mark Martin were the remaining top-10 finishers.

Heavy rain soaked Daytona International Speedway on Sunday, and NASCAR never had a big enough window to dry the track. The race was rescheduled for 12 noon on Monday, but had to be pushed back to 7 pm because of persistent showers.

The night's first wreck occurred right at the start of lap-2, when Elliott Sadler got into the rear of Jimmie Johnson's No. 48, and spun him into the outside wall. Kurt Busch, Danica Patrick, David Ragan, and Trevor Bayne were caught up in it.

Busch, Patrick, and Bayne were able to get their cars repaired and go back racing, but Jimmie Johnson had to call it a night.

"That was a hard lick," said Johnson. "I don't know why he (Sadler) got into me so hard. It's unfortunate, but we'll go to Phoenix and hope for better luck."

Martin Truex collected the \$200,000 lap bonus for leading the race at the halfway point.

Jeff Gordon lost the engine in his No. 24 Chevrolet and did not finish.

One of the scariest moments of the race came on lap 160, when under caution, Juan Montoya developed a vibration in his No. 42 and lost control. He slid up the track and hit one of the speedway's trucks, which was pulling a jet dryer.

The 250 gallon fuel tank on the jet dryer ruptured, sending flames nearly one hundred feet into the air, and spilling flaming fuel across the track.

Montoya's car was burned completely up, but he escaped without any injuries.

NASCAR had to red-flag the race for over two hours while speedway safety crews extinguished the burning fuel and cleaned up the track. **BUESCHER GETS FIRST NATIONWIDE WIN**

James Buescher weaved his way down the front straightaway through a mass of wrecking and spinning cars to win Saturday's Nationwide race.

He was running in the 11th position going into turn-4. As Kurt Busch, Tony Stewart, and the other leaders began smacking into each other and sliding all over the track, Buescher never let up and was somehow able to avoid the melee of cars.

However, there was some controversy surrounding his win.

According to Brad Keselowski, who finished third, NASCAR should have put out the caution earlier. He said that it was six-seconds after the big wreck occurred before the yellow flag was displayed. This allowed drivers to continue racing, which could be dangerous, given all the spinning cars.

"There's no doubt to me that the most dangerous aspect of the sport that's left is the yellow flag situation on the closing laps of the race," he said.

Unlike Buescher, Keselowski let up on the gas after seeing the wreck ahead of him. Had he remained at wide-open throttle, he might have won the race, because he was ahead of Buescher when the wrecking started.

"When I look at the sport and look at the most dangerous frontier, it's not the next head and neck restraint system, it's getting hit by a car that is six or seven seconds from a wreck but has to keep going because the yellow is not out," continued Keselowski.

NASCAR officials defended their decision, saying they allowed for more time because it was the last lap, there weren't cars directly ahead of the leaders, and the leaders automatically slow down at the finish line.

Elliott Sadler, Brad Keselowski, Austin Dillon, Taylor Malsam, Tommy Hill, Cole Whitt, Tony Stewart, Kasey Kahne, and Kurt Busch were the remaining top-10 finishers.

It was certainly a bad week for Kurt Busch. He wrecked in Cup practice, the Bud Shootout, and was leading the Nationwide race when he wrecked again. The way he is demolishing cars, let's hope his team has a sponsor with deep pockets.

## PATRICK HAS A TEMPER LIKE THE BOYS

Danica Patrick is getting acquainted with the walls around the Daytona track.

Just two days after hitting a retaining wall in one of Thursday's qualifying races, Patrick got clipped again, this time by her own teammate, Cole Whitt, causing her to spin and hit the inside wall.

"What the (expletive)," she shouted over her radio. "He (expletive) hit me."

Patrick was able to drive her damaged race car to the garage. Once there, she jumped out, helmet still on, and stormed into her team hauler, ignoring the small army of reporters.

"There isn't much I can say," said Whitt. "I simply got into her. It wasn't much, but it was enough to spin her out."

On Thursday she was bumped by Aric Almirola. The wreck on Saturday ruined what could have been a good day for

Patrick, who on Friday became just the second woman ever to sit on the pole for a Nationwide Series race. She finished 38th. **KING WINS WILD DAYTONA TRUCK RACE**

King was in the lead on the third and final overtime when Joey Coulter's truck flew into the fence on the front straightaway.

Unlike the 2.5-mile Daytona track, which has up to 31-degree banking, the one-mile Phoenix track only has 11-degrees in the corners. Qualifying speeds at Daytona reach 194 mph, while at Phoenix they are generally around 133 mph.

There will be wrecks, but it will be more like bumping and shoving, and rubbing. When wrecks do occur, they won't be as violent, or involve as many cars.
