The thirty-fourth Annual Union County West End Fair Junior Livestock Sale was held in Laurelton on Friday, August 10th, 2012. Fifty-one different members of several Union County 4-H Clubs and the Mifflinburg FFA Chapter sold animals at the sale. A total of ninety-eight lots containing nine steers, fifty-six market hogs, twenty-four market lambs, two dairy beef feeders, and seven rabbit meat pens were sold. Fifty buyers supported the youth by purchasing animals during the Eighty-seventh Annual Union County West End Fair. The sale grossed over \$82,000. Bryan Imes of Port Royal donated his service and was the auctioneer at the youth sale.

The Grand Champion Market Steer was purchased by Sue Iddings for Carriage Corner Restaurant and Iddings Quarry of Mifflinburg. A bid of \$3,000 per pound was accepted for the 1,325 pound steer owned by Hannah Imgrund of Lewisburg. Hannah is a member of the Union County Kelly-ites

M Catering, Hoover Tractor, & Bill Manning.

The Grand Champion Market Lamb owned by Brittani Hook was purchased by of the Mifflinburg Bank and Trust Company. A bid of \$9.00 a pound purchased the 134 pound market lamb owned by Brittani Hook. Brittani is the daughter of Steve and Brandi Hook of Lewisburg. Brittani is a member of the Mifflinburg FFA. Steve Hook III was the owner of the Reserve Champion Market Lamb. His 126 pound market lamb was bought by Dennis Keefer for the West Milton State Bank at a price of \$5.00 per pound. Steve is a member of the Cowan 4-H Club and is the son of Steve and Brandi Hook of Lewisburg. The average sale price for the non-champion lambs was \$4.69 per pound which is the new fair record price. The Grand Champion Rabbit Meat Pen was bought by Dennis Keefer of West Milton State Bank of Mifflinburg for \$35.00 a pound. The 14 pound meat pen of three rabbits was owned and bred by Evan Smith of Lewisburg. The Kelly-ites 4-H Club member is the son of Luke and Alisha Smith of Lewisburg. The Reserve Champion Rabbits were raised by Amy Chappell. The 10 pound pen of rabbits was purchased by William Wolfe Auctioneering of Mifflinburg for \$21.00 a pound. The Mifflinburg FFA member is the daughter of Tyson and Karen Chappell of Mifflinburg. The remaining pens of meat rabbits averaged \$12.40 per pound. They were purchased by Pik-Rite Manufacturing, Brother's Transportation, TJ Martin Construction, and The Bomgardner Family.

The Grand Champion Dairy Beef Feeder steer was sold by Chelynn Bingaman of Millmont. The 720 pound feeder was purchased by Glenn Wiand of Hallmark Feeds at \$2.00 per pound. Chelynn is the daughter of Mark and Mary Bingaman of Millmont. Chelynn is a member of the Mifflinburg FFA. The reserve champion dairy feeder steer was owned by Hannah Imgrund of Lewisburg. The 685 pound feeder was purchased by Pioneer Hybrids for \$1.50 a pound. The Kelly-ite 4H member is the daughter of Eric and Nancy Imgrund.

Annual Benefit Labor Day Weekend

Camp Mount Luther in Mifflinburg will be holding a 5 and 10 Kilometer trail run race at the camp Labor Day Weekend. This is the eleventh year for the event at the camp, located five miles west of Mifflinburg.

This will be an entry-level trail race on Mount Luther grounds with proceeds going to the camp. It is being organized by Joel and Shelley Heasley of Middleburg. The Dandelion Run was named in honor and memory of Rev. Glenn E. Heasley, Jr., former Assistant to the Bishop of the Upper Susquehanna Synod of the Evangelical Lutheran Church in America. Glenn's favorite "flower" was the dandelion.

The date of the race is Saturday, September 1, 2012. The start time for the race is 9 a.m. Runners decide on race day if they want to do a 5k or 10K (a double loop of the 5K) run. Age group awards will be presented and pre-registered participants will receive a drawstring sports pack. (A limited number will also be available on race day.) Registration opens at 7:30 a.m. on race day. Spectators are welcome as well.

A kid's fun run (registration for that is one dollar) and a one-mile fun walk will also be held. The same registration fees and amenities apply for the fun walk which will take place on a dirt road. Awards will be given for overall male and female race time, three awards for each

age group and an overall master's for male and female in both the 5K and the 10K. The awards ceremony will be immediately following the race.

All miles for the course will be marked and there is one water stop on the course. Timing will be electronically done. Registration forms are posted on the camp's website at www.campmountluther.org or at www.midpenntailblazers.com or you can contact Joel Heasley at 570-765-0267. Shower facilities are available after the race.

Camp Mount Luther is a Christian church camp affiliated with the Evangelical Lutheran Church in America. All proceeds from this event will benefit the camp's general operating fund.

Hazmat Leak Approximately 10:20 p.m. August 9, in the Short Stop Mart parking lot, in White Deer Township. A Halliburton Tractor hauling 4000 gallons of hydrochloric acid from Home City, PA, to Montrose, PA, which was traveling along I-80 East, developed a leak at the rear of the tanker, causing acid to leak. Once the acid hits the air it vaporizes causing a toxic gaseous cloud. The driver, Gregory Pellicer Jr., 28, of Lawton, OK and his co-driver, Nicklaus Cunningham, 38, of Semmes, AL, took immediate steps to start containing the leak and notifying a hazmat response team and EMS. Northridge Group Inc. (Hazmat crew) arrived on the scene and stopped the leak. Union and Snyder Counties EMA along with the PA Department of Environmental Protection (DEP) and the White Deer Township Fire Department and Milton Fire Department all assisted on the scene. A hazmat crew from Halliburton arrived on the scene and transferred the load and assisted with the clean up. As a precaution five people were evacuated from the surrounding residences and New Columbia Road was shut down by fire police for approximately six hours while crews cleaned up the leak.

Crash 1:27 p.m. August 7, on Broad Street at its intersection with 7th Street, in Kelly Township. A 2009 Kawasaki 600 Ninja driven by Chris L. Walker, 46, of Watsonstown, was traveling east on Broad Street, in the village of West Milton, when a 1995 Toyota Camry driven by Joyce M. Satteson, 67, of New Columbia, was traveling west on Broad Street. Satteson turned left in front of Walker causing him to strike the right front fender of her vehicle. Evangelical Prepares Through Exercise On Hazardous Materials and Mass Casualty

On Tuesday, August 21, 2012 starting at 7 am and running throughout the day, Evangelical Community Hospital, in conjunction with other federal, state, and local agencies, will be holding a hazardous materials and mass casualty exercise. The exercise will not affect normal hospital operations and patients will not experience delays during the event. Hudson continues, "The staff at Evangelical show extraordinary teamwork, and exercises build confidence that if a real-life incident were to take place, those teams can come together and provide exceptional care even in a catastrophic situation." Ambrose Wins With Amazing Finish

WATKINS GLEN, N.Y.—In an amazing last lap finish Marcos Ambrose went from third to first in Sunday's Sprint Cup race, as he survived Kyle Busch's spinning car and several bumps from runner-up Brad Keselowski.

Events leading up to the wildest finish of the season actually began on a restart with 16 laps to go in the 90-lap race. Keselowski was leading, but as soon as the green flag was given, Kyle Busch and Ambrose jumped ahead of him.

Keselowski was able to pass Ambrose, but by then, Busch had checked out on the other cars and led until the beginning of the final lap.

Right after the white flag was given, signifying one more lap, Busch's No. 18 spun in some oil. Keselowski took advantage of Busch's bad luck and was able to get by, with Ambrose right on his rear bumper.

Keselowski and Ambrose remained close, with minor bumping and shoving for almost the entire lap. Finally, Ambrose was able to make a move under Keselowski as the cars were in sight of the checkered flag. But even after Ambrose had gotten the lead, the two drivers were still bumping and rubbing.

"What a last lap," said Ambrose. "I mean that was about as hard as I've ever raced. We kept getting in oil and going all over the track. I just had to take my chances, but this was a race I'll remember for a long time."

It was Ambrose's second Cup win at the Glen. His other victory came in 2011.

"There was oil all over the track," said Keselowski. "I got in oil, Marcos got in oil, and Kyle got in oil. But the way we were able to race each other is the way racing should be."

Jimmie Johnson finished third and is the new points leader. Clint Bowyer, Sam Hornish, Greg Biffle, Kyle Busch, Matt Kenseth, Regan Smith, and Martin Truex were the remaining top-10 finishers.

Jeff Gordon, last week's Cup winner at Pocono had a top-10 finish going, but spun out near the finish line.

"There was oil all over the track," said Gordon. "I'm pretty bummed out right now. We were good on the restarts, but to have something like this happen is pretty bad."

Dale Earnhardt Jr. spun out late in the race and finished 28th. He dropped from first to fourth in points.

Polesitter Juan Montoya had a spinout along with mechanical problems, and finished 33rd.

CARL EDWARDS ON WEATHER AT POCONO

While taking part in the test session at Martinsville Speedway last week, Carl Edwards answered questions from the media about the fans struck by lightning at Pocono.

A total of 10 race fans were struck by lightning in the Pocono Raceway parking lot after the conclusion of Sunday's Pennsylvania 400. All were transported to local hospitals with various degrees of injuries. Nine have been released. The tenth victim, Brian Zimmerman, was fatally injured during the storm.

"I spoke with one of the gentlemen in the hospital up there yesterday that was struck by lightning and he told me the story in detail about what happened to him and his friends and it sounded like a very terrible scene," said Edwards. "I've read a little bit about it and I know there's a lot of discussion about what NASCAR should have done or the track should have done, but, I think, at the end of the day, it's Mother Nature and it's very difficult for anyone to take responsibility and say, 'We should have done this or done that.' It's something that I would have never expected."

"I walked right out from my hauler to my motorhome in the middle of that rainstorm and I ignorantly didn't think about the dangers that were there. I think we all maybe take that stuff a

little too lightly. I have to tell you that after talking to that gentleman, Tony, my thoughts and prayers are with him and his really good friend who is pretty bad off. He's recovering and the family that lost their father, it's tragic.

"He's a big 99 fan and the folks at Pocono got me in touch with him. The gentleman that lost his life, that's just really sad. I believe the way he told the story there were three guys that were injured. Tony, the guy I talked to was injured the least. His one buddy is pretty bad off and his other friend obviously lost his life. From what he told me, I don't want to speak for him or anything, but it was as big of a surprise to him that something like that happened. They didn't expect that and I don't think they saw anything coming. They didn't think there were at that big of a risk. It's just tragic."

Pocono Raceway has established a memorial fund to benefit the victims of the lightning strike tragedy. Donations will be accepted at any PNC Branch or by mailing checks/money orders, addressed to "Pennsylvania 400 Memorial Fund" to: Pocono Raceway, Attn: Pennsylvania 400 Memorial Fund, 1234 Long Pond Road, Long Pond, PA 18334.

Dodge will withdraw from NASCAR competition at the conclusion of the 2012 season.

Ralph Gilles, Chrysler Group spokesperson made the announcement during a media teleconference call last week. The decision affects current involvement in both the Sprint Cup Series and Nationwide Series.

Penske Racing currently fields two Dodge Charger cars in the Sprint Cup Series and two Dodge Challenger cars in the Nationwide Series. Penske Racing announced in February that it would end its partnership with Dodge, which started in 2003, at the end of the 2012 season.

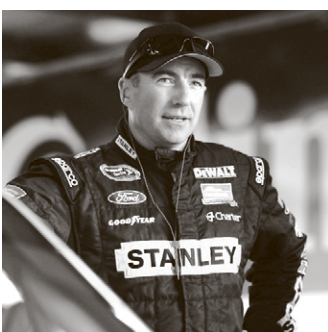

Mifflinburg's Newest Eagle Scouts



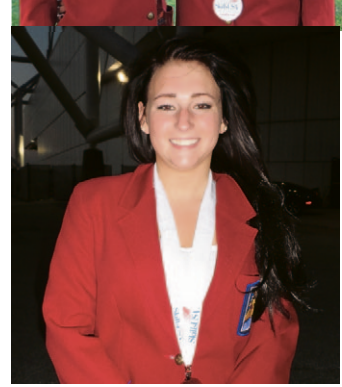

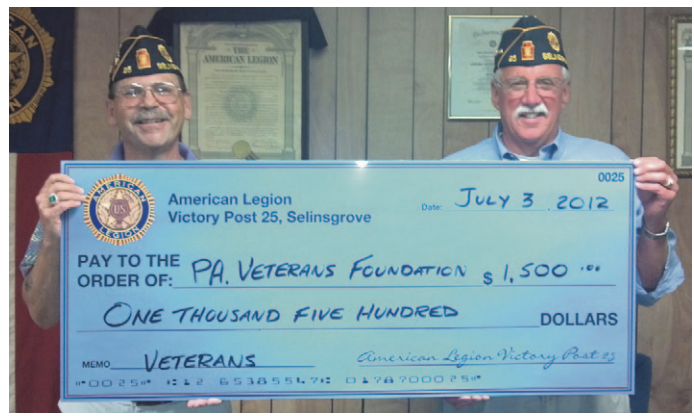
