Arrests Made in Club Burglary

On June 3, 2013, at approximately 8 a.m. Troopers from the Milton State Police ascended upon the wooded area to the rear of the Beagle Club property after information was developed that three individuals involved in this incident were camping in a stolen pull behind camper in the woods on the northeast corner of the property. David Andrew Gockley and Joseph Edward Derr, both 18 and of Lewisburg, were taken into custody and one chainsaw and the shotgun in the case were recovered at the scene. The third suspect, Matthew Hosea Gordon, 20, of Milton, surrendered to police a short time later with the second chainsaw. Also recovered at the scene was a sawed off shot gun with the serial numbers filed off.

All three were charged with three counts of burglary, one count of theft by unlawful taking, receiving stolen property and criminal mischief. They were arraigned before District Judge Mensch and were placed in the Union County Prison in Lieu of \$100,000 bail. Additional charges are pending upon further investigation for the stolen camper and sawed off shotgun.

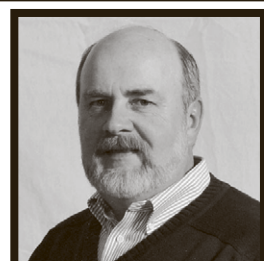

Bake Ovens of Years Gone by (Continued)

To close the oven, a wooden door, with a wooden handle screwed onto it, stood on a two-inch stone door sill projection and was held in place by an angle iron walled in above the door. No iron door was needed because the door was not in place when the fire was in the oven.

The oven was now fired with a slow fire, so as to gradually dry it out, after which it was ready for use.

The roof was double pitch of Pennsylvania redware tile, and extended forward over the front extension, for protection while baking in bad weather. The chimney had a slot left in it on the outside in the rear into which a roofing tile was inserted in order to serve as a damper. This damper was left open during the firing and cleaning of the oven. The damper was closed only during baking so that no heat could escape. The baking took place from the heat of the bricks after all the fire and ashes had been removed.

On bake days, the proper amount of wood in the oven was lighted early enough to heat the oven to baking temperature. After the wood was burned up, the embers and ashes were removed with a "kitch" (wooden scraper) similar to a long handled hoe. It had a hoe-shaped end of about 18 inches wide. This was dipped into a bucket of water before using to prevent burning. With this all the embers and ashes were scraped out and dropped in front of the oven. Water was poured on them to quench them.

The final cleaning was the wiping out of the ashes with a "huddle wish" (swab) made by sewing the legs of a child's worn-out pants together, tying them by a corner to the end of a 10-foot pole, dipping them into a bucket of water and wringing them enough to prevent dripping, but leaving them wet enough to prevent burning. The swab was inserted into the mouth of the oven, and with a circular swinging motion, alternately right handed, then left, the ashes were wiped out of the mouth of the oven. The oven was then ready for the Friday baking.

Dear Editor:

Ever Smell a Burning Tire?

It flies in the face of reason that tire burning would be considered to be environmentally permissible given the chemical composition of the tire feedstock. The smell of a burning tire is nauseating. Without your action, we will soon be smelling tires burning daily with the permission of the PA Department of Environmental Protection (DEP).

As Deputy Secretary for Pollution Prevention and Compliance Assistance at DEP during Governor Ridge's first term, I joined the PADEP Secretary in the exploration of safe tire-burning technologies in the U.S. and Canada as a dual waste management/alternative fuels option to the environmental degradation to groundwater that abandoned tires presents. We found none. As I understand the process being proposed, the En-Tire technology being proposed near Milton is not environmentally groundbreaking. It is merely dressed up as an alternative to other fuels—solar, coal, or natural gas—to reduce the electricity costs to operate the U.S. Gypsum facility.

Where are the studies and evidence proving that tire burning is the environmentally preferred alternative to other sources of electricity? The "science" being proffered by the project's proponents is suspect, at best, when the chemical makeup of tires could not be described by the company's representative at the public meeting held last month.

It is a tragedy for the PA DEP to hide behind permissible regional air quality standards to allow this facility to be constructed and operated. We are entitled to clean air as citizens under the Commonwealth's constitution. Many of us choose to live in this area because of its reasonably healthy air quality. We aren't interested in being subjected to "air quality action day alerts", further degradation of our ecosystem, the degradation of our health, or the so-called daily "nuisance" of unregulated odors from this noxious and unnecessary facility. PADEP does not regulate odors.

This tire burning facility is proposed to be sited in one of the most fertile agricultural valleys on the eastern seaboard. Agriculture and tourism comprise the backbone of our region's economy. Even assuming that this facility could release safe and odorless emissions, simply one malfunction could result in irreparable damage to our crops and acute and chronic health degradation to elderly citizens, children and other "at risk" citizens. This proposed facility is putting our regional economy at great, long-term risk for the promise of a handful of jobs.

Call DEP's Williamsport office today 570 327-3636 to request that it not permit the En-Tire Logistics facility.

LONG POND, Penn.—Jimmie Johnson dominated Sunday's Sprint Cup race at Pocono, leading 128 laps of the 160-lap race. Unless you were a Johnson fan, there was very little to cheer about, because the entire race was less-than-exciting.

Johnson started on the pole and except for the times he pitted for fresh tires and fuel, he was the leader.

"The car was fantastic," said Johnson. "It was awesome on the straightaways. We had a vibration several times that we never quite figured out, but it didn't seem to affect the handling of the car."

The race's sixth caution came on lap 153. Greg Biffle was fifth on the restart. Within two laps he had moved into second, but was unable to gain on Johnson's No. 48.

"I really didn't have anything for Jimmie," said Biffle. "I just wasn't able to catch him. Maybe we can get back on track next week at Michigan. That's a track we've always run well on."

Dale Earnhardt Jr. ran with the leaders for most of the race and finished third.

"It's been a good weekend," he said. "I'm just glad to be able to run this well. Jimmie was good in turns 3 and 4. I just couldn't do anything with him."

The remaining top-10 finishers were: Tony Stewart, Ryan Newman, Kyle Busch, Kurt Busch, Denny Hamlin, Kevin Harvick, and Joey Logano.

Though Joe Gibbs Racing drivers Kyle Busch and Hamlin finished sixth and eighth, respectively, Hamlin said he could feel a reduction in horsepower in his TRD (Toyota Racing Development) engine, after the engines were detuned in favor of reliability in reaction to several recent valve train failures.

"Any horsepower change is going to be a difficult thing to overcome, especially this week and next week (at Michigan), our two horsepower race tracks," Hamlin said. "I wouldn't be opposed to say that other guys probably stepped up coming to this race track, and we took a step back."

"It's kind of a double whammy, but it's something TRD's going to work through."

end of a twelve (12) month period established by resolution. The customer shall be required to pay all applicable charges including customer, capacity, tax and the purchased power adjustment.

The customer-generator operating an electric generating facility shall maintain homeowners, commercial or other insurance providing coverage in the amount of at least one million dollars (\$1,000,000.00) for the liability of the insured against losses or damages arising from the use of the customer's electric generating facility. The Borough shall be named an additional insured. The customer must submit evidence of such insurance to the Borough before interconnection with the Borough system. The Borough's receipt of evidence of liability insurance shall not imply an endorsement of the terms and conditions of the coverage.

Applicable fees shall be set by resolution of the Borough. Customer shall be responsible for costs as set by resolution.

All customer owned generation shall be subject to the Borough of Mifflinburg Technical Requirements for Customer Owned Generation, as amended by resolution of the Borough.

Section 3. Section 8-28, Customer Owned Standby and Portable Generation, is added to Chapter 8, Part 1 of the Borough code and shall read as follows:

SECTION 8-28, CUSTOMER OWNED STANDBY AND PORTABLE GENERATION

Standby generation shall be allowed with the express written authorization and approval of customer equipment by the Borough. Standby generation shall be limited to permanent installations and include open or closed transition automatic switching subject to approval by the Borough.

Portable customer owned generation shall be allowed only without electrical connection between the Borough service, building electrical service and the portable generation. No portable or temporary switching shall be allowed between generator to building wiring, including outlet connections.

All customer owned generation shall be subject to the Borough of Mifflinburg Technical Requirements for Customer Owned Generation, as amended by resolution of the Borough.

In no case shall customer owned portable or standby generation be allowed in any building, garage or enclosure not specifically designed for that purpose. Generator shall be located where exhaust fumes will not enter into enclosed spaces. Generator location shall be consistent with manufacturer recommendations.

Section 4. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Borough that this Ordinance would have been adopted had such unconstitutionality, illegal or invalid sentence, clause, section or part not been included.

Section 5. All ordinances or resolutions, or parts of ordinances or resolutions, which are inconsistent with this Ordinance are hereby repealed to the extent of their inconsistency with the terms of this Ordinance.

Section 6. The requirements of this chapter shall take effect five (5) days after enactment by the Borough.

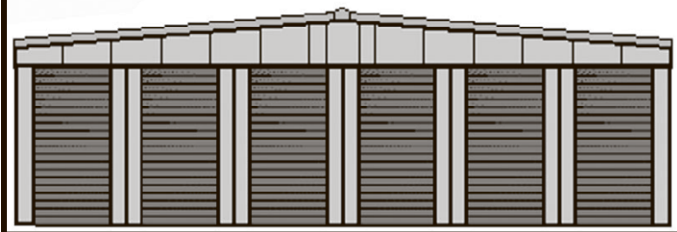
