





## Leonard Wood, Nascar Pioneer

The 2013 NASCAR Hall of Fame Induction Ceremony will be held Fri., Feb. 8, in Charlotte, NC.

Buck Baker, Cotton Owens, Herb Thomas, Rusty Wallace and Leonard Wood are the five inductees

Leonard Wood joins his older brother Glen Wood, the fabled Wood Brothers No. 21 racing team's original driver and owner.

'He's the most dedicated, talented all-around mechanic NASCAR has ever seen," said Wood's nephew, Len, co-owner of the current Wood Brothers team. "He fit the term 'chief mechanic.' He could do anything with the car."

In 990 races as a crew chief for the No. 21 Ford and Mercury cars, he won 96 times. His cars also won 117 poles. After Glen stepped out of the cockpit, Leonard worked with some of the sport's greatest drivers including David Pearson, Cale Yarborough, A.J. Foyt, Dan Gurney and Parnelli Jones.

In a recent interview, Dale Jarrett, former Wood Brothers driver and current ESPN analyst, called Wood, "One of the smartest people to come through this sport, especially early on. They had so many ideas from the pit crew to other things that people don't even know about, under the hood so to speak, that Leonard Wood was kind of in charge of making it happen."

He sat by as his father, Walter, tore down the engine from the team's first race car. Later, when the time had come to freshen it, Leonard - then in high school – volunteered for the task, which was done to perfection.

"It kind of blows your mind that somebody that young could do that," said Glen Wood, noting that in the early days the chief mechanic was exactly that - a jack of all trades from fabricator to shock and spring specialist to engine builder. "He just learned by himself and he did it really well - anything he did. I could always depend on him. If the car wasn't working right, I'd go off somewhere and sit while he worked on it. When I came back, it would be in winning shape."

Pit stops weren't a big part of NASCAR's early years when many races were held on half-mile dirt tracks at distances of 200 and 250 laps. But the advent of longer races on superspeedways – Darlington Raceway followed by Daytona, Charlotte and Atlanta – significantly broadened the sport's boundaries. With multiple stops necessary to add fuel, change tires and make adjustments, the Woods quickly recognized that less time spent on pit road meant fewer rivals to pass on the race track.

The model Leonard Wood established was copied by all other teams. In the early years, floor jacks weighing 70 to 80 pounds were used to lift the race cars. They also required a strong man to pump the handle - up to 10 pumps for tire clearance. Wood took apart the jack, inserted larger pistons and - presto - his driver could get the car off the asphalt by pumping two or three times.

He ported and polished the mechanisms in the team's air guns, allowing lug nuts to be removed and replaced more quickly. Finally, Wood modified the inside of the team's dump cans so that gasoline flowed faster.

Hired by the Ford Motor Co. to pit Jim Clark's Lotus at the Indianapolis 500, the Woods stunned the racing world as Clark spent 41.9 seconds on pit road en route to Victory Lane - thanks to "tweaking" of the gravity-fed refueling rig.

"We turned that thing on and it put in 58 gallons in 15 seconds," said Wood. It just sucked the fuel out of there. We knew we were going to be under 20 seconds on the pit stops.

We got the most publicity in the least amount of time we ever got in our lives," he added. "We hit a home run for sure."

Len Wood continues to marvel at his uncle's fabrication skills. The team is completing a replica of the Ford Galaxie in which Tiny Lund won the 1963 Daytona 500. The car will be on display at the NASCAR Hall of Fame during NASCAR Acceleration Weekend, along with a 1/8-scale, gasoline-powered car fashioned from scraps of aluminum and the soles of shoes that Wood built decades ago. He tethered it to a pole, a kind of forerunner to today's radio controlled cars.

'His fabrication skills: it's all in his head: no blueprints." said the younger Wood, recalling that they were going to use aluminum pieces to fasten the windshield to the Galaxie. "Leonard said, 'No, I think we used steel back then. I'll make steel ones.

"If you can describe it, he can fix it or make it."

The NASCAR HOF Induction Ceremony will be broadcast live on Friday, Oct. 8 at 7:30 p.m. ET on SPEED.

EDWARDS AND FENNIG MUST PICK UP THE PACE

Carl Edwards needs to find some answers that will allow him to pick up the pace next season. In hopes of turning the No. 99 team around, veteran Jimmy Fennig has been assigned the task.

Although Edwards doesn't wish to dwell on last season, he acknowledges that his team didn't evolve as quickly as the Nos. 16 and 17 of teammates Greg Biffle and Matt Kenseth. In a world where simulation plays an important element in setting up the cars for the racetrack, his teammates seem to acclimate quicker to the necessary adjustments throughout the weekend which made the cars faster. Edwards knows he must get up to speed again.

For now, he's adopted a back-to-basics approach.

'We have to qualify well," he said. "We have to have cars that race fast. We have to have a fast pit crew. Jimmy and I have to work to-

gether. All of the basic things, we have to do right. If you look at the way that Matt (Kenseth) ran with Jimmy last year, it was head and shoulders better than we ran than I ran – in that 99.

Edwards said his new crew chief has surprised him. Despite the veteran's quiet demeanor – which Edwards acknowledges he might



have mistaken for "not being engaged," the driver firmly believes that Fennig's rooted deeply in what's going on in the garage.

"To me, from the outside, it appears to me that Jimmy has a very good perspective," Edwards continued. "We're going to work hard we're going to do a good job and we're going to reap the benefits. That's not something that he yells at people about – at least he hasn't yelled at me about anything. It's just expected. That's the feeling I get from him. That he holds everybody at a high standard. And that's good. When we're at the racetrack, so far in the little time we spent there, it's not a joke. It's not a social event. We're there to do a job.

"The more I get to know him the more excited I am because I see how good he is with the people and how engaged he is with the cars. "I feel comfortable that he can help the 99 team find that winning

The Union / Snyder Transportation Alliance (USTA) is pleased to announce the new Vanpool Service is on the road with three (3) vans and (2) two more are on the way. With the Pennsylvania Farm Show behind us, I have to give my sister Shawna a shout out for raising the Reserve Champion Middle Weight Crossbred Market Hog at the show. Although she didn't take overall Reserve, she did a phenomenal job with her project and I am so proud of her. Also, my "sister" dairy princess Michala Kuhlman from Rome, PA was awarded her Keystone Degree and the Pennsylvania FFA Star Farmer at our winter convention. There is only 1 star farmer a year per state so my heart filled with pride for her as well. Afterwards I found out her mother Connie had also been a Star Farmer in Vermont. I wonder what the probability of that happening is?

This winter hasn't been as kind as last year was and with all the snow days we've had, I'm afraid we might be making days up during our summer vacation. The days off have been fun though and my brother, sister and I have enjoyed spending that time together. During one of those days off, when it was just too miserable to be outside enjoying the hill in front of our house on the sled, I was watching television when a commercial about milk came on with the beautiful Salma Hayek. It made me think...Why do I drink three or more servings of milk a day? Was it because of the marketing with celebrities or happy cows from California? No, even though the cow commercials are pretty funny. Was it because of my dairy farming heritage? Well, I must admit, that has something to do with it but it wasn't the reason. About that time, Mom got up and went to the kitchen. With that familiar sound of the refrigerator door gently shutting and my mom sitting back down in her chair with a glass of milk, it dawned on me. SHE is the reason I drink milk and eat dairy products. My whole life, all 17 years of it, my mother has been my role model and taught me what I need to know. From washing my hair to teaching me responsibility and getting homework done on time to making healthy choices, Mom has shown me the way.

Studies show that children will follow their parents lead. And with the decline in children drinking milk and getting the calcium they need to grow and stay strong, it's important for parents to be good role models. Some parents are concerned that giving their children flavored milk such as chocolate milk isn't good for them and is high is sugar and calories. Chocolate milk or any flavored milk has the same 9 essential nutrients as white milk. And chocolate milk has half the sugar that soda or fruit juices have. Comparing soda and juices to milk may also have your family reaching for milk more often. An 8 oz. serving of fat free milk fortified with vitamin D is 80 calories and provides us with the nine essential nutrients our bodies need to grow. The same 8 oz. of soda is 100 calories and will only give us 3% of the phosphorus we need compared to 20% with milk. Fruit juices have about 120 calories and about 2% of the potassium we need where milk gives us 11%.

So in the end I find myself asking, "Am I turning into my mother?" I can only hope so!

During the month of January, we celebrate my mother, Grandmother, Uncle John, Aunt Billie Jean and Cousin Megan's birthdays (all from the 23rd to the 26th). One of our favorite cakes is Chocolate Cake with Peanut Butter frosting. While you can make whatever chocolate cake you want, this is the Peanut Butter frosting you've been waiting your entire life to try. And my great grandmother had the recipe all this time!

### Peanut Butter Icing

1 Cup MILK 2 TBSP. Corn Starch

<sup>2</sup> Cup BUTTER, softened

<sup>1</sup>/<sub>2</sub> Cup Crisco

1 tsp. Vanilla

pinch of salt

<sup>1</sup>/<sub>2</sub> Cup granulated sugar

<sup>4</sup> Cup and 2 TBSP. Smooth Peanut Butter

In a saucepan over medium low heat, heat milk and corn starch until it bubbles and becomes thick. Stir constantly with a whip. Let cool (you can put it in the refrigerator to help cool it quicker.)

Scalloped Potato and Ham Casserole

4 Cups thinly sliced Potatoes

Paprika

- 3 Cups flour
- 1 stick BUTTER
- Salt and Pepper to taste 1 jar Hot Mustard
- 1 <sup>1</sup>/<sub>2</sub> Cups MILK
- 1 lb. Ham

Arrange potatoes on the bottom of a casserole. Put onions on top. Sprinkle with flour, salt, pepper and paprika. Dot with 2 table-spoons of butter. Add ham and 1 teaspoon of hot mustard. Continue to add layers as above. Scald 1  $\frac{1}{2}$  cups of milk and pour over the layers. Top with more ham and sprinkle with paprika. Bake at 350° F for 2 hours.

USTA's vanpool service is one of only five currently operating in the Commonwealth.

According to PaCommutes, a PennDot sponsored website, fuel costs driving 20 days per month, 120 miles per day, are \$384. In addition to fuel savings, commuters save "wear and tear" on their vehicles. Commuters especially appreciate relaxing, napping or reading as well as not driving their personal vehicles to work.

Vanpool participants, including the driver, are responsible for deciding who will drive and where they are picked up and dropped off. Drivers assume additional responsibilities for collecting the fares, keeping a travel log, ensuring the vehicle is maintained, and filing reports. The fare paid by the participants covers fuel, insurance, and operation costs. The program also guarantees a ride home in case of an emergency while a commuter is at work.

As one commuter summarized, "not having the stress of a long, lonely daily commute has been a life changer. My eleven year old car can stay on the road until my retirement in a few years."

USTA currently has openings on two vans, one to State College and one to Harrisburg. The monthly fare is \$160 to State College and \$170 to Harrisburg. With two new vans arriving in mid March, new vanpools are now forming. Commuters to Williamsport are looking for riders. To form a new vanpool, several commuters should be headed to a similar destination at similar times. Often folks who work together explore a new vanpool. ## Middleburg Reliance Hose Company and Evangelical Celebrate One Year of Collaborating Services

Middleburg Reliance Hose Company recently celebrated a year of sharing Paramedic and EMT services with Evangelical Community Hospital.

The combined services came when the two partners realized there was an opportunity to improve access to services for community members, lower charges provided to patients needing Pre-Hospital services, offset staffing challenges for the local fire company, and make better use of resources for both the fire company and the Hospital.

Starting in November 2011, Evangelical began placing a paid paramedic and EMT on initial 911 calls. The decision provided consistent staffing on rotation to the ambulance and allowed the elimination of the costs associated with a second response vehicle. Under the new structure, the EMT and Paramedic serve on location at the fire company; when an emergency call comes in they respond through the coordination of services under one roof.

The transition has been smooth and positive with a huge impact in efficient service and lower cost for patients. The occasional confusion of seeing personnel with Evangelical apparel or name tags is easily explained with patients knowing they are receiving the quality emergency care they expect when the ambulance arrives on scene.

Jared Mizer, Ambulance Captain of Reliance Hose Company, said, "Reliance Hose Company has always made serving the community its top priority. The partnership with Evangelical has proven to be a perfect fit for that mission, with our com-munity members having available to them rapid-response Advanced Life Support coverage 24 hours a day, 7 days a week."

The year of partnership has included a total of 1,045 ambu-lance calls comprised of 737 medical calls, 268 trauma calls, and 40 stand-by situations such as a fire or accident where there is a chance for ambulance need.

Nicholas Klose, Director of Pre-Hospital Services for Evangelical, said, "We constantly look for the most efficient ways to get patients the emergency care they need while keeping in mind cost and resources involved. This partnership with Middleburg is similar to one we've had with Mifflinburg, Milton and Watsontown. In total, Evangelical has 88 employees in Pre-Hospital services serving our communities.'

Klose continued, "Reliance Hose Company has a long history of providing excellent emergency services to Middleburg service area and now through this partnership they support rural areas like Richfield, Beaver Springs, Troxelville, and Kreamer. By building on that experience and working together we are assuring accessible ambulance services continue for a long-time to come.'

annual event as


