

### Cable TV Contract Negotiations — An Opportunity For The Region's Municipalities One of the lesser known responsibilities of municipal officials

is contract negotiations for cable television franchises. SEDA-

COG has scheduled a series of meetings in June to educate elected and non-elected officials about their rights and potential benefits related to the negotiating process. Meetings are scheduled in Mifflintown, Sunbury, and Montoursville. Under federal law, municipalities essentially serve as their cable company's "landlord." The companies place cable lines

and other equipment in the public rights-of-way. The municipalities control those rights-of-way as a public trust, and they are entitled to benefits in return for the cable companies' use of

Depending on the cable company, the benefits from franchise negotiations include: • Increased franchise fee revenue by applying the franchise fee

- to all revenue sources
- A cash franchise grant
- Free internet service to the Municipal Building
- Enforceable customer service standards
- A government access channel

Strong right-of-way protections

In many cases, municipal officials simply accept what the cable company offers when, in actuality, they can negotiate for The potential for increased benefits is even greater if munici-

palities band together to negotiate franchise agreements. Group negotiations give municipalities more bargaining leverage with the cable companies. The process for working together and the benefits to the municipalities will be fully discussed at the cable TV meetings in June.

### PA Dutch Life & Culture

Recently I found an interesting article that I'll share with you. I'm amazed at the wonderful products the women of times past baked without the advantages of the modern conveniences we

#### THE BAKE OVEN

The change-over to baking in a cook stove was slow in many areas. While people were adapting to the "new" gadget in one area early, bake ovens were still being constructed in others. In one area, one farmer bought a new cookstove and bricked up the hearth in 1845, while a neighbor built a new bake oven in 1869.

The following is an interesting account of activities and everyday happenings in and around the boyhood home of John Z. Harner of Berks County.

BOCK DAG---Friday, (bake day) was a gilt-edged day at the Harner's and the excitement of it, the aroma and the "tasting" still linger in John's nostrils, mind and heart. As he tells it, one is fascinated by the idea that the delicious pies and cakes he remembers, were baked in an outdoor oven built in the early

When John was about ten, Emmanuel Schwenk, a stone mason, rebuilt the brick oven part of the Harner bakery area, which gave him a splendid opportunity to observe all the details. He even remembers going with his father to the upper end of Jim High's mill dam near the Earlville Covered Bridge for a load of sand with which to do the job.

This oven was egg-shaped, about six feet deep and five feet wide inside, with an eight-inch vertical wall all around, on which the arch started all around the oven. There was no opening to the space under the roof except from the front. In this front opening over the oven mouth, Mother Harner stored her oven tools, the handles of which always extended forward, overhead, for easy grasping, always out of the way and protected while not in use.

Do you remember when certain household tasks were done on certain days of the week? Sunday-church day; Monday- wash day: Tuesday-ironing day; what were Wednesday and Thursday? Cleaning?? Friday (and other days)-baking days: Saturday-shopping day... How were things done at your house?

When I was at home, she always used a wringer washer, with a "rinse tub," then back through the wringer and then carried the heavy wet clothes out to hang on the clothes to dry... even in the cold Pennsylvania winters. Do I recall that if they froze, it helped to 'whiten" them?

After marriage and children, I never used a wringer washer, but I did have to hang the wash "out to dry" for many years. I didn't have a dryer until after our youngest was three or four years old. Fortunately that was in California, so the weather was clear and fairly warm, most of the time. Do tell me about your memories of "Wash Day" and the other







# "Happy" Harvick Takes Coca Cola 600 By Gerald Hodges/the Racing Reporter

CONCORD, N. C.-Kevin Harvick won Sunday's Sprint Cup Coca Cola came Saturday at Charlotte, as he 600, the season's longest race ahead of Kasey Kahne and Kurt Busch. When a late race caution came out, Harvick, who was running fourth pitted for four fresh tires, while Kahne, who was leading, elected to stay on

When racing resumed on lap 389 of the 400-lap race, the leaders were Kahne, Harvick, Denny Hamlin, and Ryan Newman.

Harvick immediately passed Kahne for the lead, and was never threatened.

"We made a good strategy call there near the end," said Harvick. "We had fresher tires and were able to get by him (Kahne). That's all we needed." For Kahne, who finished second, it was a decision that probably cost him

the race.
"We were in a tough spot," said Kahne. "We had raced all day and thought we had enough tires left. We had a good car, but just didn't get it done." Third place finisher Kurt Busch led some laps and ran with the leaders,

but the battery on his No. 78 failed and he had to pit for his team to install a new battery "I was shell-shocked by that," said Kurt. "We had a good car and the bat-

tery just died in it. We battled back, but you've got to be perfect to win here.' A broken television cable that fell across the race track caused NASCAR officials to red-flag Sunday's race for nearly 30 minutes after lap 126. The cars of four drivers, including race leader Kyle Busch, suffered dam-

age after running over the wire. It was part of the rigging used for the overhead camera that is moved up and down along the frontstretch.

After hitting the debris coming out of Turn 4, Busch radioed his crew to say

'Something fell apart. And of course it fell apart on us."

Officials red-flagged the race before bringing the field to pit road under yellow. The red flag was displayed once again and teams were told they could repair any damage thought to be caused by the debris, and given a 15 minute window in which to do so. All teams were able to make repairs to their cars

Track officials announced that 10 fans were hurt. According to a statement from track officials, seven fans were treated and released for "minor cuts" and scrapes" at the speedway's on-site care centers. Three fans were taken to area hospitals for observation.

A second red flag came out on lap 225 after a big wreck took out the cars driven by Jeff Gordon, Mark Martin, Aric Almirola, Ricky Stenhouse, and Bobby Labonte.

Kyle Busch's team was able to repair damage to his car from the television cable, but on lap 254, his engine expired, and he did not finish the race.

On 5/1/13 Lynn Pierson, from the Office of Civic Engagement for Bucknell University was the Lewisburg Sunrise Rotary Club's guest speaker for their morning meeting. Lynn is the Assistant Director for Community Service. She talked to them about the Community Harvest Meal Program and their one fundraiser which is "Empty Bowls". They have donations from anyone who can make pottery, including students from Bucknell to make the pottery bowls. They also, try to get local restaurants, food markets and local persons to donate the soup for this fundraiser. For the price of \$10 you get a handmade bowl with soup and bread. They need about 12,000 year to fund the year round free meal, Community Harvest Meal Program.
