Over 200 million boxes of Girl Scout Cookies are sold each year which results in approximately \$700 million in sales each year. This year, cookies will sell for \$5.00 per box with the exception of the gluten-free flavor which will be \$6.00 per box.

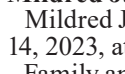

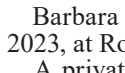

Song of the Susquehanna by Herbert E. Stover a Thrilling Novel

Original May 12, 1949

Herbert E. Stover's historical novel, Song of the Susquehanna, has led us here and there in Pennsylvania in an effort to locate places, names and mountain ranges which he mentions and which should be familiar to all of us. But are they?

If you read nothing else in Song of the Susquehanna, than Mr. Stover's description of General John Armstrong's attack on the Indian village of Kittanning, you would have indeed gained much. Song of the Susquehanna has many thrilling instances in its pages, but to our way of thinking, Mr. Stover did a superb job at Kittanning.

The Indian village was located in what is now Armstrong county, named in honor of colonel John Armstrong. He attacked Kittanning just before daylight on the morning of September 9, 1756, with five of the eight companies of frontiersmen under his command. The other three had not yet crossed the last range of mountains. Some of the Indians were asleep in the very cornfield in front of the village in which Armstrong's men awaited the dawn. It was a surprise attack, and practically annihilated the village.

Mr. Stover's hero, Peter Grove, naturally lighted the fuse that set off the large stores of powder, munition and other supplies, stored there by the French. Both Colonel Armstrong and Captain Hugh Mercer were wounded in the fight. Mr. Stover takes special pride in playing up Armstrong, and apparently equal delight in playing down Mercer. That is his prerogative.

However, we deplore the fact that Mercer, our first pharmacist, should fare so badly at his hands. We remember visiting the site of his little pharmacy in Fredericksburg, Virginia. Hugh Mercer was a Scotchman, a graduate of medicine at the University of Aberdeen. He fought to put "Bonnie Prince Charlie" on the throne of James II, after the crushing defeat of the Stuart forces at Culloden. Mercer then came to America, where he met George Washington in Braddock's tragic campaign. Mercer was severely wounded, and Washington prevailed upon him to settle in Fredricksburg, which he did and where he opened our first apothecary shop. His home near Fredericksburg was called Pine Grove Farm.

The Kittochtinny, or Kittatinny, or Blue Mountains, have an average height of from 700 to 1,200 feet above the streams that flow at their base. They extend from the Delaware Water Gap to near Fort Loudon.

Kittanning is now the countyseat of Armstrong county, and is located on the site of the Indian village of that name. From that place an old Indian trail known as "The Kittanning Path" led across the mountains to Standing Stone (Huntingdon). It was that trail that Armstrong's men followed on their expedition against Kittanning.

The name Kittanning is Indian, and is a corruption from Kit-hannic, "town on the great river"—the Allegheny.

Shade Mountain, so familiar to us all in Snyder county, lies beyond the Tuscaroras, in both Union and Snyder counties. The mountain folds sharply toward the Juniata under the name Black Log Mountain. This is one of the beauty spots in this Commonwealth. Many a fall picnic we have enjoyed at that point, where the maple trees stand like flames of fire against the dark green of the hemlocks and pines.

Sliding Hill Mountain, over which Indians

and white men fought during the French and Indian Wars, today has a tunnel bored thru it, and forms part of the great Pennsylvania Turnpike. Sliding Hill extends from the Maryland line northward thru Bedford and Huntingdon counties to Jack's Mountain, below Standing Stone (Huntingdon).

Jack's Mountain rises new New Berlin. In fact it forms the most beautiful backdrop for that quaint village. Crossing Penn's Creek into New Berlin, Jack's Mountain rises formidably to the west. Approaching New Berlin from Dry Valley, the mountain seems to hover over New Berlin. However, as you drive on the highway westward from New Berlin, Jack's Mountain just is not there. The mountain lies to the southwest, across Penn's Creek, but the illusion of its disappearance is none the less surprising. It has a southwest course across the Juniata below Huntingdon to nearly Bedford county.

Mr. Stover of course mentions the most famous of all local Indian villages in his narrative, Shamokin, now Sunbury. The Delawares called the village Schachamekhon, which signified "eel stream." The late Dr. George Donahoo said the name was derived from "Shumokenk, where horns are beautiful." Be that as it may there lived Shikellamy, head of the Six Nations from 1728 to 1749.

Another location that enters into Mr. Stover's book is Harris Ferry (Harrisburg). John Harris was a Yorkshireman, who came to America with 16 guineas in his pocket. He was licensed in 1705 as an Indian trader by the provincial governmental "authorities, and allowed to seat himself on the Susquehanna"—rather damp reposing. In 1725 the Penns granted him five hundred acres of land, on which a small settlement soon grew. This was the outpost of civilization. There the men crossed the Susquehanna into the wilderness and on to the Allegheny Mountains, and from there they traveled northward thru the valley of the Susquehanna to the great unknown and on into Canada. John Harris died in 1749. His son, John Harris, Jr., then came into possession of 700 acres of land, a ferry and one of the largest trading posts in the colony.

Mr. Stover tells how John Harris and his Paxtang Guards came up to Penn's Creek following the massacres of October 16, 1755.

There is something very familiar in the way Mr. Stover relates one episode. He writes: "They killed a man and his wife, and carried off a little girl. Four or five days they'll be crossing the Wyalusing Flats. We're to stop them," relates Peter Grove and his companions. That story rings mighty true to the Stock Massacre, which took place in 1781 on Middle Creek, just across that stream from the present village of Kreamer.

Three Indian fighters pursued the Indians. Their names were Michael Grove, John Stahl and Peter Pence. Mr. Stover's hero, Peter Grove might have been Michael Grove or Peter Pence, the character suits either man. As you read the story of the three white Indian fighters pursuing the Indians and their captive white child; how they themselves were captured by the Indians; how they regained their freedom, and revenged the death of the white people, you will be reading the true story of the Stock Massacre.

There are many instances, places and facts recognizable to anyone familiar with the history of Pennsylvania during those pre-revolutionary days in Mr. Stover's Song of the Susquehanna. It is a thrilling book and will take its place along with the historic works of such men as Hervey Allen and Neil H. Swanson. Prepared by Esther Klingler



SAHS Alumni Association Introduces Sports Hall of Fame

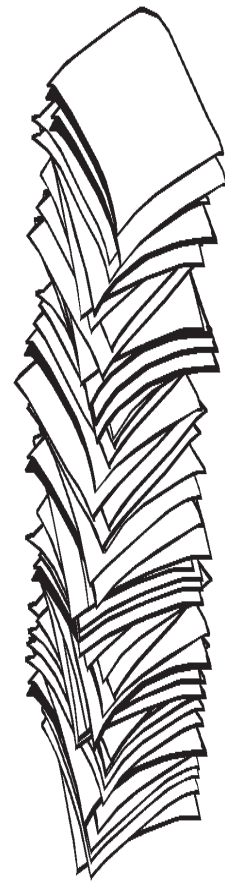

Union County has always been a great place to work, raise a family and enjoy the outdoors. I will strive every day to ensure that continues."

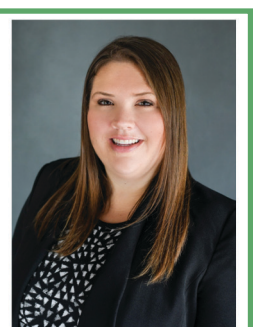

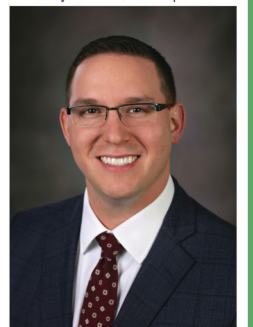

PennDOT Reminds High School Students of 'Innovations Challenge' Deadline

The Pennsylvania Department of Transportation (PennDOT) reminds high school students of the upcoming deadline for the sixth annual PennDOT Innovations Challenge, which encourages students to use their problem-solving, creative and strategic-thinking abilities to solve real-world transportation challenges in a competition among their peers. The Innovations Challenge is open to all students in grades 9-12, regardless of their school's learning model.

For this year's challenge, students are asked to develop ideas to help address the shortage of commercial truck parking along major interstate corridors in Pennsylvania. Trucks parking on highway shoulders and ramps is common during overnight hours and presents a significant safety issue.

The challenge asks students to select one of Pennsylvania's interstate corridors where truck parking is a known issue and develop an innovative approach to increase commercial truck parking availability in that area and offset costs incurred for construction. The solution must consider local ordinances and zoning laws for the area selected, commercial entity interaction in land development, community impact, restroom facilities, and space requirements for commercial trucks that are generally 70-80 feet long.

Regional Innovations Challenge winners will be selected and invited to present their solutions to the PennDOT Secretary and a panel of judges, who will determine the statewide winner. For this year's challenge, the Transportation Policy and Education Foundation, an educational arm of the Associated Pennsylvania Constructors (APC), has donated \$2,500 and the American Council of Engineering Companies of Pennsylvania (ACEC/PA) has donated \$1,500 for a combined total award of \$4,000 to the statewide winning team.

Seedling Sale Underway

While it might be winter, landowners can begin making plans to help wildlife this spring – and beyond – by planting tree and shrub seedlings offered by the Pennsylvania Game Commission's Howard Nursery.

The 2023 seedling order form is available online, and sales are underway.

The Howard Nursery grows tree and shrub seedlings for use on state game lands, by participating Hunter Access cooperators, in the Seedlings for Schools program and by the Game Commission's conservation partners.

Any remaining surplus is available to Pennsylvania residents to purchase for wildlife food and cover, watershed protection, soil-erosion control, and for reclamation of disturbed areas, such as surface mine sites and utility rights-of-way.

The selection of seedlings changes from year to year due to available seed, seedling germination, and growing conditions.

"It takes three years to grow conifers and sometimes two years to grow hardwood trees from seed," explained Brian Stone, manager at Howard Nursery. "Our surplus of conifers and oaks is up even more from last year; and this year we have a very limited supply of persimmon, domestic apple and wild plum."

Seedlings are sold in units of 25. The 2023 order form contains a selection of evergreens, deciduous trees and shrubs, most of which are native to Pennsylvania and collected from Pennsylvania sources. The order form lists seedling descriptions, site preferences and benefits.

Some of the more popular species available this year are white pine, Norway spruce white cedar, red oak, sawtooth oak, black walnut and crabapple.

All seedlings offered for sale can be purchased at a discounted price. Orders of 12 or more total units (300 seedlings) qualify for applicable discounted pricing. With the discount, prices are as low as \$11.25 per unit. Regular price ranges from \$12.50 to \$16.25 depending upon the seedling species.

Those who are interested in placing an order should call the Howard Nursery at 814-355-4434. Orders can also be placed by FAX at 814-355-8094. Hours of operation are Monday through Friday from 7 a.m. to 3:30 p.m. The nursery is closed on federal holidays.

PennDOT Reminds Motorists Seat Belts Save Lives

The Pennsylvania Department of Transportation (PennDOT) District 3 reminds motorists, including passengers, to buckle up for safety. Wearing your seat belt is your best defense against injury or death in the event of a crash. A seat belt increases your chances of surviving a crash by up to 60%. Despite this fact, far too many motorists still refuse to buckle up.

In 2021, there were 12,672 crashes in Pennsylvania where at least one person was not wearing a seat belt, resulting in 378 fatalities and 1,064 suspected serious injuries. Locally in PennDOT District 3, which includes Tioga, Bradford, Lycoming, Sullivan, Union, Snyder, Northumberland, Montour and Columbia Counties, there were 505 crashes where at least one person was not wearing a seat belt, resulting in 27 fatalities and 68 suspected serious injuries in that same year.

In Pennsylvania, drivers and passengers 18 years and older are required to wear a seat belt when behind the wheel or in the front passenger seat. If you are a driver 18 or older and police pull you over for another violation, you will receive a second ticket if you or your front-seat passengers are not wearing seat belts.

Pennsylvania's Primary Seat Belt Law requires drivers and passengers under 18 years of age to buckle up anywhere in the vehicle. Additionally, drivers under 18 may not operate a vehicle where the number of passengers exceed the number of available seat belts.

Under Pennsylvania's Primary Child Passenger Safety Law, children under the age of 4 must be properly restrained in an approved child safety seat anywhere in the vehicle. Additionally, children under the age of 2 must be secured in a rear-facing car seat until they meet the maximum weight or height requirements set by the manufacturer of the seat. Children must ride in an appropriate booster seat until their eighth birthday.


Research shows that child safety seats, when properly installed, reduce the risk of fatal injury by 71% for infants and 54% for toddlers. Children under the age of 13 should always ride in the back seat for safety.

Although air bags are now prevalent for most vehicles, they must be used with a seat belt for maximum effectiveness. Air bag deployment without seat belts can be dangerous.

Remember, even on short trips, it is important to buckle up. Seat belts protect you and your loved ones in the event of a crash.
