## 2012 LARA Sprint Triathlon



Elizabeth Reitz of Lewisburg is making a habit of winning the LARA Sprint Triathlon.

On Saturday, she won her fourth straight women's title in the race's seven-year history.

Meanwhile, Luke Watson of State College, making his first appearance in the swim-bike-run event that drew more than 300 entrants, won the men's race. Watson, a former professional runner, recently finished first in the Steamtown Marathon in the Scranton area and earned a spot as a 2012 U.S. Olympic Trial qualifier.

While the performances of the overall finishers were impressive, it was not the most important aspect of the triathlon, said Tara Michaels, race creator and director.

"It is certainly exciting to see so many athletes come back year after year," she said. "Not just the competitive ones, but also those who are simply looking to challenge themselves or just try a different type of event."

Michaels also said that the LARA event has served as a springboard for many novices to take on more challenging

events.

"The Tri is about our community," she added. "It would not be possible without the support of the loyal volunteers and public safety organizations such as the Buffalo Valley Regional Police Department."

"Much of the race feedback I receive focuses on the great volunteer support we receive each year. Many of our individuals have been with us since the race originated in 2005."

The adult triathlon was preceded by a Kid's Triathlon held on Friday evening. Over 140 children from age 7-13 tried their hand at the sport.

Participants came from all over the state as well as from DE, MD, NH, NJ, NY, and VA, many of whom stayed overnight at local establishments.

## Fatal Accident Closes Route 15 for Several Hours

On Sunday, August 19, 2012, Route 15 was closed for approximately six hours as police determined the cause of a fatal accident which claimed the life of an elderly Milton woman. At approximately 12:55 p.m. Hazel E. Hock, 83, of Milton, who was driving a 1998 Mercury Mystique attempted to make a left turn from Col. John Kelly Road on to Route 15 North. As Hock attempted to make the turn, she pulled into the path of a 1993 Honda Civic CP driven by a 17 year old male, of Milton, who was traveling south on Route 15. The Honda struck Hock's vehicle in the front left driver's door, causing it to spin

approximately 180 degrees, coming to a rest in the right southbound lane of travel, facing southwest. The Honda became disabled and stopped at the primary impact location. Hock was pronounced dead at the scene by the Union County Coroner's Office. The 17 year old driver sustained unknown injuries and was taken to Geisinger Medical Center for treatment. Both vehicles were towed from the scene. Assisting on the scene were the William Cameron Fire Department and EMS, Milton EMS, Evangelical Community Hospital Paramedics, White Deer Fire Police, PennDOT, and Catherman's Towing.

## Safely Share the Road with School Buses

Since school is back in session, here are a few reminders for drivers that will help everyone have a safe school year.

According to the American School Bus Council, school buses are designed to be safer than passenger vehicles in avoiding crashes and preventing injury. Today, as compared to years ago, school buses are built with safety in mind. In fact, a study by the U.S. Department of Transportation states that children are safer riding the bus to and from school than being driven in a car by an adult. When you are sharing the road with school buses, follow these tips.

**Yellow and Red Flashing Lights** – School buses have yellow lights to warn drivers they will be making a stop and red flashing lights and an extendable stop sign to tell drivers to stop. Yellow does not mean go faster, it means slow down. Be aware of your surroundings and always come to a complete stop. Do not continue driving until the lights have turned off and the sign is pulled in.

**Passing a School Bus** – It is illegal to pass a school bus on the right side of the road because you cannot be aware of where the bus needs to stop to load or unload. Always wait for the bus to move to the right lane or stay a safe distance behind it. Additionally, it is illegal in all 50 states to pass a school bus that is stopped to load or unload children. It is vital that you stop your vehicle at least 10 feet away from the school bus to allow for riders to enter and

exit safely.

**Railroad Crossings** – In most states it is required that school buses stop at all railway crossings. Be alert when a crossing is ahead and a school bus nearby so that you can stop as well.

**Divided Highways** – You must always stop for flashing red lights; however, most states do not require drivers to stop when on the opposite side of a divided highway. Use extreme caution if you are in this situation as passengers may be trying to cross in that area, especially if there is a crosswalk.

**Buses Need Turning Space** – Just like trucks, buses have a wide turning radius. Remember to provide them with ample turning space so they can maneuver easily on the road.

**Watch for Children Waiting for the Bus** – As the driver, you are responsible for keeping an eye on the road and on children waiting for the bus. Come to a complete stop at all stop lights and stop signs, drive slowly near bus stops and watch for children crossing the road.

**Slow Down** – Use caution if you are driving in residential areas and school zones. Fines for speeding in an area can be hefty.

**Allow for Extra Time During Your Commute** – School bus drivers have to follow the same speed limit rules as every other driver; however, they make frequent stops which can delay traffic. Know the bus routes in your community and allow ample travel time when school is in session.

## Police Warn Residents About a Utility Scam

A utility scam claiming that President Obama is providing funds to help consumers pay their utility bills is sweeping the nation. Imposters contact power company customers, through telephone calls, mail, fliers, email, text messages, social media, and in person. After the victim is contacted, the imposter convinces them to relay personal information by claiming that the victim is eligible to receive cash benefits from a government program. After the victim provides their social security number, credit card number, and bank information, the victim is given a bank account and routing number to use when paying utility bills. The victim is told the account is set-up through a federal assistance program that will provide up to \$1,000 toward the victim's utility bills.

The bank account and routing numbers provided by the con-artist are not real. Victims of this scam assume their utility bills are being paid by the fictitious government bank account. While there is no direct or immediate financial loss to the victim, the victims are now susceptible to identity theft because they provided their personal information to the imposter. Additionally, their utility payment is now overdue and they could be assessed late fees or penalties for non-payment.

### Conclusions And Recommendations

According to the Better Business Bureau, thousands of people throughout the nation, including Pennsylvania, have become victims of this scam with the majority being elderly. Many utility companies are publishing information regarding the fraudulent program on their websites in an attempt to educate their consumers. This information should be shared with family and friends to help prevent them from becoming victims.

Do not give personal or sensitive information, such as social security numbers,

credit card numbers, or banking information, to anyone unless you initiated the contact and you are confident of their legitimacy.

Do not allow anyone into your home unless they have official identification. Examine the identification card closely and contact the company he/she claims to represent if you think the circumstances are suspicious.

Do not open your door to anyone from the utility company unless you have a scheduled appointment or have reported a problem. Utility companies only send their employees out for appointments or problems; they will not just show up. If you think you have been a victim of this scam:

- Contact your bank immediately.
- Contact the three national credit bureaus; Equifax at (800) 685-1111, Experian at (888) 397-3742, and TransUnion at (SOO) 888-4213; and put a fraud alert on your account.
- Contact the Federal Trade Commission and register an identity theft complaint at (877) 438-4338 or [https://www.ftccom.com/identityassistance.gov/](https://www.ftccom.com/identityassistance).

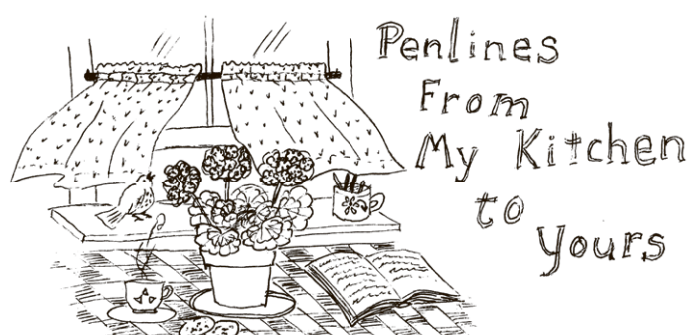

**Buffalo Valley Lutheran Village Receives \$50,000 Grant**



Construction is under way on Buffalo Valley Lutheran Village's new health care center.

Buffalo Valley Lutheran Village has received a \$50,000 grant for its "Love Thy Neighbor" campaign designed to raise capital dollars toward completion of the village's new

health-care center.

The Diakon senior living community received the grant from the Edna M. Sheary Charitable Trust, established to help fund "religious, charitable, scientific, literary, or educational purposes." Born in Snyder County, the late Mrs. Sheary taught school in the Lewisburg area and later as a trust officer and vice president with Union National Bank of Lewisburg, now Mellon Bank NA, which administers the trust.

The \$14 million, two-winged health care center is being built behind, and will be connected to, Buffalo Valley's personal care center along Fairground Road. The center will provide 102 beds, the same as the village's current nursing care building, but is being constructed in what is called a modified neighborhood concept, which staggers rooms and includes strategically placed common space to avoid an institutional appearance for residents. It also will have a large rehabilitation suite.

The Sheary Trust has supported several projects at Buffalo Valley Lutheran Village over the years, beginning in 1994.

BROOKLYN, Mich.— Greg Biffle took the lead from an off-the-pace Jimmie Johnson with only six laps remaining in Sunday's Sprint Cup race and held on through the final restart to earn Roush Fenway's record 12th Cup victory at Jack Roush's home track of Michigan International Speedway.



"We are going to make a run at the title," said Biffle. "I know they don't talk about us a lot, but they will when we get to Vegas." Biffle gained the lead after the engine let go in Jimmie Johnson's No. 48. The win marked Biffle's second of the season. Brad Keselowski tried to catch Biffle during a two-lap run to the finish but fell .416 seconds short, taking second in a photo finish over fast-closing Kasey Kahne. Dale Earnhardt Jr. came home fourth, followed by Marcos Ambrose.

"Greg had a fast car," said Keselowski. "I just couldn't keep up with him. We needed a little more horsepower." Keselowski made reference to "tricks," Hendrick teams may have done on their cars.

"There's parts and pieces on their cars that are moving after inspection that makes the cars more competitive," Keselowski said. "Some guys have it, some don't. There's a question as to the interpretation of the rule."

"I'm not going to slam it. But it's living in a gray area. ... We have to make a re-evaluation of that internally to decide if that's the right way to go."

Carl Edwards, Clint Bowyer, Ryan Newman, Paul Menard, and Martin Truex rounded out the top-10.

A bizarre accident involving polesitter, Mark Martin occurred on lap 65. Bobby Labonte was tapped from behind by Juan Montoya as the cars exited turn-4. Martin, who was running behind the pair lost control and spun down into the pit area. His car hit the concrete retaining wall that protects the crews, and caught on fire. "We've had a rough weekend," said Gordon. "We weren't handling that well and never had good track position. Dale (Dale Earnhardt, his teammate) came up on me and I had to check up, but I know he didn't mean to do it."

But the question is where would the date come from? NASCAR will not add another weekend to the racing schedule. In order for Montreal to host a Sprint Cup event, another track will have to lose one. Therein lies the roadblock for NASCAR to bring its premier circuit to Canada.

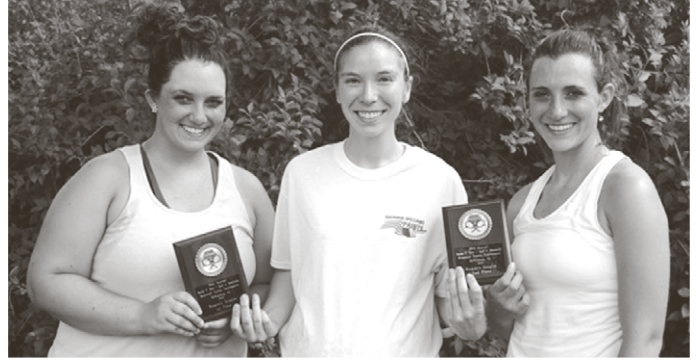

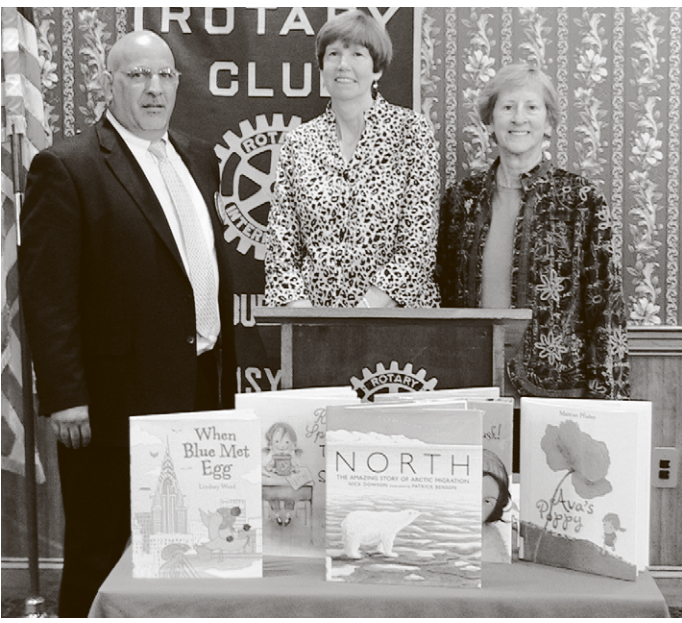

On 6/20/12 the Lewisburg Sunrise Rotary Club proudly presented Alan Barrick with their 2012 Service Above Self Award during their Annual Club Dinner at the La Primavera Ristorante in Lewisburg. Following is Nada Gray's introduction of Alan Barrick to the club members at the dinner.

Missourians have the reputation for having to be shown values before embracing ideas or projects. They may even be thought to share some of the attributes of the state animal, the mule. Often stereotyped as a stubborn animal that needs physical

persuasion to perform, in fact, a typical mule, a male/female hybrid, is patient, even tempered, has cognitive intelligence, is highly intelligent, curious by nature, resistant to disease, long lived, hardy, surefooted and capable of carrying heavy burdens with great endurance.

All of these qualities are recognized and respected by Rotarians, not only in our members but as well in individuals who use them to fulfill our standards of service above self. Our nominee this year is a Missourian, born in Saint Louis, educated at Missouri University and graduated from Washington University with a degree in general engineering-the last class to receive this designation.

Moving to Lewisburg from Houston when hired by Weis Markets, he assumed responsibilities for their mechanical and electronic systems as varied as air conditioning, lighting, production and recycling. He always had an eye on increased production, innovative technology, profit, food safety and customer satisfaction. Innovations not assigned to departments became his duties. Upon his retirement he was replaced with several employees.

Lewisburg inherited his tireless enthusiasm, competency in management, and ability to see projects needed and their solutions.

He served on a study committee to explore joint marketing of the area -now known as Susquehanna Valley. He supported Sunbury's street fair.

The Campus Theatre never has his name on the marquee but he is on twenty-four hour call to fix electrical problems, even simply changing bulbs.

When it was obvious that filling towel and toilet paper rolls was an issue, he took time to instruct volunteers. You will have to ask him how many college graduates it takes to change light bulbs and toilet paper rolls. Setting up shelf and storage systems, painting and general maintenance, he is the man behind the scene which ensures that your visit to the theatre is at least physically enjoyable.

He can be found in his elf costume providing holiday hams and chickens at the Eastern Union County Food Bank. You might have noticed him walking the streets of Lewisburg as an ambassador for the Lewisburg Downtown Partnership. Sans costume he is a regular volunteer at the food bank and as an ambassador.

Affectionately known as the tree man in his year of service on the Lewisburg Cemetery Board, he has supervised the removal of dead, dangerous and diseased trees on the 38 acre lot. At one point it seemed the area might be deforested but he had an answer for everyone who wanted to save a tree. He is presently engaged in finding funds for replacements. Supervising and planting Memorial Day flowers on designated grave sites, hand trimming around monuments and with his wife, Martha, maintaining the baby section of the cemetery keep him busy. Three dumpsters of holiday decorations were removed after March 1 and in the fall 1400 flags will be disposed of properly. The Lewisburg cemetery with its new columbarium and plantings is assuming its proud heritage dating to 1848.

Probably his longest term of service is to his church, the First Baptist on South Third Street. As a vestryman and property manager, he has worked to preserve and improve idiosyncrasies inherent in a building dating from the 1860's. His present preoccupation is repairing the roof, pointing the stone work and restoring the clock in the steeple. He would love to take you up there to view the impressive brass pendulum.

As Ben Franklin, he marched in this year's Fourth of July parade. Formerly he assisted with building the Coldwell Banker float. For many years he got up at six to put out flags and even developed a tool to make the job easier. When the committee needed collection boxes, he built them.

If he is lacking in any of the valued attributes of Missourians-it is patience. As a perfectionist and doer-he wants things done yesterday and right. He is not shy about mentioning that, but always with a smile. He is learning to serve on boards rather than independently. His eye opening experience of working with non-profits with limited budgets and costly projects often leads to lamentations.

In his spare time he shares his love of tennis with his grandchildren, attends their musical performances, athletic events and horse shows. He is a loyal friend and does not hesitate to come to their assistance when called. He and his wife Martha have proudly reared two sons, Brett, a lawyer, Curtis, an engineer, and daughter, Anna, an engineer. We can hardly wait to see the accomplishments of their grandchildren.

Working behind the scenes as the invisible but highly productive and competent performer, the community is indebted in many ways to Alan Barrick. He truly exemplifies service above self. Nada Gray proudly presents him, a fellow Missourian, to our president, Tony Cooper for recognition.

# Maximum Care for One-Day Surgery at Local Hospital

Understanding and compassionate health providers can ease patient anxiety, especially fears associated with surgery. That's the type of atmosphere that can be found in the One-Day Surgery unit of Evangelical Community Hospital, Lewisburg. Nursing staff, anesthesiologists, surgeons and other caregivers understand that by taking the time to listen, inform and answer questions, each patient can gain a sense of comfort on procedure day.

The Evangelical philosophy of care is that each person who enters One-Day Surgery gains a voice through the nurses and staff who are charged with their care, or the care of their loved one. The patient's responsibility is to relax; the staff's responsibility is to do everything in their power to give patients what they need to be able to meet that objective.

With eight new, larger-than-before operating suites, including some of the most modern technology, Evangelical has increased its one-day surgeries each week. Minimally invasive surgical procedures are done with special equipment that can "see" inside a patient without the need to make a major incision. The smaller incisions get the individual back to work or their normal routine due to shorter healing times. Though the surgeries are more minimal in nature, the attention from experienced surgeons and qualified nursing staff is at the highest level for comfort and trust.

Carol Oberlin, Registered Nurse, in the One-Day Surgical unit, says, "We are a family of care providers in our unit, we work as a team and care for and about one another - - that attitude carries through to our patients. They know we will treat them like our own and do everything possible to be their advocates from admission to discharge."

Being an advocate means encouraging questions, arranging time to talk directly to the surgeon, making sure the anesthetist addresses any concerns about going under anesthesia, and even making sure IVs are administered in the most painless way possible. This role of advocate extends beyond the patient to family members who are oftentimes anxiously wondering about their loved one.

Oberlin says, "Our rule of thumb is that every patient could be our own mother, father, child - we ask ourselves what we would want as treatment for our own family members and then treat the patient with that goal in mind."

One unique aspect about the One Day Surgery department is their "humor cart." Filled with DVDs of comedies and other movies, the cart -- a donation from a previous patient who because of his condition required frequent one-day procedures--distracts from the stress and anxiety that can be associated with surgery.

Barbara Bordner, Registered Nurse, Director of Outpatient Services at Evangelical Community Hospital, says, "We do everything we can, through every moment of care, to make one-day surgery run as smoothly as possible so the patient has the best possible experience. It is our job to minimize stress and create trust that they are in good hands of people who truly care about them as individuals."

Before going home, each patient is evaluated to make sure they are truly ready for release - their pain is managed, they are told what to expect at home, and the staff answers all of their questions. Within a few days patients follow-up with their own physician, but in the hours in-between they can contact their surgeon for any concerns they may have after returning home.

One reason the One-Day Surgery unit is successful in providing exceptional care is because patient feedback is given serious consideration. The staff read every patient survey returned and take great pride when they've answered a patient's needs. The ability to see care through the patient's eyes allows the team to build a foundation of care that is uniquely patient driven.

# Local Attendees Part of "Citizens with the Saints"

Some 160 local youth and their adult leaders from the Upper Susquehanna Synod were part of this year's Evangelical Lutheran Church in America (ELCA) Youth Gathering last month. They joined about 35,000 other youth, adults, and volunteers in New Orleans, Louisiana, under the theme "Citizens with the Saints." The three core practices of the gathering were "Practice Peacemaking," "Practice Justice," and "Practice Discipleship."

In the Ernest M. Morial Convention Center, multi-sensory activities were held as part of "Practice Peacemaking." Participants were urged to raise money at home and bring it to the gathering for the "100 Wells Challenge." The ELCA set a goal to raise \$250,000 to support the water projects of ELCA World Hungeraround the world. That amount represents building 100 wells in poor countries, each one with the potential of bringing clean water to 500 families at a time. More than \$406,000 was collected. Trinity Lutheran Church, McClure, took a check for \$1,500 that youth raised before going to New Orleans.

At the convention center, Lutheran Campus Ministry staff and students, and ELCA youth took part in starting the construction of three Habitat for Humanity houses for three families in New Orleans. Other activities of practice peacemaking included artistic expressions, sports and "The Wall," where ELCA youth heard stories of war and armed conflict, as well as stories of hope, from young people and adults who came to the gathering from other parts of the world.

On each of three days of the five-day gathering, about 11,000 ELCA youth and adults were dispersed throughout New Orleans, engaging in nearly 400 service opportunities that ranged from painting a high school to rebuilding community libraries. This was part of the "Practice Justice" theme. Trevor Morehart, of Holy Spirit Lutheran Church, Turbotville, was affected by doing service work in this city.

"The thing that touched me the most was our group's justice day. We went with a group of other kids to Haufmann Triangle to tear down houses and reuse the materials and to spread the word about deconstruction. The group that was from our area handed out flyers to tell people about deconstruction. While handing out flyers we talked to a lot of people that were glad to see us in New Orleans and surrounding areas. Also, people driving by couldn't help but to honk and wave. During that task we came upon houses that have been abandoned or destroyed after Hurricane Katrina in 2005. There is a question going around asking if there has been a lot or a little to fix up. Some people don't realize that there is so much to do and that it will take a while until it gets completely done," Morehart said.

One of the local Lutheran pastors who accompanied youth on this trip agreed that the service day was important.

"Our youth had an amazing experience. On our 'practice justice' service day, one youth said 'Today, we're being the loaves and fishes,' speaking about the Gospel story of Jesus feeding the thousands with a few loaves of bread and fishes. We spent one afternoon working on a literacy matters project, putting together a book fair where the youth spent time reading with young children and more. It was great to witness so many amazing grace moments," Pastor Amanda Range, Salem Lutheran Parish, Selinsgrove, said.

Another group from the synod also had a powerful experience. "We stopped by the police station to hear the stories of what it was like after Katrina. We talked to a man who volunteers there. He shared his story about Katrina and how so many people pulled together during that time. He then went on to tell us that his brother was killed just this year as he was taking his daughter to the bus stop. He heard a woman scream and he ran to help her. He was shot and killed. A reminder of how fragile life is and how listening to others is a great gift," Danielle Ulrich, from Trinity Lutheran Church, McClure, recounted.

Participants were also inspired by worship and Bible study led by 60 of the ELCA's 65 synod bishops, including Rev. Robert L.

Driesen, bishop of the Upper Susquehanna Synod.

"This was a wonderful event, as all these Lutheran youth people gathered to experience fellowship, service, and a deeper love for their faith," Driesen said.

As part of "Practice Discipleship," the youth learned to take their relationship with Jesus Christ to a deeper level, according to one local pastor.

"It was great! We are ready to make a difference in the world. I think the youth really grew in their faith during the Youth Gathering," Pastor Bev Cotner of Messiah/St. James Lutheran Parish, near Muncy, said.

Another participant agreed by quoting one of the songs he liked.

"I won't go back to the way it used to be before Your presence came and changed me," Derek Cotner, from St. James Lutheran Church in Muncy, said.

Every evening, all ELCA youth and adults participants gathered at the Mercedes-Benz Superdome for music, dance, speakers, and more. They were moved and inspired by the Rev. Nadia Bolz-Weber, pastor of House for All Saints and Sinners in Denver, who shared her personal story of overcoming addiction and of her love for the ELCA. Other speakers included ELCA Presiding Bishop Mark S. Hanson; Leymah Gbowee, a 2011 Nobel Peace Prize laureate and Lutheran Liberian peace activist; Shane Claiborne, an author and activist from Philadelphia; The Rev. Andrea Ingram, pastor of St. Michael Lutheran Church in Philadelphia, and AIDS activist; and anti-bullying activist Jamie Nabozny. It was Nabozny's talk that stuck with one youth.

"One of the speakers said that 'Hurt people hurt people.' It made me think about bullying and how many of the people who bully are hurting inside. It was also a reminder to stand up for others who are hurt and unable to use their voice," Hannah Boonie from Trinity Lutheran Church, McClure, said.

The reviews were all positive from those who attended from the Upper Susquehanna Synod.

"The National Youth Gathering was amazing! It was the most inspirational gathering of kids I have ever experienced. The speakers each sent a great message to follow the example of Jesus," Luke Beaver, Zion Lutheran Church, Kratzerville, said.

The ELCA is one of the largest Christian denominations in the United States, with 4.2 million members in 10,000 congregations across the 50 states and in the Caribbean region. Known as the church of "God's work. Our hands," the ELCA emphasizes the saving grace of God through faith in Jesus Christ, unity among Christians and service in the world. The ELCA's roots are in the writings of the German church reformer, Martin Luther.

The Upper Susquehanna Synod, headquartered in Lewisburg, PA, is one of 65 synods of the ELCA. The synod is made up of 131 congregations in Clinton, Columbia, Juniata, Lycoming, Mifflin, Montour, Northumberland, Snyder, Tioga and Union Counties. ## New Car Seat Safety Regulations Can Help Prevent Fatalities

According to the Centers for Disease Control and Prevention, motor vehicle crashes are the leading cause of death for young children, but many of these deaths can be prevented if children ride in a properly fastened and secured car seat.

The Certified Child Passenger Safety Technicians at Community Health Education are experts dedicated to helping the community be aware of and meet the most current car seat safety guidelines. Over the most recent months of car seat checks, Evangelical Community Health found that four out of five car seats were installed incorrectly. Learning how to properly install a car seat only takes a few minutes and is the prevention needed to save the life of a child.

Some of the new car seat safety guidelines include:

- Children facing the rear of the car are 75% safer than those facing forward and should remain rear facing until at least the age of two and thirty pounds or the highest weight limit allowed by the car seat. When installing a rear facing seat, parents must look at the angle indicator on the seat to make sure it is installed correctly to correspond with the child's age, weight, and height.
- Five point harnesses provide more protection than seat belts. Children should not switch to a booster seat until they reach the highest height or weight limits of their harness.
- Children should remain in their booster seat until they are at least 4'9" and must have a lap/shoulder belt. Pennsylvania law states that eight year olds can legally ride in a seat belt, but many are too small for a regular seat belt.
- The center seating position is the safest position, but many vehicle manufacturers do not have the lower anchors of the LATCH system (Lower Anchors & Tethers for Children) in the center seat. To make sure children are in the safest position in the car, the center seat belt may have to be used to install the seat instead of the LATCH system.
- Some newer vehicles (Ford Explorers and Ford Flex newer than 2011, for example) now have inflatable seat belts. These belts have small airbags that come out of the seat belt webbing during a crash. These types of belts are not compatible with most brands of car seats. If you have these seat belts in your vehicle, you will most likely need to install your child safety seats with the LATCH system.
- Most vehicle manufacturers allow a child seat to be installed with the LATCH system up to the weight of 40 or 44 lbs. However, the Chrysler Group LLC (Chrysler, Dodge, Jeep and Dodge/Ram) changed the LATCH weight limits on their new vehicles, as well as many of their existing vehicles to allow the use of LATCH up to 65 lbs. This weight limit is the combined weight of the child plus the weight of the seat. Consult your vehicle manufacturer if you have questions regarding your vehicles weight limits.

Parents can set up a free car seat check Monday-Friday from 8-4:30 with the experts at Community Health Education. Each safety check is personalized for your vehicle and your car seat, the only requirement is to bring the operation manuals for both the vehicle and the car seat you are using.
