ACLU School Handbook Speaker



Margie Torres, chapter board member, and Tony Toluba, chapter president, of the Central Susquehanna Chapter of the ACLU, announce, as a public service, the chapter is making available an ACLU STUDENTS RIGHTS HANDBOOK speaker.

The Central Susquehanna Chapter of the ACLU, with membership in a five county Valley area, announces Harold Jordan, editor of the Know Your Rights will be available to speak between Tuesday, November 13, Thursday, November 15. Jordan is available to speak to high school students, pre-law college and university classes, high school social studies classes, teachers, administrators, school boards, service clubs and parent groups in the Bloomsburg, Danville, Lewisburg, Selinsgrove, and Williamsport areas.

The Central Susquehanna Chapter is doing this as a public service as it believes knowledge of the law will help administrators and school boards avoid actions that could result in costly lawsuits. Several school districts in Pennsylvania have violated the law and thus have been subject to lawsuits and unfavorable court rulings.

Jordan will cover issues as religion, locker, backpack, and strip searches, T-shirt messages, and sex education. Participants will receive a copy of Know Your Rights

A Handbook for Public School Students in Pennsylvania, in English and Spanish editions, while supplies last.

Sims Found Guilty of Murder



After a seven day trial and two hours of deliberation on Wednesday October 31, 2012, Roderick Sims, 50, was convicted of felony second-degree murder for the 2008 slaying of Charity Spickler and could receive life in prison.

During the trial Sims disagreed with his defense team and would speak out in court so he had to wear a shocking device on his leg during the trial. As the verdict was read Sims didn't react but later stated that his conviction was unjust because "it was an all white jury" and that he would

appeal.

Through his attorney, Michael Dennehy, Sims asked President Judge Michael H. Sholley to set aside the verdict based on his claim of prosecutorial misconduct by the Union County District Attorney D. Peter Johnson and the "corrupt process." Sholley denied the motion. Sims was led back to jail after the verdict was read in the Union County Courthouse, in Lewisburg.

Sims was found guilty of second-degree murder and other charges for shooting and killing his fiance Charity Spickler, who is the mother of his three children, on September 27, 2008.

District Attorney Johnson said the Spickler's family and the prosecution were very pleased with the verdict.

Penn State Alumni Association Susquehanna Valley Chapter And Rippon Family Restaurants Doing Business As McDonald's Restaurants

The very first official collegiate football game ever played by the Pennsylvania State University was an away game on the campus of Bucknell University in Lewisburg, PA on November 12, 1887.

The Susquehanna Valley Chapter of the Penn State Alumni Association will observe the 125th Anniversary of this historical event by hosting a social gathering of alumni, fans, the public and the press at McDonald's Restaurant in Lewisburg. The commemorative social will start at 5:30 PM on Monday, November 12th, exactly 125 years to-the-day after this first Penn State football game.

For many years, a large print of the 19th Century campus of Bucknell University has hung in the north atrium of McDonald's of Lewisburg. This reproduction of an old print depicts clearly football players on the original football field surrounded by a track. A framed poster will be unveiled at the gathering next to the print which explains to on-lookers that they are viewing the scene where the very first Penn State football game was played. Penn State won 54-0.

A few short comments will be made by a few presenters. Each person who attends the November 12th gathering at McDonald's will receive a gift memento from the two sponsors which commemorates the 125th Anniversary gathering.

First Local Red Cross Volunteers Deployed



The first volunteers from the SUN Area chapter of the American Red Cross left Nov. 2, for Northeastern Pennsylvania where they will work in a shelter. Many families who were evacuated from the New York and New Jersey coastline are staying in shelters in the area while they wait to see if they may return to their homes. Sadly, many of them will not be able to. As those families begin to make the long and arduous journey towards recovery, they will need a place to stay, a shoulder to lean on and practical support. That is exactly what Red Cross volunteers provide. Bill Hart from Montoursville, and Deb and Scott Weaver from Mt. Carmel are on their way to offer their help.

For Hart, this is the first time he has done something like this and he said "It's appropriate; it's an extension of what I've been trained to do." At age 79 he is retired and able to commit to the possibility of a three week stay away from home. He came to Red Cross through the Americorps program which matches volunteers to community agen-

cies for extended periods of service. For the Weavers, this is one of many deployments they have made. Both are seasoned volunteers with years of experience between them. "We'll be listening to people tell their story, helping them come to terms with their losses and just being there for them," said Scott. The American Red Cross has volunteers on standby across the region, waiting to go where they are needed most. Anne Smith, Communications Coordinator for the SUN Area said "There are volunteers in our area from St. Louis, Missouri, Indiana and Michigan who are serving the needs of families here who have been adversely affected by Hurricane Sandy." "They will move throughout the region and help as needed until their three week deployment is up." She added. 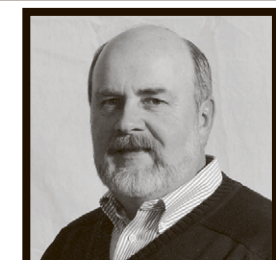

Evangelical's Future Center for Orthopedics Granted \$50,000 From Local Foundation

The Center for Orthopedics at Evangelical Community Hospital, slated for completion in early 2013, was awarded a grant of \$50,000 from the Williamsport-Lycoming Community Fund at the First Community Foundation Partnership of Pennsylvania. Evangelical Community Hospital President & CEO, Michael O'Keefe, was presented with the gift on October 5 during the 2012 Fall Competitive Community Grant Reception. The funds are designated for construction and renovation of the Center for Orthopedics. The grant was one of several totaling \$443,000 awarded by the Foundation to support a wide array of community needs.

The new Center for Orthopedics will expand the hospital's rehabilitation space, which will include a therapy gym and dining area, and designate a centralized patient care area for all orthopedic surgery patients.

The Center will house the Hospital's Joint Replacement Program, which since its opening in 2005, has completed nearly 2800 joint replacements. The Joint Replacement Program gets high patient satisfaction marks from patients with consistent scores in the upper 90th percentile. Building on that success, the Hospital is constructing a Center for Orthopedics to provide care for patients receiving and recovering from a wide-range of orthopedic procedures including spine surgery, fractures and sports injuries, in addition to total joint replacements.

"Our goal at Evangelical is to be a health care facility that serves the medical needs of our community. The demand for orthopedic surgery continues to grow as people live longer and want to stay active and healthy," said Tami Radecke, Vice President - Community Relations for the Hospital. "The new Center will provide a seamless continuum of care for all orthopedic patients from pre-registration to discharge without sacrificing our patient-centered mission and focus. It will provide dedicated space and personnel that maximizes our current building footprint without the cost of adding a separate facility."

The Center, which will be located adjacent to the eight new surgical suites which opened in July of this year, will offer convenient and centralized services to patients requiring orthopedic procedures.

Evangelical Community Hospital is a non-profit organization that employs approximately 1,300 people and has more than 170 employed and non-employed physicians on staff. The Hospital is licensed to accommodate 127 overnight patients, 12 acute rehab patients and 18 bassinets. The Hospital serves residents throughout the Central Susquehanna Valley, including those living in Snyder, Union, Northumberland and Lycoming Counties.

Johnson Gets Second Win In A Row

FT. WORTH, Tex.—A determined Jimmie Johnson outraced Brad Keselowski on a green-white-checker finish to win Sunday's Texas Sprint Cup race, and extend his lead by seven points over Keselowski, with two races to go.

"It was an awesome race," said Johnson. "I think our cars were pretty equal, but our four tires were a little better than his two. We got a good restart, and were able to get by him."

"That's what it takes to win championships." Johnson led the most laps, but faded to fourth after about lap 212 of the 334-lap race. As the laps wound down, Kyle Busch and Brad Keselowski took turns leading. The race's ninth and final caution set up the green-white-checkered finish.

Johnson was lined up on the outside of the leader, Keselowski. Both drivers got a good start. As the two leaders entered turn-2, Johnson pulled ahead of Keselowski, and it was 'bye, bye,' as he headed for victory lane.

"Man, I thought I had it," said Keselowski. "I really hate to lose one that way. We raced hard. I couldn't do any better. But we're gonna race hard all the way to Homestead."

Keselowski took only two tires on his last pit stop, while Johnson and the other leaders took four. He was barely able to stay ahead of Kyle Busch, who finished a close third.

"We were really fast today when we got up front," said Busch. "At the end I wanted to get the car out front in the clean air, but I couldn't get there."

Matt Kenseth, Tony Stewart, Clint Bowyer, Dale Earnhardt Jr., Kurt Busch, Kevin Harvick, and Greg Biffle, were the remaining top-10 finishers.

With just two races left in this year's NASCAR season, the championship is down to only two contenders, Jimmie Johnson and Brad Keselowski. All the others will have to wait until next year.

Polesitter Kyle Busch ran third, followed by Ricky Stenhouse Jr., who erased the six-point series lead Elliott Sadler held when the race began. Stenhouse, the defending Nationwide champion, is tied with Sadler with two races left in the season.

Denny Hamlin ran fifth, with Austin Dillon, Sam Hornish Jr., Justin Allgaier, Kevin Swindell and Joey Logano completing the top-10.

TELEVISION STILL LOVES NASCAR

There is still a loving relationship between NASCAR and television executives.

At least that's the case if you look at the new 13-race television package Fox signed with NASCAR. It's worth \$300 million per year. That's up from the current contract of \$200 million.

That averages out to \$23 million per race. Track owners get 65 per cent, teams share 25 per cent, and NASCAR gets the remaining 10 per cent.

TV has changed the sport more than anything else. When television came onboard, the money began to roll in. Costs went up because everyone had to have the best money could buy. The faster the cars went, the more it cost to run them.

There are many "ifs and buts," like the high cost of hotel rooms, poor economy, gasoline prices, and costs to get in the track, but it seems to me like the sport is being controlled more and more by television and a handful of car owners, who want to keep it that way.

Bruton Smith, the eccentric billionaire whose Speedway Motorsports Inc. owns eight NASCAR tracks, held court in the Texas Motor Speedway media center on Saturday and addressed a wide range of subjects.

"NASCAR needs to make the racing more exciting," he said. "They have made some good moves in recent years - notably double-file restarts - but needs to implement additional improvements, like slow the cars down and thus make it easier for drivers to make bold moves."

Races with too many long green-flag runs are not exciting, Smith said, and he suggested a smaller fuel tank would force drivers to make more pit stops. Fuel-mileage races, he said, are "boring, boring, boring." One solution could be a minimum number of cautions per race to serve as TV timeouts.

Drivers are "maybe not as eager" right now and NASCAR needs more racers who have a "mean streak."

Smith is still supportive of the Chase. He sounded concerned, though, that the playoff drivers get treated with kid gloves.

It's NASCAR's job to promote a sellable product the fans will like and want to see more of.

Apparently the television companies see something they like, but a lot of fans I hear from say the sport is stagnant, and something needs to be done.
