State Employee Charged with Theft



On Thursday, August 22, 2013, the Attorney General's Office arrested Marylinda Freyermuth, 54, of McAlisterville, for allegedly stealing money from the state while she was an employee.

Freyermuth worked for DCNR at the Bald Eagle State Forest Office in Laurelton and stole more than \$12,000 that was collected for permits. She also used a credit card to make purchases for herself and family members totaling \$2,614.

Freyermuth is charged with one count of theft by failure to make required disposition of funds received, one count of theft by unlawful taking or disposition, one count of access device fraud and one count of conflict of interest.

She was arraigned before District Judge Jeffrey Mensch and released on \$50,000 unsecured bail. A preliminary hearing is scheduled for August 27. The case will be prosecuted in Union County by Senior Deputy Attorney General Anthony Forray a member of the Attorney General's Criminal Prosecution Section.

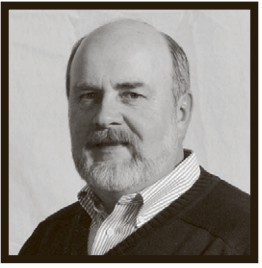

Logano Gets Michigan Win

BROOKLYN, Mich.—Polesitter Joey Logano won Sunday's Sprint Cup race at Michigan International Speedway.

Logano had a fast car, but as the laps wound down in the 200-lap race, he found himself running second to Mark Martin. But he didn't have to worry about getting around Martin, because with two laps remaining, the fuel tank in Martin's No. 55 ran dry.

Logano was the new leader, and all he had to do was keep the second-place finisher, Kevin Harvick, in his rearview mirror.

"This is unbelievable," said Logano. "When we started the race we weren't too good. The guys kept tuning the car until here we are."

The win was the first for Logano since 2012, and the first as a driver for Penske Racing. A.J. Allmendinger, driver of Penske's Nationwide car won Saturday at Mid-Ohio road course.

"We knew we needed another caution if we were going to win the race," said Martin, who finished 27th. "We didn't pull it off, but we showed we had the speed."

Kevin Harvick led some laps during the midway point of the race, but could not close on Logano near the end.

"You know when we could get out front, we could hold Joey off," said Harvick. "All in all it was a good day. We've put ourselves in a good position for the Chase, and that's when the real racing will begin."

Kurt Busch finished third. He was able to lead, but each time he pitted, he would lose several positions, and on the last restart, was not able to make it back to the front.

"Third was as good as we could hope for today. We just didn't have the speed," said Busch.

Paul Menard was fourth, followed by Clint Bowyer, Marcos Ambrose, Kasey Kahne, Jeff Burton, Greg Biffle, and Carl Edwards.

Austin Dillon, who was subbing for the injured Tony Stewart was 14th.

"We got too fancy and messed up NASCAR," said Humpy Wheeler in a YouTube post. "I think we've messed it up a little, folks. I think we got too fancy. And those people were dead wrong."

"We need to put the emphasis on winning, he continued. "And

we need to put the emphasis on leading and passing people as the race progresses. Give points for the repass. People in the grandstands are gonna go crazy when we do that."

"Give winners and leaders bigger bonuses. That will make races more exciting and that will bring fans back to the track. You've got to give them a reason to come back to the ballpark, whether the ballpark is a racetrack or whether it's a stadium. Part of that reason is excitement."

Wheeler went on to say that one of the reasons fans are staying away from the track is the increases in the quality of TV broadcasting. Due to better TV coverage, fans are satisfied to stay home and watch.

But better TV coverage doesn't always equate to more fans viewing. Television ratings for 2013 are slightly lower than 2012. Each year for the past four racing seasons, there has been a decline.

STEWART OUT FOR THE YEAR

Tony Stewart is out for the remainder of the 2013 season after suffering a broken right tibia and fibula in a sprint car crash Aug. 5 at Southern Iowa Speedway. Stewart, a three-time Sprint Cup champion, is expected to return to the seat of the No. 14 Chevrolet in time for pre-season testing in January 2014.

Felix Sabates, co-owner of Earnhart-Ganassi Racing, said Juan Montoya, driver of the No. 42 will not return in 2014.

"We did not renew the contract for next year," Sabates said on Sirius Radio. "It was a difficult decision. He understands. You have to move on in life sometimes. It's frustrating for everybody when you know you've got good equipment and you can't seem to put everything together."

Jamie McMurray, driver of the No. 1 EGR car is expected to return in 2014.

Chase contender Ryan Newman could be viewed as a candidate to drive the No. 42 car, because he does not have a contract for next season.

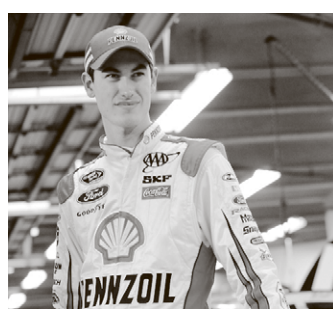

High blood pressure can greatly increase your risk for heart disease and stroke, but there's good news if you are living with this condition. In addition to medication, there are proactive steps you can take to control your blood pressure and help improve your heart health.

Certain populations, such as women and African-Americans, are at greater risk for high blood pressure, also known as hypertension, according to the American Heart Association. After the age of 65, a higher percentage of women have hypertension as compared to men. Additionally, approximately 40 percent of African-American women have high blood pressure. Higher rates of obesity and diabetes, compared to other groups, also put African-Americans at greater risk for high blood pressure and heart disease.

Other risk factors, such as family history, advanced age, lack of physical activity and poor diet—especially one that includes too much salt—can also contribute to high blood pressure.

Tips For Taking Control

Take control of your blood pressure with these six tips from the American Heart Association that are good for your heart and brain:

1. De-stress. Take a break from work and listen to relaxing music or meditate.
2. Fit in physical activity. Regular, moderate-to-vigorous physical activity can help keep your blood pressure and cholesterol at heart-healthy levels and help you maintain a healthy weight. Walking is a great way to get started, but also consider jogging, yoga or a cardio class.
3. Eat heart-healthy foods. Healthy foods give you more energy, keep your brain fed and help prevent other health problems. If you've got to "eat on the run," choose nutritious snacks.
4. Reduce your sodium intake. Eating too many salty foods can lead to high blood pressure. The average American consumes more than twice the 1,500 milligrams recommended by the American Heart Association/American Stroke Association. More than 75 percent of the sodium consumed in the U.S. comes from processed and restaurant foods.
5. Limit caffeine. Water is usually the best choice.
6. Don't smoke. Smoking is the No. 1 preventable cause of death.

These factors hit home for Tisha Dixon-Williams. At 31, she thought she was pretty healthy, despite a junk-food diet. Then one day she felt dizzy and couldn't maintain her balance.

"I didn't want to accept that something could be wrong," she said. "I finally went to the doctor, and when I walked in my blood pressure was 190 over 120. I was a walking stroke."

The Brooklyn resident also found out that high blood pressure ran in her family. She now controls her risk by doing something she loves: dancing. Other positive lifestyle changes, such as eating more nutritious foods as well as taking blood pressure medication, have helped her gain control both on and off the dance floor.

Taking small steps toward eating healthier and getting more physical activity is a commitment that more people need to adopt, said Jennifer Mieres, M.D., American Heart Association spokesperson and Medical Director, Center for Learning and Innovation, North Shore-LIJ Health System in New York.

"We need to remember that 80 percent of heart disease is preventable, so simple changes can help," she said.

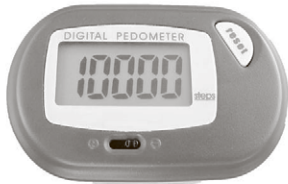

An "Eye-Opening" Shift In Classroom Learning

Computers and Smart Boards are a common staple in today's classrooms, and with programs like "bring your own device" to school, smartphones and tablets are also seeing increased use in schools. The use of technology both in and out of the classroom has many benefits for students, but it can also take a toll on their eye health and vision if proper precautions aren't followed.

According to the American Optometric Association's (AOA) 2013 American Eye-Q survey, 85 percent of parents indicate their children use electronic devices up to four hours per day. The survey also indicates that 41 percent of children have their own smartphone or tablet and 32 percent use both e-books and textbooks at school. Additionally, 66 percent of children use a computer or tablet to do homework or study. With the consistent use of electronic devices both in and out of school, children of all ages can face a number of visual challenges.

Frequent, prolonged use of technology can lead to a temporary condition called computer vision syndrome, or CVS. Symptoms may include eyestrain, headaches, fatigue, burning or tired eyes, loss of focus, blurred vision, double vision or head and neck pain. To rest eyes, students should follow the 20-20-20 rule—take a 20-second break every 20 minutes and view something 20 feet away.

As the use of electronic devices increases, eye doctors are providing age-specific tips and warning signs for parents and teachers to be on the lookout for this school year that may indicate an undiagnosed vision problem or CVS:

- Preschool/Kindergarten Children: Limit tech time to two hours or less and increase screen font size. During this stage, parents should also be aware of physical signs that may flag a potential vision problem, such as:
 - Improper eye alignment or if one or both eyes turn inward or outward
 - Excessive blinking or eye rubbing when children do near work
 - Difficulty recognizing colors, shapes, letters and numbers.
- Elementary School Children: Encourage kids to use smartphones only for quick tasks such as texting and to position devices half an arm's length away—slightly below eye level. Parents should ask children at this age:
 - Do words "swim" on a screen or in a book? Do they lose their place frequently when reading?
 - Does the child experience frequent headaches during the school week or while performing near work?
 - Are the child's grades high in nonvisual classes and lower in other, more visually focused classes like math or reading?
- Middle/High School Children: Remind students that computers should be positioned 20 to 28 inches away from their eyes, with the top of the screen at eye level. Background settings on smartphones should be adjusted to keep vision comfortable. To stay involved with children's vision, parents should ask:
 - How long can my children read before they need to take a visual break?
 - Does my child perform with a lowered level of comprehension?
 - Does my child experience discomfort or fatigue or have a short attention span?

Additional warning signs include:

- Squinting while reading or watching television
- Turning or tilting the head or covering an eye
- Consistently performing below potential or struggling to complete homework
- Having behavioral problems.

The AOA recommends that a child's first eye exam take place at 6 months of age, then at age 3, again before kindergarten and yearly thereafter. To find an optometrist nearby, or for additional information on children's vision and the importance of eye exams, visit www.aoa.org.

1st Annual Worldwide Cystic Fibrosis Day

Cystic Fibrosis Worldwide (CFW) will host the 1st Annual Worldwide Cystic Fibrosis Day on September 8th with the support of their 62 member countries, and Pennsylvania Cystic Fibrosis, Inc. (PACFI), will join them in celebrating the event.

"We're glad CFW is hosting this event," PACFI President Betty Hollenbach said, "because it helps our organization by making more people aware of cystic fibrosis (CF) and its major impact on children and young adults." Hollenbach has a grandson with the disease.

CF is a life-threatening genetic disease that primarily affects the lungs and digestive system, and currently the average life span is 37 years. A defective gene causes the body to secrete thick mucus that clogs the lungs and other organs leading to major infections. About 30,000 people in the United States have CF, and 10 million people in the nation carry the CF gene. If both a male and female have the CF gene and decide to have children, the odds are one-in-four that they will have a child with CF. A carrier test is available to determine if a person has the CF gene.

On September 8, 1989, Dr. Lap-Chee Tsiu's discovery of the CF gene was published. Dr. Tsiu worked in the department of genetics at the Hospital for Sick Children in Toronto where he received a Distinguished Scientific Achievement Award for his discovery. Tsiu's discovery was lauded as one of the most significant in human genetics and it opened the door to more research into long-term beneficial treatments or a cure for the disease.

"We are really focused on making this first Worldwide CF Day a huge success," said Christine Noke, Executive Director of CF Worldwide who is based in Izmir, Turkey. "The major goal is to spread awareness about this life-threatening genetic disease." Noke also noted another goal is to offer members an international platform to raise funds, gain volunteers, and lobby local officials to support patients and research.

"PACFI was formed in 1985 and we're dedicated to providing services and supports for Pennsylvania individuals and families affected by the disease," Bob Derr, founder and public relations person for PACFI, said. "We also allocate funds to CF researchers every year, and we applaud CFW's effort in hosting Worldwide CF Day."

Derr's son, Burke P. Derr, died due to CF in 1997 a few months after two of Burke's friends convinced The Boyds Collection to name a teddy bear in his honor. PACFI began the Million Dollar Bear campaign and Burke's Tour in late 1997 as a way to increase awareness and raise funds for research. Co-sponsored by former state representatives Merle Phillips and Russ Fairchild, House Resolution 198 was unanimously passed by the Pennsylvania legislature in 1999 titling Burke P. Bear as "The Pennsylvania Ambassador for Love, Peace, Having Fun, and Curing Cystic Fibrosis." Dubbed the "Globe-Trotting Ambassador of Love" by a British magazine, Burke P. Bear has toured 47 states and 23 world countries in raising over \$450,000 for CF research. The bear hopes to visit Nebraska, South Dakota and Rhode Island by the end of this year to finish his U.S. Tour.

"We've also raised over \$300,000 in supporting the needs of Pennsylvania citizens affected by the disease," Derr added. PACFI provides air conditioners, portable nebulizers, other CF-related equipment, medications and travel expenses not totally covered by insurance, scholarships for students with CF who want to continue their education, advocacy services for families and students, and educational in-services to schools and community organizations.

"CF Worldwide has partnered with PACFI and Burke P. Bear to raise funds and awareness about CF in developing countries," Noke said. "PACFI is one of the few non-governmental organizations (NGOs) out there that still operates with volunteers only and are totally dedicated to helping people who suffer from cystic fibrosis."

Derr and his wife, Linda, worked with Noke in having Burke P. Bear create awareness and raise funds for CF clinics in Tbilisi, Georgia (of the former Soviet Union), India, and other countries. PACFI has sent Burke P. Bears to England, Ireland, Australia, and other world countries at no cost to the organization.

With an extensive international network of parents, patients, medical professionals and researchers, PACFI sends donated equipment, enzymes and/or vitamins to other countries when the receiver is willing to pay the shipping costs. PACFI is known throughout the worldwide CF community. It is the only organization of its kind in the nation.

LEWISBURG- Evangelical Community Hospital hosted its 27th Golf Classic Event on Friday, August 16, 2013, at the Susquehanna Valley Country Club. The event was a great success, raising over \$40,000 for Pre-Hospital Services.

A vital part of Evangelical's services to the community, Pre-Hospital Services provides life-sustaining treatments performed by highly qualified, experienced paramedics and EMTs at the scene of an emergency.

From July of last year to July of this year alone, Pre-Hospital services answered nearly 11,000 calls and of those calls, 7,500 patients were transported to a hospital. Those calls included medical emergencies such as stroke and heart attack, trauma incidents from motor vehicle accidents, falls, assaults and sports injuries, miscellaneous injuries such as animal bites, drowning and electrocutions, and stand-by incidents such as fires and law enforcement requests where injuries may occur during response. In total, Pre-Hospital units traveled approximately 330,000 miles last year alone for emergency responses, that's almost 63 trips to Los Angeles and back.

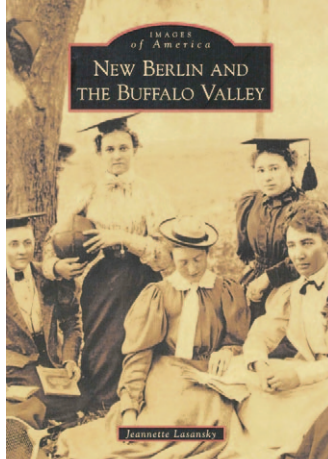
Nick Klose, Director of Pre-Hospital Services said, "The services of our department are something people hope they never have to need. But if an emergency arises, our team of professionals is there to respond quickly with their medical expertise and reassurance for the families of the patients. Funds raised support equipment and other medical supply needs that give our experts the tools they need to save lives."
