license and the first woman to ever fly across the English Channel. Their performance combined with their first-place score in the spontaneous event at the April state finals put them ahead of 8 other Pennsylvania teams in their category to qualify them for the World Finals. In 2019, five of the six young women on this team qualified for their first Worlds competition, and prior to that, the only other time that a team from Lewisburg had reached the finals was in 2015, making this a truly historic achievement.

"Odyssey of the Mind is such a special competition because it is an opportunity to get closer to friends while also competing against other teams," said team member Linghan Wan. "The most fun part is creating the props, and the hardest part is usually creating the script. The most important part is having an open mind and being as creative as possible." According to her teammate Ceili Kisvarday, "The judges like it when you do the unexpected and creative, and I like the feeling of achievement that we made it so far. The most important thing I take away is a sense of being part of an international community, and working as a team!" Lewisburg Area School Board president Virginia Zimmerman added, "Odyssey of the Mind requires creative problem-solving, hands-on learning, and sustained teamwork. The community should be very proud of this team for their extraordinary success in heading—for the second time—to the World Competition." The team is also very grateful to received support from both the Parents School Association (PSA) and Green Dragon Foundation to help make the students' trip to Iowa possible.

For the first time in the history of Lewisburg, a team of young women will be traveling for a second time to compete in the "Odyssey of the Mind" world finals competition, taking place this year in Ames, Iowa from May 25-28. The six students from Donald H. Eichhorn Middle School and Linntown Elementary, coached by Chris Kisvarday, Susannah Kisvarday, and Linda Smolka, captured first place for their category in the Pennsylvania states championship contest in April and earned the chance to move on to the upcoming World Finals event, competing against hundreds of teams from all across the U.S.

Odyssey of the Mind is a volunteer-run, international creative problem-solving program for K-12 students in which they learn the value of brainstorming and teamwork. At each competition event, the students perform an original, creative presentation that they have written and designed on a specified topic, and they are also given a challenging 'spontaneous' problem to solve that they have never seen before prior to the day of the competition. This year, the team of six young women—Clara Graham, Ceili Kisvarday, Abby Ryu, Rachel Ryu, Maya Sak, and Linghan Wan—wrote and performed a short, completely original musical about the life of Harriet Quimby, the first American woman to earn a pilot's

This weekend at Williams Grove speedway the W00 sprint car series will be on hand for two races on Friday night and Saturday night for \$10,000 and \$12,000 to win features. Brad Sweet is leading the W00 series points over Carson Macedo and David Gravel only 20 and 30 back in the standing going into the Wednesday show at Lincoln speedway, Macedo leads the way with four feature wins, one for Sweet and two for Gravel. The grove has had five different feature winners in five races with four events cancelled due to weather. Justin peck won the tracks opener, Dylan Norris, Anthony Macri, Brents Marks picked up the win against the All Stars and Devon Borden. Danny Dietrich is leading the Grove point standings by 10-over Dylan Norris Freddie Rahmer is third. May 20th the 358-sprints will try again to get there first show in of the season, two events already have been weathered out. The Grove closes out the Month of May with the All Star sprint back for the Randy Wolfe Tribute race on May 27th for a \$10,000 top prize. One each of the 305-sprints Wingless and winged 360-sprints have been run at the Grove with Dave Grube winning the 305-feature with a field of 25 drivers on hand, Briggs Danner the wingless sprints 21 drivers in action and Josh Weller the Wing sprints with a solid field of 32, with some 358 sprint drivers also racing at the April 29th event. Two late model shows have been run at the Grove back in March with Gregg Satterlee winning over Rick Eckert with the next Friday they reversed the finish with Eckert over Satterlee. Both of these drivers and more can be expected at Selinsgrove speedway this Saturday for the Ron Keister Memorial race for the super late models, paying the winner \$5,200 to win \$4,000 for second \$2,000 for fifth, \$1,200 for 10th, \$1,000 for 12th and \$400 to start the feature. Special bonus money will also be paid out with \$210 for Hard Charger, \$110 to win heats and B-mains, along with fast time, and \$250 for the team with the longest tow. The Limited late models will also be racing this Saturday for \$1,200 to win, this will be the first race for the Limited's this season with the first schedule event weathered out.

Clinton County speedway has run off three straight programs before rain ended the streak last Friday. The tracks runs the Laurel Highland 305-sprints and in two events Tylor Cochran scored his second career feature win in the opening night program, with Josh Beamer getting his first ever feature win on Friday April 29th, they will be back in action this Friday night, so far 22-drivers and 27-drivers have signed in for the two programs. The 600-wing micro-sprints have run two shows with Johnny Smith an Cody Hauck scoring feature wins, Hauck and his Wife Sierra chased Smith on the first night with Trevor Teats and Jeff Weaver on the second program followed Cody. @70-micro sprints have run three features with Jeff Weaver scoring two feature wins one on opening night and the other on April 29th, Timmie Bittner has the other feature win. On these night both Weaver and Bittner run in three divisions, 600 and 270-micro sprints and also in the 305-sprint division. The 410-sprints will be visiting for the second season in a row, on Saturday August 13th with the event titled the Phil Walter Classic, Phil has 29 feature wins at the track and won the 1993 track championship.

Three stock classes race at Clinton County with the Limited late models scheduled for nine events, one was rained out last Friday and the other was won by Andrew Yoder after race leader Kevin Probst had nowhere to go when a lapped car spun in front of win costing him what would have been his first late model win. Matt Cochran and Jim Yoder placed second and third. The next race for the limited late models will be on Friday May 20th, with Friday May 27th back for there fourth scheduled show the Laurel Highlands 305-sprints. Pro-Stocks have run three features with Brandon Moser winning the first two races, with the divisions defending champ placing third in the third event, which was won by AY Schilling for his career 58th feature win Schilling has been racing at the speedway all most from the first night the speedway opened in 1989. The four-cylinder class has been a real force at the speedway with close to 100-different drivers racing at the speedway in the 2021 season, and already in three nights of racing 43 different drivers have competed in this great brand of low-buck started class of racing. Three different drivers have found victory lane this year with Dylan Craft winning opening night Hunter Flook getting his first ever win on night two and defending champ Blake Snyder winning on Friday April 29th.

# Clinton County Speedway News

Clinton County Speedway successfully brought 410 Sprint Car racing back to the 3/8th mile oval for the first time in over a decade in 2021. This year, with much anticipation from fans and drivers, the 410s will return on Saturday, August 13th, presented by NAPA Toner Auto Parts.

This year's 410 race will be named in honor of the speedway's all-time 410 sprint car feature winner, Phil Walter of McClure, PA. Walter was the 1993 division champion and has 29 victories at the speedway. Walter's first career win at Clinton County came on May 12, 1989. He earned four wins during the Speedway's inaugural season in 1989.

"Walter was one of the original stars of the Clinton County Speedway," says speedway promoter Jason McCahan. 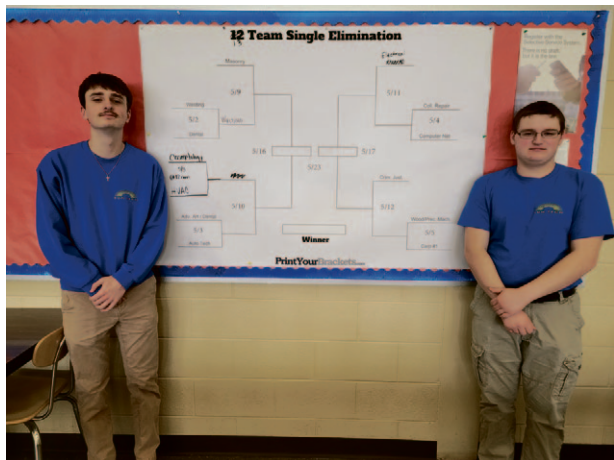
## Candidates Invited By LWVLA

# Evangelical Community Hospital Adds Transesophageal Testing

Evangelical Community Hospital recently added accreditation for adult transesophageal testing (TEE) to its existing Echocardiography Accreditation by the Intersocietal Accreditation Commission (IAC). The accreditation demonstrates the Hospital's ongoing commitment to providing quality patient care in echocardiography through the Heart and Vascular Center of Evangelical and is in place until 2023.

TEE uses high-frequency sound waves (ultrasound) to make detailed pictures of the heart and the arteries that lead to and from it. Unlike a standard echocardiogram, the echo transducer that produces the sound waves for TEE is attached to a thin tube that passes through the mouth, down the throat, and into the esophagus. Because the esophagus is so close to the upper chambers of the heart, very clear images of those heart structures and valves can be obtained.

TEE is just one part of Evangelical's Echocardiography program used to assess different areas of the heart and can detect heart disease or signs of serious conditions. With the addition of TEE accreditation, the IAC accreditation for the Hospital's existing echocardiography program covers TEE, adult stress testing, and adult transthoracic testing.

There are many factors that contribute to an accurate diagnosis based on echocardiography. The training and experience of the sonographer performing the procedure, the type of equipment used, and the quality assessment metrics each facility is required to measure, all contribute to a positive patient outcome. IAC accreditation is a "seal of approval" that patients can rely on as an indicator of consistent quality care and a dedication to continuous improvement.

"Accreditation for TEE by the IAC means Evangelical Community Hospital has undergone an intensive review process and is found to be in compliance with the published standards for that testing process," said Christopher Brancato, MD, FACC, Medical Director of the Echocardiography Laboratory at the Hospital. "Our teams continue to deliver high-quality echocardiography services in a compassionate and comfortable environment that allows us to provide accurate final diagnostic reports for proper treatment and care.
