

Discounted Elevation Certificates For Lewisburg Homeowners

Lewisburg homeowners who live in the 100-year floodplain can get discounted elevation certificates that can reduce their flood insurance costs. The Federal Emergency Management Agency (FEMA) elevation certificates cost \$700 for these homeowners. This is a discounted group price that SEDA-Council of Governments (SEDA-COG) negotiated with Orangeville Surveying Consultants Inc. Without the discount, the rate can be as expensive as \$2,000.

Residents must own and occupy their homes.

Geralee Zeigler, a program analyst in SEDA-COG's Flood Resiliency program, explained how elevation certificates can reduce flood insurance premiums.

"Your insurance agent will use the elevation certificate to compare your building's elevation to the Base Flood Elevation shown on the map being used for rating and determine the cost to cover your flood risk," Zeigler said. "If the elevation certificate shows your property at a high elevation, it will lower your flood insurance cost."

Zeigler said the certificates also can help when homeowners want to sell their homes.

"Not only can elevation certificates greatly reduce flood insurance premiums, they also make a home more attractive for buyers since the buyer will know where the house stands in relation to the floodplain and knowing they'll have less of a flood insurance cost," Zeigler said.

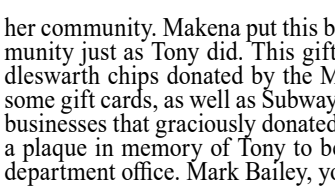

Game Commission Hosting Waterfowl Briefing

Hunters and members of waterfowl organizations are invited to virtually attend the Pennsylvania Game Commission's Annual Waterfowl Briefing, which will be streamed live via the agency's Facebook page, on Wednesday, March 10, at 1 p.m. The briefing will be recorded and a link will be available to view online at www.pgc.pa.gov.

During the live briefing, Game Commission Waterfowl Biologist Nate Huck and Wildlife Management Program Chief Ian Gregg will be discussing the proposed 2021-22 waterfowl hunting seasons, proposed regulations, proposed federal frameworks and the 2020 waterfowl hunter survey results. A question-and-answer session will follow the presentation.

"We're looking forward to hosting the annual briefing live on Facebook this year," said Huck. "This meeting is usually held in-person, but in an effort to reach more people and due to safety concerns related to Covid-19, it will be held online this year. Those who are interested in learning more, and weighing in, on issues related to waterfowl hunting in Pennsylvania are encouraged to attend."

Proposed 2021-22 waterfowl seasons, as well as the 2020 waterfowl hunter survey results, have been posted online at www.pgc.pa.gov and can be accessed by searching, "Waterfowl Hunting and Conservation." Those planning to tune in to the live briefing are encouraged to review the proposed seasons in advance.

Public comments on the proposed seasons can be submitted via email to waterfowlcomments@pa.gov or via mail to Pennsylvania Game Commission, Bureau of Wildlife Management, 2001 Elmerton Ave., Harrisburg, PA 17110-9797 through Sunday, March 21.

With public comments and results of the 2020 waterfowl hunter survey in mind, Game Commission staff will prepare and present the recommended 2021-22 waterfowl and migratory bird seasons, bag limits and related criteria to the U.S. Fish and Wildlife Service (USFWS) for final approval.

All migratory bird hunting seasons and bag limits must conform to frameworks set by the USFWS. States select their hunting seasons within these established frameworks. Final seasons will appear in the 2021-22 Pennsylvania Hunting & Trapping Digest. The Pennsylvania Game Commission manages and protects wildlife and their habitats and promotes hunting and trapping for current and future generations. Library Announces Capital Campaign, Funds Needed

Community support is needed to help the Public Library for Union County reach its goal of \$900,000 to meet the local match requirements for two significant grants, by March 31 for an expansion and renovation project.

"Our ReImagine, ReFresh, RePurpose campaign is making changes to our building that will ensure we continue to play an important role in education and access for people of every age and background in our community," said Library Director Roberta Greene. "We are grateful for the support of individuals and businesses and hope the community will join in to raise the remaining dollars by the end of March."

Eighty percent of the library's ReImagine, ReFresh, RePurpose campaign has been raised in effort to match the grant funding already secured for the project: a \$750,000 Keystone Recreation, Park, and Conservation Fund Grant and a \$100,000 grant from the Stabler Foundation.

An 1,150 sq. ft. addition is already underroof and will be part of the new Children's Library featuring the children's collections, programming space, an ADA compliant family restroom, storage, a service desk, and seating areas where adults and children can sit and learn together.

Also included in the redesign of the library is an updated adult space moved closer to the library's main entrance. Throughout the library, new seating, tables, outlets and counters will facilitate work, technology use and collaboration. A reconfigured check-out desk will maximize space and adapt to changing methods of providing services.

Visitors are encouraged to bring their children to this educational and tasty event. They are reminded to dress for the cold and possible snow or mud, as the activities are primarily outdoors. There are tours available inside each sugar shack to see the syrup being made, plus an optional trip into the sugar bush (or woods) to see the various sap collection methods. Each producer will have products for sale. There is no cost to attend the event.

Lindig Lewisburg Grant To Linn Conservancy

On Saturday, March 27 at 10 am, the Merrill Linn Conservancy will host an online educational event exploring how the built environment in a community—buildings, parking lots, and other impermeable surfaces—affects the quality of rainwater runoff that enters our local streams. This hands-on educational opportunity, Rain to Drain--Slow the Flow and Protect our Community Streams—is geared to intermediate and middle school students in the Borough of Lewisburg as well as to students throughout Union and surrounding counties.

The program is made possible by the First Community Foundation Partnership of Pennsylvania's approval of a \$500 award to the Conservancy. The award is provided by a grant from Lindig Lewisburg Foundation Fund at the First Community Foundation Partnership of Pennsylvania (FCFP).

"We are grateful for the support of FCFP and for their recognition that clean water and healthy streams are closely linked with community wellness and quality of life," says Tali MacArthur, Education Chair of the Merrill Linn Conservancy (MLC). "With the Foundation's support, we are able to offer a fun and educational program that highlights how each of us can make a difference right where we live."

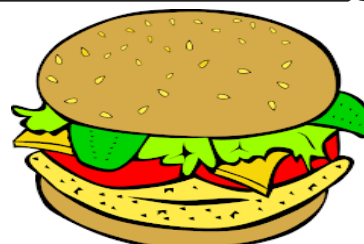

New Game Wardens Added To The Ranks

Twenty-seven new game wardens have been assigned to districts in Pennsylvania.

Following 45 weeks of intensive training, the 32nd Class of the Pennsylvania Game Commission's Ross Leffler School of Conservation graduated Feb. 13, 2021 at the Best Western Premier, The Central Hotel & Conference Center in Harrisburg. The 32nd Class shall forever be known as the "Covid Class" and was faced with many unique challenges to overcome. Over the last year, cadets had to adapt and work in ways never imagined before experiencing a pandemic. The 32nd Class enrolled on March 29, 2020. Their reporting date coincided with many closures, uncertainty, and virus-related mandates across the nation.

Graduate Shawn Greevy was selected as the fitness award winner for maintaining the highest standard of physical fitness during the training program.

Shawn Seeley received the Emergency Vehicle Operator Course driving award.

And, Graduate Philip Bietsch was chosen by his classmates to receive the "Torch Award for Leadership."

In 1930, Ross Leffler, then president of the Pennsylvania Board of Game Commissioners, proposed the establishment of a training school for game protectors. When the training school opened its doors in 1932, in Brockway, Jefferson County, it was the first such conservation officer training school in the world and served as a model for other states.

From 1932 until 1935, the Ross Leffler School of Conservation offered in-service training for game protectors. The school became a permanent facility and enrolled its first class of trainees in 1936, and continued training new classes at this facility until 1986, when the school was moved to the agency's Harrisburg headquarters.

Using a pollinator chart, Hefner explained how the butterflies and bees spread pollen from flower to flower. Diane Lengle assisted with the program by providing packaged "Silver Dollar" seeds and instructed the young gardeners on how to plant them in the soil.

Even the smallest future gardeners were very enthusiastic about their projects. They also creatively painted the rocks provided by the library. "Planting Seeds of Kindness" was a definitely a success!

MACST Scholarships To Be Awarded

The Mifflinburg Area Community Scholarship Trust will award \$58,000 in scholarships this year. Forty-three thousand dollars will be awarded to members of the Class of 2021. Fifteen thousand dollars will be awarded to collegiate students that graduated from Mifflinburg.

CAA 2020 Community Needs Assessment Results

Union-Snyder Community Action Agency (CAA) has released their results from their triennial Community Needs Assessment, highlighting community-reported needs facing Union and Snyder county residents.

The Assessment was initiated in the summer of 2020 and included three data collection phases, which included an asset mapping project, surveying, and interviews with residents and service providers. In analyzing all phases of the data collected during these phases, CAA identified the following themes needing attention in the region:

- Access to Healthcare and Health Insurance / High Healthcare Costs
- More Good-Paying Jobs / Working But Not Making Enough Money
- Children’s Success in School / Child Abuse and Neglect
- Mental Health Problems and Awareness
- Substance Abuse
- Racial Discrimination
- Affordable Childcare
- Transportation
- Cost of Nutritious Food

The Assessment also included an evaluation on the impacts to the Union and Snyder county community as a result of the COVID-19 pandemic. The COVID-19 Needs Assessment evaluated responses on questions on how the pandemic has had an impact on family and community resources, children’s education, and personal experience.

Community Action Agencies across the country are required to complete a Community Needs Assessment every three years as a tool to refine programs offered by the Agency to meet the truest needs of community members. As a result of their 2020 Community Needs Assessment, CAA has published a list of action items to pursue through 2023 to address the key themes that have emerged from the report.

Sprint Cars & Super Late Models Sunday At Port Royal Speedway

The sounds of roaring engines are set to return to the Port Royal Speedway this Sunday, March 7th, as the Weikert's Livestock 410 Sprint Cars and the River Valley Builders Super Late Models take to the track for the 79th Annual Port Royal Speedway Opening Day presented by Packer's Concessions LLC.

In what has been a recent tradition, the Speedway will again utilize a Sunday opener where the Sprint Cars will compete for a \$5000 winner's share while the Super Late Models will race for an increased \$3000 to win prize.

All gates open at 11A.M while racing is set to kick off at 2 P.M. Adult admission is \$20, while students are \$10. Pit admission is \$30.

Last year, All Star Circuit of Champions invader Cory Eliason bested 45 other competitors to score his first career opening day triumph. Brent Marks, Logan Wagner, Lance Dewease and Anthony Macri rounded out the top-five.

Wagner is the series defending champion and is looking to join rare air in becoming only the second driver to ever win four consecutive track points championships. All-time winningest driver, Keith Kauffman, is the only other driver to accomplish the feat as he did so from 1978-1981. Speaking of Kauffman, Dewease sits 14 back of the 'Man from Mifflintown' on the career wins list with 115 victories and will be looking to chip away at that total for his fourth career opening day trophy.

Last year's winningest sprint car driver at the speedway, Macri, will be searching for his first career opening day triumph along with a who's-who list of regular competitors and expected invaders searching for the \$5000 prize.

The last driver to triumph on opening day and go on to claim the season ending track points title was Todd Shaffer in 2008.

Valley Supply will again serve as the series hard charger presenter and there will be \$200 on the line for the driver who passes the most cars. This will also be the debut of their fan incentive program where the fans will have the opportunity to bring home various Valley Supply swag and possibly \$30 cash and tickets the following week's racing event.

Also new to this season is the Jim and Sandy Kline J&S Fabrication Warrior Award where one lucky driver will earn \$1000 extra as a result of a random draw. This award is designed specifically to benefit those who finish farther back in the field and drivers eligible will be positions 7-24.

In Super Late Model competition, Virginia's Trevor Feathers scored the opening day triumph last season over Dan Stone, Jason Covert, Andy Haus and Ross Robinson. Haus went on to score the season ending points championship for the second time in his career. He bested Dylan Yoder, Colton Flinger, Mike Lupfer and Gary Stuhler.

The Super Late Models have been a part of opening day festivities yearly since 2013 and both Haus and Covert have two career triumphs in the event. Other drivers to claim victory in the division on opening day are Tim Wilson, Lupfer and Jeff Rine. Rine turned his triumph into a track championship in 2018.

New to this season, the series will race for a minimum of \$3000 to win and \$300 to start. This is a \$500 increase on last year's winner's share and will be the standard for all races in 2021 for the division. George's Used Cars Inc. Will serve as the presenter of the series hard charger award with the driver passing the most cars at the end of the night earning a cool \$200 in cash. Driver's must be carrying a decal that will be passed around earlier in the night to be eligible.
