

## Charges Filed in 1997 Seebold Homicide Case



District Attorney Mike Piecuch has announced that criminal charges have been filed against three Snyder County men for the 1997 beating death of 21-year-old Donald "Donnie" Seebold.

DA Piecuch said that the charges were filed as the result of a difficult but sustained investigation by state police over the past fifteen years, culminating in a months-long grand jury investigation. The grand jury has issued a presentment, which was attached to the criminal complaints filed today, containing its findings of fact and its recommendation for criminal charges.

Based on the grand jury's recommendations, criminal charges have been filed against the following:

Robert Reich, 36, of 5325 Troxelville Road, Beavertown, for violating 18 Pa.C.S. sections 903 (relating to criminal conspiracy), 2501 (relating to criminal homicide) and 4902 (relating to perjury).

Ryan Sprenkel, 36, of 249 Longer Road, Middleburg, for violating 18 Pa.C.S. sections 903 (relating to criminal conspiracy), 2501 (relating to criminal homicide) and 4902 (relating to perjury).

Christopher Aucker, 37, of 5335 Troxelville Road, Beavertown, for violating 18 Pa.C.S. sections 903 (relating to criminal conspiracy), 2501 (relating to criminal homicide) and 4902 (relating to perjury).

Sheila Liddington Aucker, 36, of 5335 Troxelville Road, Beavertown, for violating 18 Pa.C.S. section 4902 (relating

to perjury).

Linda Thomas, 45, of North Carolina, for violating 18 Pa.C.S. section 4902 (relating to perjury).

The grand jury concluded that Seebold died as the result of a beating he suffered on July 12, 1997, by a group that included Reich, Sprenkel and Aucker. The grand jury also concluded that Reich, Sprenkel, Aucker, Liddington Aucker and Thomas provided false testimony before the grand jury.

The supervising judge of the grand jury has designated Snyder County as the location for the prosecutions of these charges. All five defendants will be preliminarily arraigned before Magisterial District Judge Lori Hackenberg in Middleburg.

"Our sympathies are with the Seebold family," said DA Piecuch. "They have suffered for too many years without knowing who was responsible for their loved one's death. I'm happy to say that this is a case where justice has been delayed, but not denied."

DA Piecuch complimented the tenacity of state police investigators in overcoming many barriers to finally solve the case. Sgt. Frederick C. Dyroff first brought the case to DA Piecuch's attention shortly after his appointment as District Attorney in February 2010. They formed a task force to develop and pursue leads in the case. In early 2011, the task force submitted the case to an investigating grand jury sitting in Harrisburg, with the

assistance of the Pennsylvania Office of Attorney General. DA Piecuch praised Attorney General Linda Kelly and her staff for their support and cooperation with the investigation.

The Seebold homicide investigation began on July 13, 1997, when Sgt. Dyroff (then Trooper Dyroff) responded to a report of a deceased person at Sprenkel's home in Center Township, Snyder County. The deceased person was Seebold. Following an autopsy, pathologist Samuel Land, M.D., concluded that his cause of death was blunt trauma to the head and should be considered suspicious and unnatural.

Sprenkel testified before the grand jury that he was with Aucker and Liddington Aucker when they discovered Seebold lying along Troxelville Road, in the early morning hours of July 13, 1997. According to his testimony, they loaded Seebold into the back of Sprenkel's car and then Sprenkel drove home. Sprenkel testified that he could not get Seebold out of the car by himself so he went to bed. When he checked on Seebold the next morning, he was unresponsive. Paramedics were called but Seebold was pronounced dead shortly thereafter. Sprenkel denied knowing why Seebold died or how he suffered the injuries described by Dr. Land.

Hundreds of interviews were conducted since 1997 to answer those questions. Many witnesses stonewalled the state police investigators, claiming that they knew nothing about how Seebold could have suffered his injuries. Investigators also wasted time and effort running down many false leads. For example, rumors were rampant, falsely blaming Timothy Steffen or Brian Swartzlander for Seebold's death. Investigators have cleared Steffen and Swartzlander of any involvement in the case. Eventually, investigators found witnesses who admitted to seeing Seebold get beaten at a party the day before he was found dead at the Sprenkel residence.

Several of those witnesses testified before the grand jury. According to the grand

jury, Seebold attended a birthday party thrown for Robert Reich on July 12, 1997. The party was held in the yard behind the home of Reich's aunt, Linda Thomas, near Port Ann, Snyder County.

According to witnesses' testimony, Seebold at some point during the party, put his arm around Sheila Liddington, who was dating (and later married) Christopher Aucker. The witnesses testified that Liddington took offense and the ensuing commotion attracted the attention of other partygoers. The escalating confrontation, which included Aucker, Reich and Sprenkel, then reportedly turned physical.

According to the grand jury, Seebold was outnumbered and unable to defend himself against the punches and kicks of a group of persons that included Aucker, Reich and Sprenkel. Even after Seebold fell to the ground, the assault continued. The witnesses testified that eventually the group withdrew and Seebold was left lying there on the ground. The grand jury found that this beating caused Seebold's death.

DA Piecuch said that the pathologist who conducted Seebold's autopsy concluded that his injuries, including a skull fracture and multiple brain contusions, were most consistent with being struck repeatedly in the head. The pathologist also concluded that these injuries were the cause of death.

Witnesses testified before the grand jury that after the beating, Linda Thomas told people to get Seebold off her property. According to the witnesses, Seebold's bloodied semiconscious body was loaded into a pickup and then unloaded down along Troxelville Road, where he was later discovered by Sprenkel, Aucker and Liddington.

# Library News

**Libraries for Health Expo slated for March 31**  
Diet, nutrition and fitness will be the focus of the Libraries for Health Expo slated for 10:00 a.m. to 2:00 p.m. on Saturday, March 31 at The Public Library for Union County.  
This all-age event will feature something for the entire family with story time, child fingerprinting by the Buffalo Valley Regional Police and live demonstrations including cooking, yoga and Tai Chi.  
Evangelical Community Hospital will provide body composition screenings which include body mass index (BMI) and body fat percentages. A registered dietician will be available for risk counseling.  
Geisinger Health System will be offering blood pressure screenings through the Lewisburg community practice clinic and cancer screening information in conjunction with the National Cancer Institute Community Cancer Center. Through a grant from Kohl's Cares for Kids, Geisinger will also sponsor children's activities, including Nintendo Wii Fitness and a raffle for a children's bicycle and helmet.  
The Special Olympics from Union and Northumberland counties will be showing off their Bocce ball skills, while the Penn State Extension will be offering healthy cooking demonstrations, with a special focus on diabetes. For children, the Extension will offer "Color My Plate" activities.  
The Union-Snyder Community Action Agency will offer information on providing healthy food for families, the Supplemental Nutrition Assistance Program (SNAP), and the WIC program, a special supplemental nutrition program for women, infants and children.  
Along with the live demonstrations there will also be health and wellness information and representatives from area organizations including the Union-Snyder Agency on Aging, Inc., Donald Heiter Community Center, Greater Susquehanna Valley YMCA, the Girl Scouts and more. An additional raffle of a healthy foods basket, donated by the Natural Food and Garden Store, Ltd. will also be held.  
The Libraries for Health Expo is a project of the Union County Library System—The Public Library for Union County, Lewisburg; Herr Memorial Library, Mifflinburg; and the West End Library, Laurelton—in conjunction with the Union-Snyder Agency on Aging, Inc., Evangelical Community Hospital, Geisinger Health System, and the Penn State Extension. The Libraries for Health group was formed in 2010 to improve and expand health materials in the libraries' collections through a \$20,000 LSTA (Library Services and Technology Act) grant received by the library system.

## Letters Written During WW1 From Jay A. Rigel to Family and Friends

Letter to: Mrs. P.F. Rigel  
Date: May 30, 1918  
Location: Camp Merritt, N.J.

Dear Parents and all,

Decoration day and will write a few lines or you will begin to think I left camp. We are kept busy at present getting our new clothes. There is a lot of work connected with exchanging our old clothes for new ones. All our clothes were inspected by one of the Lieutenants, and if there was a small hole in them or they were poor, they were condemned and we will get new ones. I got two good suits, one new and the other one is as good as new. We got new socks, two pairs of new shoes, two new shirts, two suits of tan overalls. We sure will have a load of clothes, but do not carry more than we need. The rest is shipped and hauled by truck or railroad. I guess it will be hauled by boat soon.

I got the letters yesterday, dated May 28. It doesn't take very long for it to come to camp. I got the letter and paper that Annie sent.

Wm. has been thinking about coming to this camp on Sunday. I don't know what he will do.

I subscribed for a paper here. It will be sent to you each month. It costs only \$.75 a year. I worked all night Tuesday night and was up until one o'clock last night. We can sleep a few hours during the day.

Some of us bought French books, so we can learn French.

I have not heard from Roy and Chas for nearly two weeks. I suppose they are real busy.

We will each have our over coat, raincoat, cap, 3 blankets. I also have five pairs of wool socks, heavy scarf, helmet, wool sweater, wristlets. These are from the Red Cross.

I saw George Gross this morning. I see him nearly every day. He had his hair clipped all over his head. A good many of the boys had.

Well, this is a nice camp but no visitors are allowed in this part of camp unless they get a pass. They are very scarce, although in some parts of camp there are a good many visitors.

They say we will get a pass after we are fully equipped, but they might not give us any.

How are Clarence's and Ira's? I should have written to them, but hardly had time. I suppose if you move to town Norman will get married and do the farming. Then I must ride the bake oven. (If Norman builds one before I get back.) Ha! Who is Norman's girl?

Does the old flyover run yet or is it dilapidated?

Yes, most of the young boys will be drafted soon, but it's the only way to beat Kaiser Bill. And the Sammys will do it.

They won't need a big service flag at the Ridge Church. Some churches have 50 or more, but they are in big cities.

Did you get the pillow slip I sent, Mother? Answer soon and maybe I will be there yet a week or more. This leaves me well and enjoying camp life.

LAS VEGAS, Nev.--Tony Stewart took the lead on lap 234 of Sunday's 267-lap Kobalt 400 and held off Jimmie Johnson for his first-ever Las Vegas Cup victory.

There were three cautions late in the race, but each time Stewart was able to maintain his lead.

"This is special, after having the dominant car last year and losing it," said Stewart. "We might not have had the dominant car today, but we were awesome on the restarts."

Johnson tried to catch Stewart after each caution, but was never able to get within distance to make a passing move.

"I think we could have used a little more speed," said Johnson. "Tony could get up through the gears quicker than I could."

Johnson moved up 14 spots from 37th to 23rd.

Greg Biffle, Ryan Newman, Carl Edwards, Clint Bowyer, Paul Menard, Jamie McMurray, Trevor Bayne, and Dale Earnhardt Jr. were the remaining top-10 finishers.

Polesitter, Kasey Kahne finished 19th.

Matt Kenseth had the stronger of the Roush Fords, but he got bottled up in a bunch of cars on the last restart, brushed the wall, and finished 22nd.

"I really don't know what happened near the end," said Kenseth. "I think some of the drivers laid back on that last restart, and I just got shuffled around."

## STENHOUSE WINS VEGAS NATIONWIDE RACE

Ricky Stenhouse Jr. dominated the last 50 laps of Saturday's Sam's Town 300 Nationwide Series race at Las Vegas Motor Speedway, pulling away from Mark Martin during a 39-lap green flag run to the finish.

The victory was Stenhouse's first of the season and third in the series, and his first on a 1.5-mile track.

"To win on a mile-and-a-half (racetrack) is big for me," Stenhouse said. "I feel like our cars are better than I am at some mile-and-a-halfs, and I feel like I drive really hard at the short tracks. The car was not as good as we wanted at the start of the race. If you would have listened to our radio, I'm sure (crew chief) Mike (Kelly) over here was tired of listening to me, but he kept taking notes of what I was saying and made it better. The guys on pit road did an awesome job to get us out first and that really helped to win us that race."

Stenhouse drove away from Martin after a restart on Lap 162, opening a lead of 4.785 seconds with 20 laps left. The defending Nationwide champion maintained a comfortable lead the rest of the way.

Martin said the last green-flag run was no contest. "That was one serious beat-down he put on me that last run," Martin said. "I mean just a beat-down. I kept up with him for a while and about wrecked five times, and that's it. I could stay ahead of him, and any time he would close in on me, I could get up on the wheel and pull back out."

"But that last run, he seemed to be stronger. I didn't feel my car was off. He just had that thing rolling. I'm not ashamed to say it wasn't even close."

Points leader Elliott Sadler came home third, followed by Trevor Bayne and Las Vegas native Brendan Gaughan. Cole Whitt, Austin Dillon, Justin Allgaier, Sam Hornish Jr. and Kasey Kahne completed the top-10.

Weekend Racing: The Cup and Nationwide teams are back east this weekend at Bristol, Tennessee, one of the shortest tracks on the schedule. The .533-mile track's first NASCAR race was the Volunteer 500 in 1961, which was won by Jack Smith in a Pontiac.

Darrell Waltrip is the all-time leading race winner with 12. Jeff Gordon and Kurt Busch leads all current drivers with five wins. Kyle Busch is the defending champion.

Saturday's Nationwide race might not have all the big-name Cup stars, but it could have just as much action, because the Cup racers are more likely to mix it up more when their points aren't on the line.

There is no love lost between Kevin Harvick and Kyle Busch, and both will be in Saturday's race.

Harvick has five Nationwide wins at the half-mile oval and joins Busch, winner of the last three Nationwide events at Bristol, Dale Earnhardt Jr. and Brad Keselowski, with one Nationwide win each at BMS and Danica Patrick, who is making her second Cup start.

Ricky Stenhouse Jr., winner at Las Vegas, goes for his first win at BMS while Justin Allgaier, tries to duplicate the success he experienced winning for the first time at Bristol in March, 2010.

A surprise entry for the race is another Earnhardt. Jeffrey Earnhardt becomes a fourth-generation racer to compete in NASCAR events at Bristol, following in the footsteps of his great grandfather Ralph, grandfather Dale, and father Kerry.

The Camping World Trucks do not race again until March 31. Sat., Mar. 17, Nationwide St. Patrick's Day 300, race 4 of 33; Starting time: 1 pm ET; TV: ESPN.

Sun. Mar. 18, Sprint Cup Food City 500, race 4 of 36; Starting time: 12:30 pm ET; TV: FOX.

This is a statement from NASCAR upholding the penalties on the No. 48 car. National Stock Car Racing Appeals Panel Statement - Penalty Upheld: On March 13, 2012, the National Stock Car Racing Appeals Panel heard and considered the appeal of the #48 Hendrick Motorsports NASCAR Sprint Cup Series team. The penalties concern Section 12-1 of the NASCAR Rule Book "Actions detrimental to stock car racing;" Section 12-4(J): "Any determination by NASCAR Officials that the Race Equipment used in the Event does not conform to NASCAR rules detailed in Section 20 of the NASCAR Rule Book, or has not been approved by NASCAR prior to the Event;" and Section 20-2.1(E): "If in the judgment of NASCAR Officials, any part or component of the car not previously approved by NASCAR that has been installed or modified to enhance aerodynamic performance, will not be permitted: Unapproved car body modifications."

This stemmed from an opening day inspection for the NASCAR Sprint Cup Series at Daytona International Speedway on February 17, 2012.

The original penalties assessed prior to the deferral were:  
 - Car Owner (Jeffrey M. Gordon) Loss of 25 NASCAR Sprint Cup Series Championship Car Owner points;  
 - Car Driver (Jimmie K. Johnson) Loss of 25 NASCAR Sprint Cup Series Championship Driver points;  
 - Crew Chief (Chad A. Knaus) - \$100,000.00 fine. Suspended from the next six (6) NASCAR Sprint Cup Series Championship Events. Suspended from NASCAR until April 18, 2012. Placed on NASCAR probation until May 9, 2012.  
 - Car Chief (Ron P. Malec) - Suspended from the next six (6) NASCAR Sprint Cup Series Championship Events. Suspended from NASCAR until April 18, 2012. Placed on NASCAR probation until May 9, 2012.

Upon hearing the testimony, carefully reviewing the facts and historically comparative penalties, the unanimous decision of the National Stock Car Racing Appeals Panel (John Capels, Leo Mehl, Dale Pinilis and Ed Bennett: Appellate Administrator and non-voting member) was to uphold the original penalties assessed by NASCAR. The Appellants have the right under Section 15 of the Rule Book to appeal this decision to the National Stock Car Racing Chief Appellate Officer.(NASCAR)

# Free screening of 'Liquid Assets' at Campus Theatre

The Bucknell University Environmental Center's "Green Screens" documentary series continues with a public screening of the film "Liquid Assets," about the critical role that the nation's water infrastructure plays in protecting public health and promoting economic prosperity, on Tuesday, March 27, at 7 p.m. in the Campus Theatre in Lewisburg. Admission is free for this event.

It is out of sight and usually out of mind, but the nation's aging water system is in dire need of an overhaul. Penn State Public Broadcasting (WPSU-TV) created a 90-minute documentary in 2008 about the looming crisis underneath our feet and how communities are trying to meet this challenge. "Liquid Assets: The Story of Our Water Infrastructure" tells of the nation's distressed essential infrastructure systems: drinking water, wastewater, and stormwater. These complex and aging systems -- some in the ground for more than 150 years -- are critical components for basic sanitation, health, public safety, economic development, and a host of other necessities of life in the United States.

"The goal of this public service media project is to stimulate community discussion and bring this issue into the public consciousness," said Tom Keiter, executive producer.

The documentary explores major water, sewage, and stormwater infrastructure issues facing communities across the country, including Atlanta, Boston, Las Vegas, Los Angeles, New York City, Philadelphia, Pittsburgh, and Washington, D.C.

A panel discussion, moderated by Cathy Curran Myers, Interim Director of Bucknell University's Environmental Center, will follow the documentary showing. Myer's career in environmental law and policy spans three decades and includes executive level management in government, business, and academia. Prior to her appointment at Bucknell, she served as Deputy Secretary for Water Management in the Pennsylvania Department of Environmental Protection (PADEP), where she shaped the water policy of the commonwealth from 2003-2009.

The panel will include the following experts: Dr. Kevin Gilmore, Assistant Professor in Bucknell's Department of Civil & Environmental Engineering; Marcus Kohl, Director of the new Office of Program Innovation for the PADEP, who was lead staff for Gov. Rendell's Sustainable Water Infrastructure Task Force in 2008; and Chuck Wunz, an expert in water reuse and the conversion of wastewater and its byproducts into sources of renewable energy who was Executive Vice President of the Herbert, Rowland & Grubic, Inc. civil engineering firm before his retirement in 2011.

"Green Screens," a sustainability-themed series, is presented regularly by the Bucknell University Environmental Center and the Campus Theatre. Each film is followed by an opportunity for audience discussion with a panel led by local experts. The final film in the spring series, "Climate Refugees," will be shown on April 24 and will focus on the people who are displaced by climatically induced environmental disasters.

"Liquid Assets" is a production of WPSU, Penn State Public Broadcasting. Major funding for the "Liquid Assets" documentary was provided by the Colcom Foundation, with additional funding from the Associated General Contractors of America, the American Society of Civil Engineers and its Environmental & Water Resources Institute, Insituform Technologies, and the National Association of Clean Water Agencies.

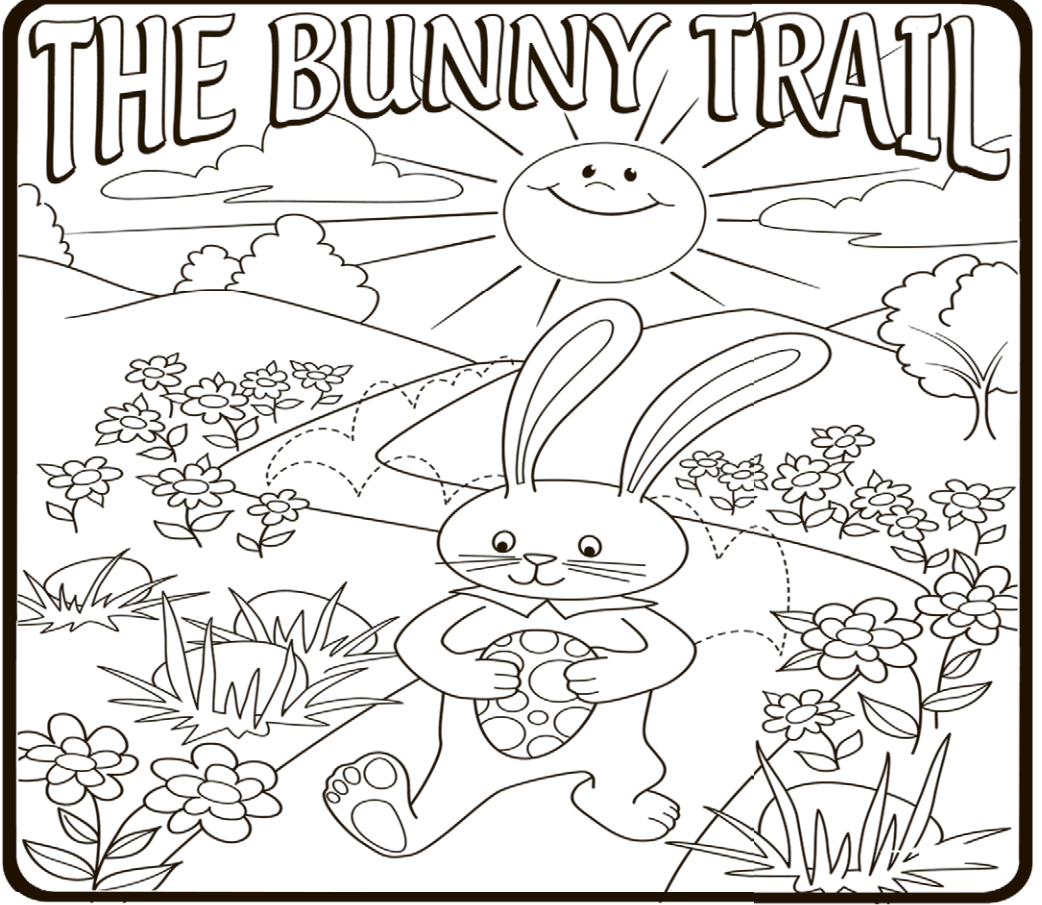
